A minimum of 30 unique waveforms are required for each of the Short Pulse Radar Types 2 through 4. If more than 30 waveforms are used for Short Pulse Radar Types 2 through 4, then each additional waveform must also be unique and not repeated from the previous waveforms. If more than 30 waveforms are used for Short Pulse Radar Type 1, then each additional waveform is generated with Test B and must also be unique and not repeated from the previous waveforms in Tests A or B.

For example if in Short Pulse Radar Type 1 Test B a PRI of 3066 usec is selected, the number of pulses would be Roundup $\left\lceil \left(\frac{1}{360} \right) \cdot \left(\frac{19 \cdot 10^6}{3066} \right) \right\rceil = \text{Roundup}\{17.2\} = 18$.





DFS Measurement System


DFS measurement system consists of two subsystems:

System Block Diagram




Conducted Method**Setup for Master with injection at the Master****Setup for Client with injection at the Master**


A spectrum analyzer is used as a monitor verifies that the EUT status including Channel Closing Transmission Time and Channel Move Time, and does not transmit on a Channel during the Non-Occupancy Period after the diction and Channel move.

APPLICABLE STANARDS

Description of EUT

The calibrated radiated DFS detection threshold level is set to -62 dBm.

CHANNEL MOVE TIME AND CHANNEL CLOSING TRANSMISSION TIME

Description of EUT

Channel Move Time and the Channel Closing Transmission Time should be performed with Radar Type 0. The measurement timing begins at the end of the Radar Type 0 burst. Repeat using a long pulse radar type5 waveform.

The Channel Closing Transmission Time is comprised of 200 milliseconds starting at the beginning of the Channel Move Time plus any additional intermittent control signals required to facilitate a Channel move (an aggregate of 60 milliseconds) during the remainder of the 10 second period. The aggregate duration of control signals will not count quiet periods in between transmissions.

The aggregate channel closing transmission time is calculated as follows:

Aggregate Transmission Time = $N \times \text{Dwell Time}$

N is the number of spectrum analyzer bins showing a device transmission Dwell Time is the dwell time per bin (i.e. Dwell Time = S/B , S is the sweep time and B is the number of bin, i.e. 8192

Test Procedure

Measure the EUT for more than 30 minutes following the channel close/move time to verify that the EUT does not resume any transmissions on this channel. Provide one plot to demonstrate no transmission on the channel for the non-occupancy period (30 minutes observation time)





5270 MHz Bandwidth 40 MHz




5510 MHz Bandwidth 40 MHz





5270 MHz Bandwidth 40 MHz





5510 MHz Bandwidth 40 MHz
