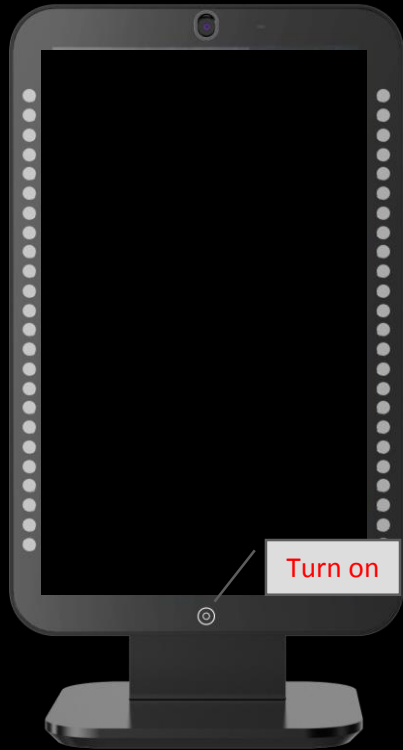

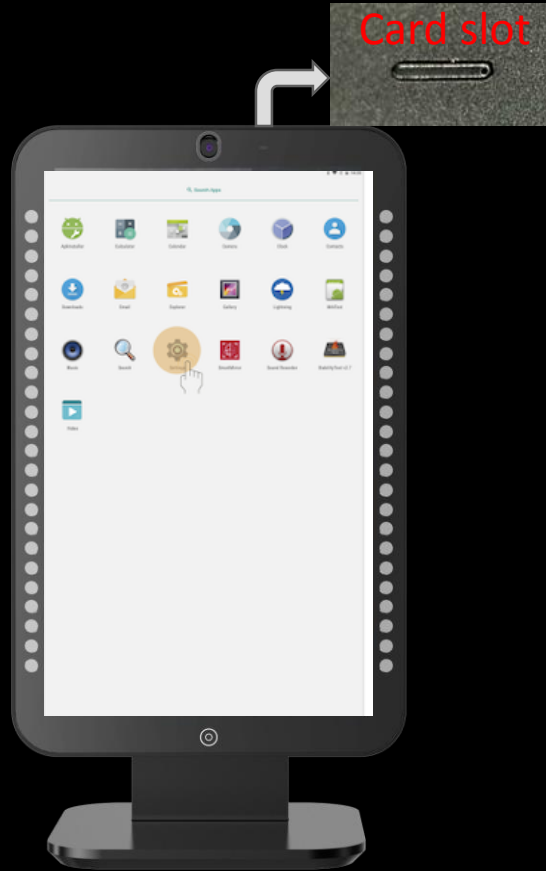

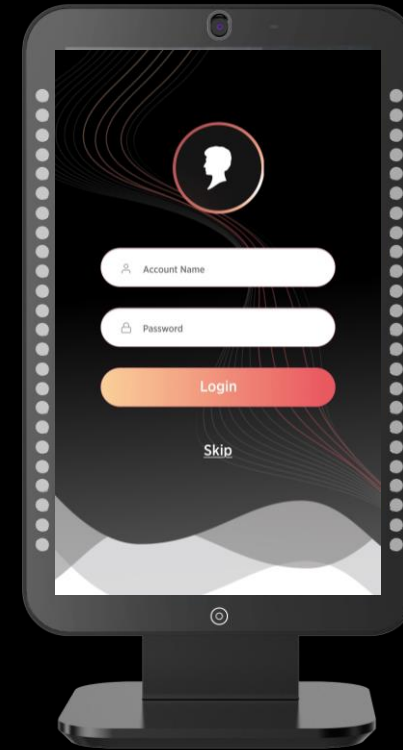
ADMIN-LOG IN



- Plug in.

- Go to settings and connect to Wi-Fi or insert the SIM.

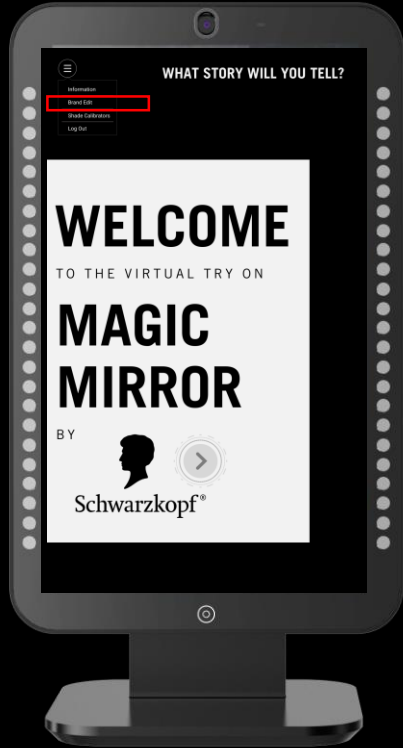


- Fill in account and password to log in.

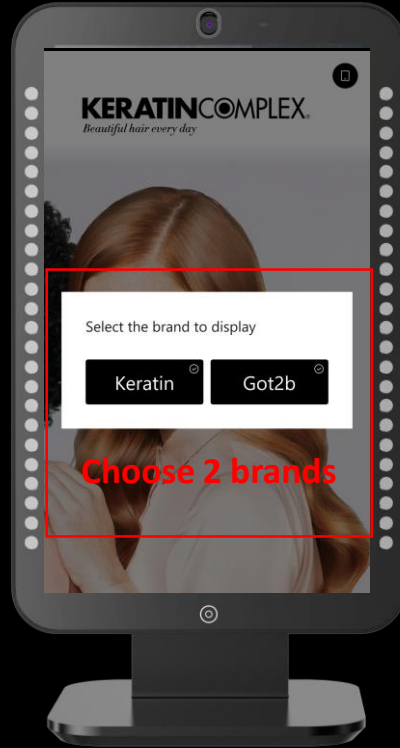
Note:

- The account can only be distributed by dxT.

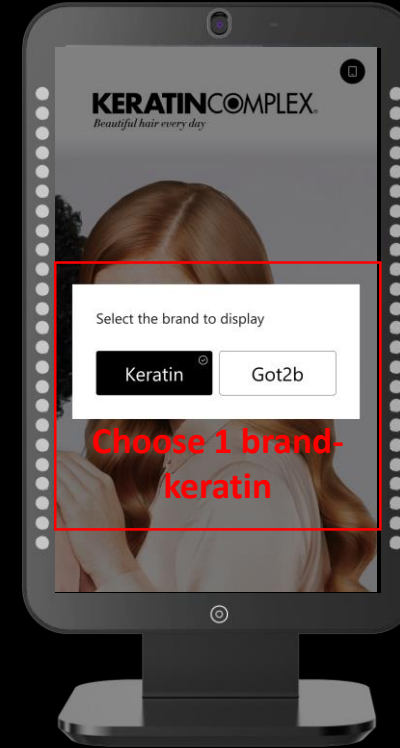
ADMIN-BRAND CONFIGURATION



- Click “Brand edit” button.

- You must choose at least one brand.

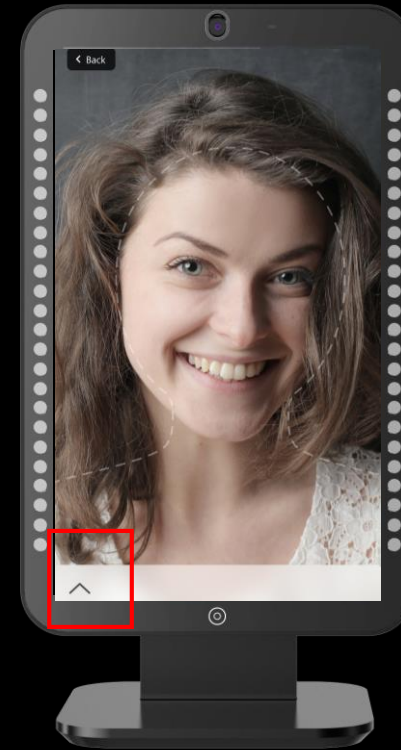
ADMIN- COLOR ADJUSTMENT

- Click the “Privacy agreement” button.

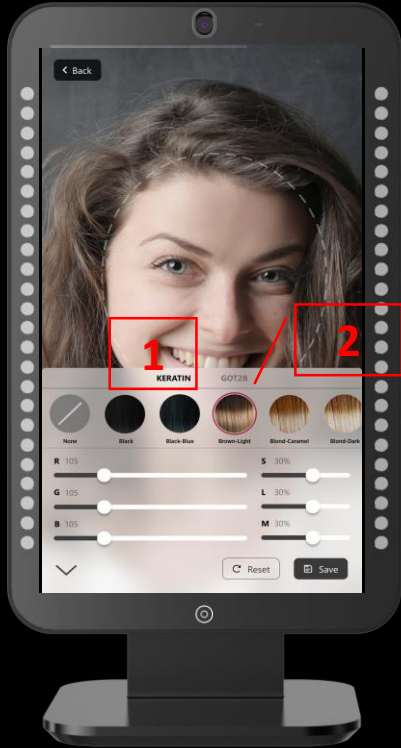


- click “↑” to open the hidden panel.

- Everyone needs to agree the privacy agreement before trigger the camera.

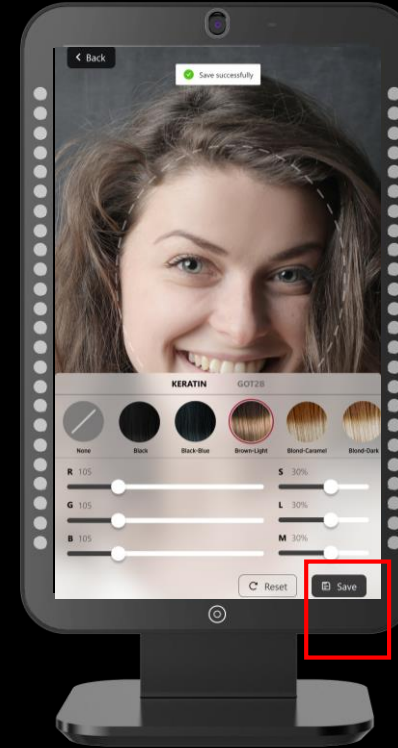
ADMIN- COLOR ADJUSTMENT



- 1) Choose the brand first.
- 2) Choose the shade which you want to edit.



- Change the six parameters to change the effect of hair dying.

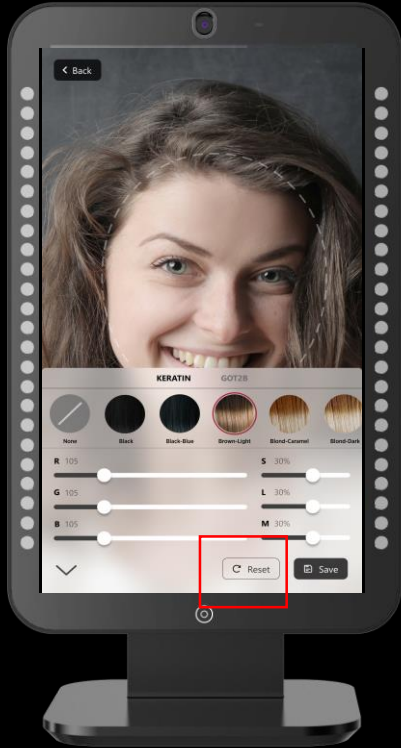


- Save the final value.

Note:

- S(strength)- Most shades are set to 100.
- L(highlight)- Depending on the shade.
- M(midtone)- Depending on the shade

- Please click “Back” button to go back home after adjustment.

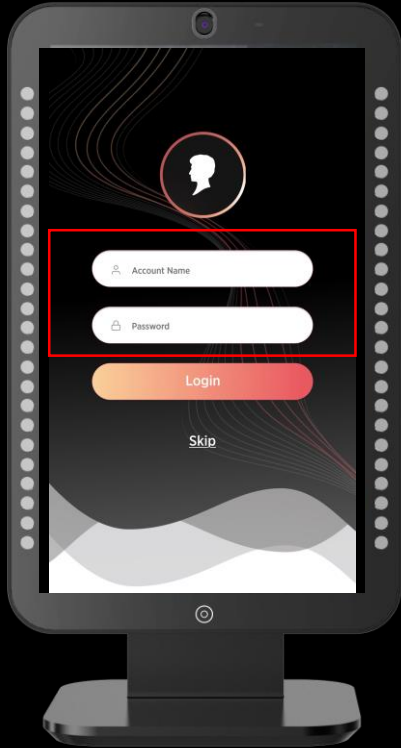


- Log out your admin account.

- Do not forget to log out your admin account to avoid others to use it.

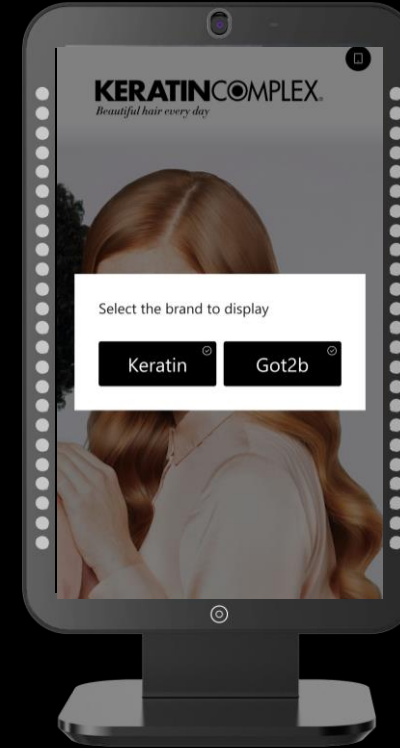
BUSINESS- LOG IN

- Choose the brand which you will show in the event.

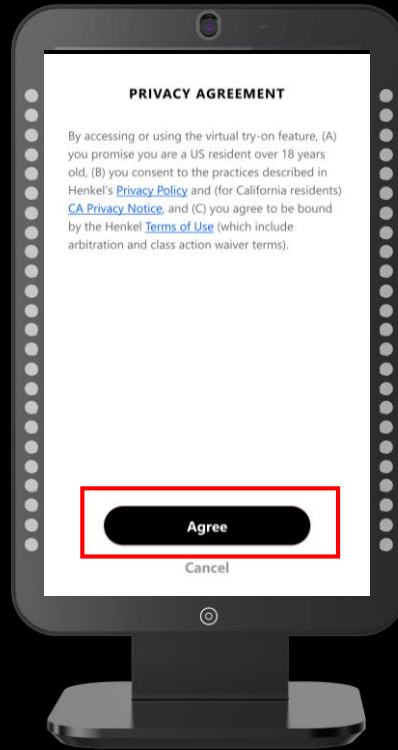
Note:

- Here is to define the Brand you want to show during the event.

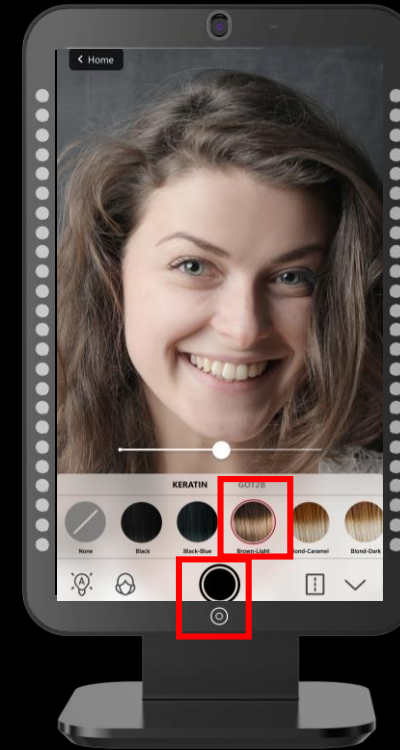
END USER- VTO

- Agree the privacy agreement.

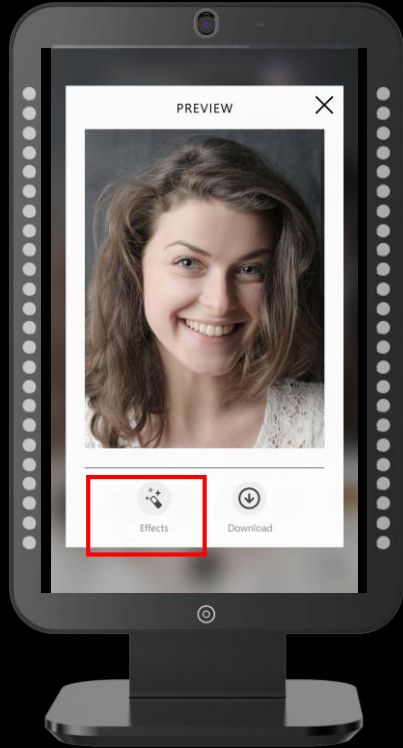


- Choose a shade.
- Take a photo

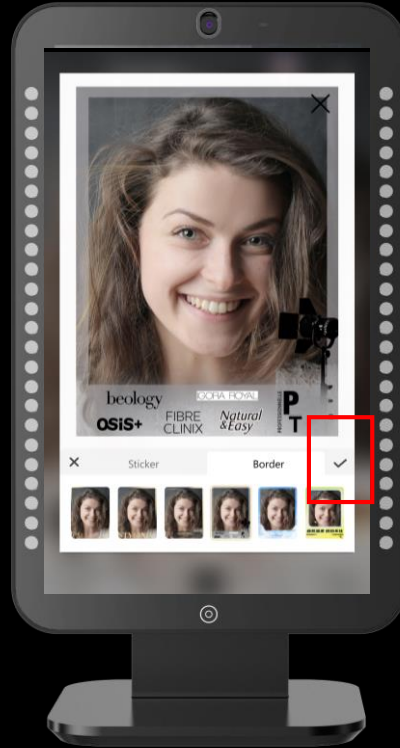
Note:

- Please click “Back” button after the VTO, otherwise the screen will automatically go back to Welcome page after 60s.

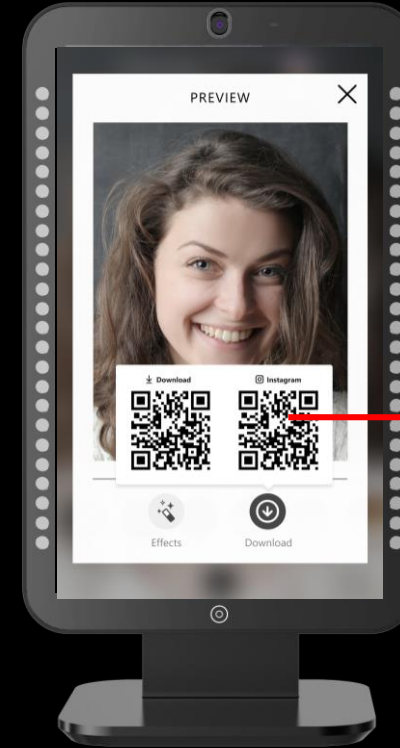
END USER- TAKE PHOTO



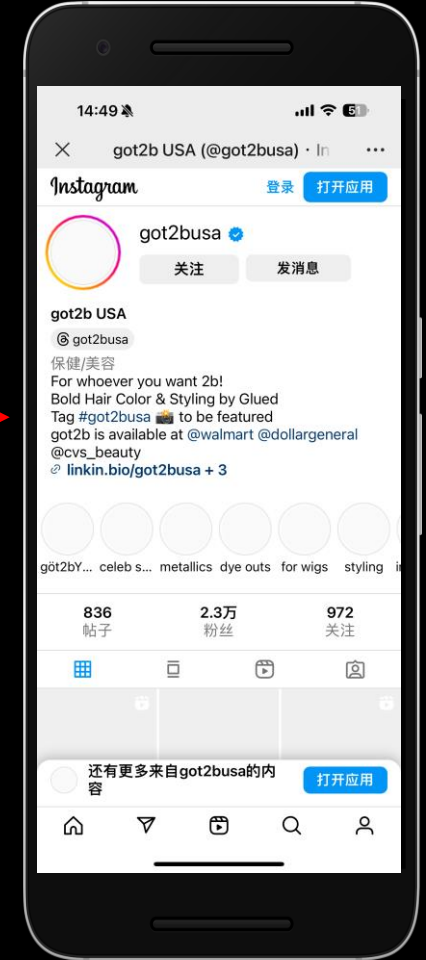
- Click "Effect" to add stickers and border to your photo.
