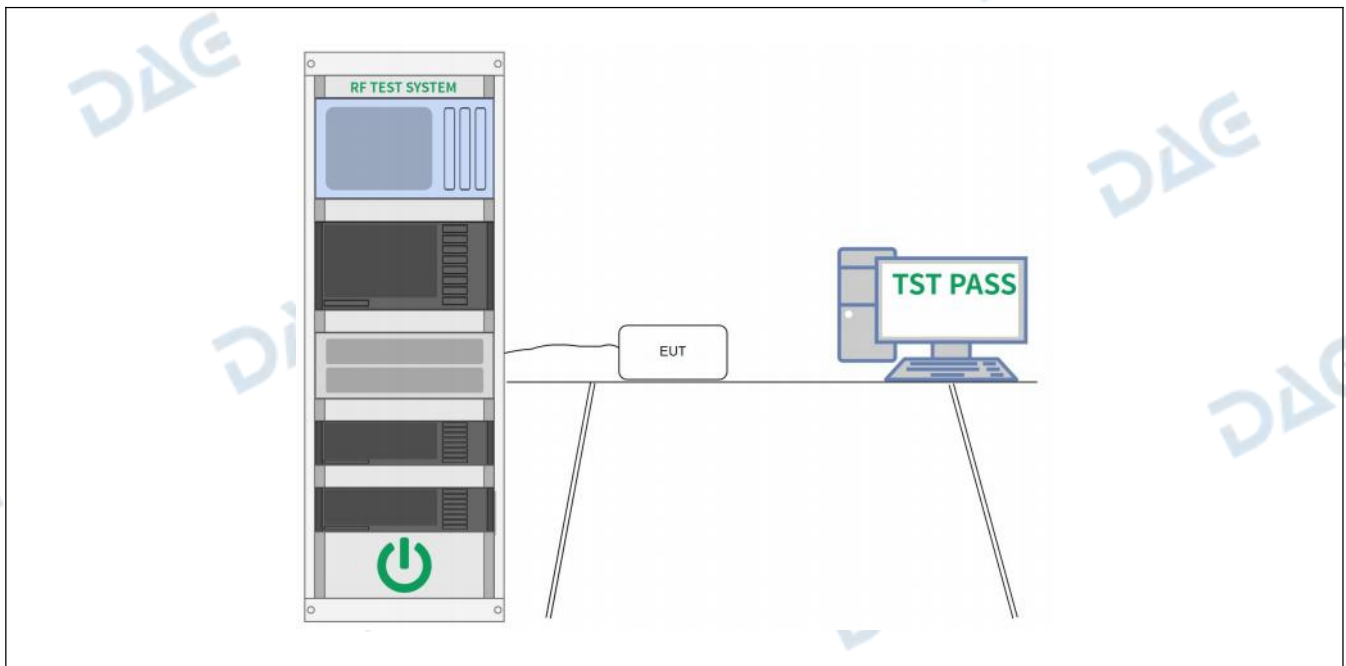
4.5 Emissions in non-restricted frequency bands
