The antenna is a **FPC Antenna** which permanently attached, and the best case gain of the antenna is **0.51dBi**. It complies with the standard requirement.



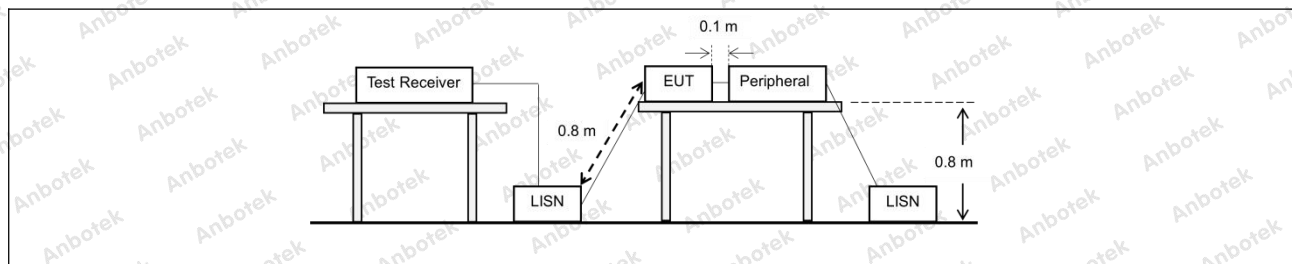
