

## Product instructions



## Product Introduction

- (1) Do not attempt to disassemble or replace any part of the product except for the operation mode specified in the manual. What parts.
- (2) Do not put the product into water or any other liquid. This product is not waterproof.
- (3) If any liquid accidentally enters the product, please disconnect it immediately and remove the product.
- (4) To avoid electric shock, make sure your hands are free from water when installing or uninstalling the product.
- (5) Do not place this product near heat sources or directly expose it to fire sources.
- (6) Do not place this product in an environment with strong electromagnetic force, otherwise it may cause product failure.

## Use function operation

### charge

Charging the headset: put the headset into the charging box, close the upper cover of the charging box, and the headset will automatically enter the charging state.

Charging the charging box: use the Type-C charging line included in the package to charge the charging box. The orange indicator flashes when charging, and the orange indicator is always on when charging is completed

Tip: Please select a power adapter that complies with CCC certification for charging.

**Power on:** Take out the headset, and the will turn on automatically.

**Sleep:** Put the headset back into the charging box, close the box cover, and the headset will automatically disconnect and enter the sleep state.

**Wearing:** Take the headset out of the charging box and wear it according to the left and right marks of the headset.

Tip: After use, please put the headset back into the charging box in time to prolong the service life and prevent loss.

### Connect

Connect new device

1. Remove the headset and wait for the connection.

2. Open the device Bluetooth, search and connect to . To connect the password, enter "0000".

## **Connection interrupted**

When Bluetooth is turned off or the headset connection range is exceeded, the headset will automatically enter the waiting connection state;

If the headset is not connected to any device within 10 minutes, it will enter the sleep state, and then it will wake up after being put into the charging box again, and it will enter the waiting connection state.

## **Automatic reconnection**

The headset is in the charging box. Open the charging box, and the headset will automatically connect to the recently connected Bluetooth device; If no connection record is detected or any Bluetooth device cannot be successfully connected back, the headset will automatically enter the waiting connection state.

Tip: If the headset cannot be automatically connected back to the device, you need to manually connect it on the Bluetooth interface of the device.

Tip: Due to the connection characteristics of the Bluetooth signal, there may be intermittent disconnection or silence in places where 2.4GHz electromagnetic signal interference is intensive.

## **Function introduction**

1. Click Play/Pause;
2. Three clicks on the left ear, one song above and three clicks on the right ear, one song below
3. When listening to music, long press the right ear for more than 3s to increase the volume, and long press the left ear for more than 3s to decrease the volume. Normal operation for 4-6 seconds must complete the volume increase and decrease operation;
4. When calling, click to answer, then click to hang up, and press and hold for 3 seconds to reject the call;
5. Press and hold any headset for 2-3 seconds to activate the voice assistant;
6. When the headset is not connected to the mobile phone, it will shut down automatically within 3 min.
