4. Portable Device Evaluation Method and Limit

Following FCC KDB 447498 D01v06 "General SAR test exclusion guidance" The corresponding SAR Exclusion Threshold condition, listed below:

- ◆ The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances ≤ 50 mm are determined by:
 - $[(\text{max. power of channel, including tune-up tolerance, mW}) / (\text{min. test separation distance, mm})] [\sqrt{f(\text{GHz})}] \leq 3.0$ for 1-g SAR, and ≤ 7.5 for 10-g extremity SAR, where $f(\text{GHz})$ is the RF channel transmit frequency in GHz.
 - Power and distance are rounded to the nearest mW and mm before calculation.
 - The result is rounded to one decimal place for comparison. The test exclusions are applicable only when the minimum test separation distance is ≤ 50 mm and for transmission frequencies between 100 MHz and 6 GHz. When the minimum test separation distance is < 5 mm, a distance of 5 mm is applied to determine SAR test exclusion.
- ◆ At 100 MHz to 6 GHz and for test separation distances > 50 mm, the SAR test exclusion threshold is determined according to the following:
 - $[\text{Threshold at } 50 \text{ mm in step 1} + (\text{test separation distance} - 50\text{mm}) (\sqrt{f(\text{MHz})/150})] \text{ mW}$, at 100MHz to 1500 MHz;
 - $[\text{Threshold at } 50 \text{ mm in step 1} + (\text{test separation distance} - 50 \text{ mm})-10] \text{ mW}$ at $> 1500 \text{ MHz}$ and $\leq 6 \text{ GHz}$;
- ◆ At frequencies below 100 MHz, the following may be considered for SAR test exclusion.
 - The threshold at the corresponding test separation distance at 100 MHz in step 2) is multiplied by $[1 + \log(100/f(\text{MHz}))]$ for test separation distances > 50 mm and < 200 mm.
 - The threshold determined by the equation in a) for 50 mm and 100 MHz is multiplied by 1/2 for test separation distances ≤ 50 mm.
 - SAR measurement procedures are not established below 100 MHz. When SAR test exclusion cannot be applied, a KDB inquiry is required to determine SAR evaluation requirements for any test results to be acceptable.

According to KDB447498 D01 V06, threshold at which no SAR required is ≤ 3.0 for 1-g SAR, separation distance is 5mm, and no simultaneous SAR measurement is required.
