


I Umoven Tag Operating Instructions on Apple Find My App

To use the Apple Find My app to locate this item, the latest version iOS, iPadOS, or macOS is recommended.

How to set up Umoven Tag in the Apple Find My app:


First make sure Bluetooth are turned on



Make the Umoven Tag discovered following the steps:

Click the power button, after the ringtone rings and the Controlling light blinks in white, the Umoven Tag is ready.

Press and hold the button for 5 times (Long press for the fifth time). And pair it with the iphone after reset is successful.




How to activate the tracker card: Long press for three seconds until a ringtone sounds

How to turn off the tracker card: double-click and long press until a beep sound is emitted

How to reset the tracker card: quickly click four times and press and hold for the fifth time to sound a ringtone

How to confirm that the tracker card is in the open state: double-click and make a beep sound

Turn on the Apple Find My app




Click "Add Item", then click "Add Other Supported Item" then follow the instructions shown.

If you have added other items, you need to click on the "+" sign at the top right and enter it by clicking on "Add Other Items".

How to remove items from the Apple Find My app:





After removing it on the Apple Find My app, the Card will automatically shut down after 3 minutes. Subsequent re-link can be done by following the steps above.



Navigate to the item page on the Apple Find My app, Click "Items", then Swipe left on the item you want to remove.

II Charge your card



As shown in the picture, aim the charger at the charging port of the wallet to charge. Note: If the charger uses the reverse-magnetic suction port, there will be repulsion.

The red small light displays during charging. After charging is completed, the small light turns from red to green.

Product defects do not include those resulting from accidents, product modification, or failure to follow instructions for us.


