## 2. Precautions for Applying Situations and Operating Environments

- 1.1 The radio waves generated by the device may affect the normal operation of implantable medical devices or personal medical devices, such as pacemakers, hearing aids, etc. If you use these devices, check with the manufacturers for restrictions on the use of this device.
- 2.1 The following behaviors are not allowed, including changing the transmission frequency, increasing the transmission power (through radio frequency power amplifier or any other methods), connecting with an external antenna or using other transmission antennas.

- 1.3 "Device Software" means the software supplied by TourBox Tech for use with the applicable Device and includes any authorized upgrades or supplements from TourBox Tech for such software.

### 2. Duration

Without prejudice to any legal (statutory) rights to which you may be entitled under your local law, this Warranty lasts for one year from the original date of purchase from TourBox Tech.

### 3. Warranty

To the extent permitted under your local law, tourbox tech and its suppliers, distributors, resellers, and content providers make no express or implied warranties, guarantees, or conditions, including for merchantability, satisfactory quality, fitness for a particular purpose, workmanlike effort, title, or non-infringement other than the following.

- 3.1 TourBox Tech warrants that the Device will not malfunction due to a defect in materials or workmanship under Normal Use Conditions.
- 3.2 Subject to your legal (statutory) rights under your local law (which may include the law of the Province of Quebec) this Warranty is the only guarantee, warranty, or condition TourBox Tech gives for your Device. No one else may give any guarantee, warranty, or condition on TourBox Tech's behalf.

## 5. TourBox Tech's Responsibility

- 5.1 If TourBox Tech determines that the Device malfunctioned under Normal Use Conditions during the warranty period due to a defect in materials or workmanship, TourBox Tech will (at its option) repair or replace it or the defective part, or refund the purchase price in exchange for the return of the Device, unless a mandatory provision of your local law provides otherwise. If a court or arbitrator holds that TourBox Tech cannot enforce a part of this Warranty as written, those parts shall be deemed replaced with similar terms to the extent enforceable under the relevant law (or where a local court or arbitrator will not amend this Warranty, such part will be severed), but the rest of this Warranty will not change. Section 10(g) indicates what will happen if parts of Section 10 (Arbitration and Class Action Waiver) are found to be illegal or unenforceable. Section 10(g) prevails over this section if inconsistent with it. Notwithstanding the foregoing, in the event of a conflict between the terms of this Warranty and the terms of the applicable agreements found on TourBox Tech's website, the agreements found on TourBox Tech's website will control.

## 9. Choice of Law

If you live in (or, if a business, your principal place of business is in)

the United States, the laws of the State where you live (or, if a business, where your principal place of business is located) govern the interpretation of this Warranty, claims for breach of it, and all other claims (including consumer protection, unfair competition, implied warranty, and tort claims), regardless of conflict of laws principles, except that the Federal Arbitration Act governs all provisions relating to arbitration.

## 10. BINDING ARBITRATION AND CLASS ACTION WAIVER IF YOU LIVE IN (OR, IF A BUSINESS, YOUR PRINCIPAL PLACE OF BUSINESS IS IN) THE UNITED STATES

We hope we never have a dispute, but if we do, you and we agree to try for 60 days to resolve it informally. If we cannot resolve our dispute, you and we agree to binding individual arbitration before the American Arbitration Association ("AAA") under the Federal Arbitration Act ("FAA"), and not to sue in court in front of a judge or jury. Instead, a neutral arbitrator will decide, and the arbitrator's decision will be final except for a limited right of review under the FAA. Class action lawsuits, class-wide arbitrations, private attorney-general actions, and any other proceeding where someone acts in a representative capacity are not allowed; neither is allowed to combine individual proceedings without the consent of all parties.

10.1 Disputes Covered-Everything Except IP. The term "dispute" includes any claim or controversy between you and TourBox Tech concerning the Device, its price, advertising, marketing, communications, your purchase transaction, billing, or this Warranty under any legal theory including contract, warranty, tort, statute, or regulation, except disputes relating to the enforcement or validity of your, our licensors', our, or our licensors' intellectual property rights.

10.2 Mail Notice of Dispute First. If you have a dispute and our customer service representatives can't resolve it, send a Notice of Dispute by email to support@tourboxtech.com. Tell us your name, address, how to contact you, what the problem is, and how we can help. We will do the same if we have a dispute with you. After 60 days, you or we may start an arbitration if the dispute is unresolved.

10.3 Small Claims Court Option. Instead of mailing a Notice of Dispute, you may sue us in small claims court in your county of residence (or, if a business, your principal place of business) or in Santa Clara County, California, if you meet the court's requirements.

10.4 Arbitration Procedure. The AAA will conduct any arbitration

under its Commercial Arbitration Rules (or its Consumer Arbitration Rules if you are an individual and use the Device for personal or household use, or if the value of the dispute is \$75,000 or less regardless of whether you are an individual or how you use the Device). To start an arbitration, submit the form available at [aka.ms/us-arbitration](http://aka.ms/us-arbitration) to the AAA and mail a copy to TourBox Tech. In a dispute involving \$25,000 or less, any hearing will be telephonic unless the arbitrator finds good cause to hold an in-person hearing instead. Any in-person hearing will take place in your county of residence (or, if a business, your principal place of business) or Santa Clara County, California. The arbitrator may award the same damages to you individually as a court could. The arbitrator may award declaratory or injunctive relief only to you individually to satisfy your individual claim. Under AAA Rules, the arbitrator rules on his or her own jurisdiction, including the arbitrability of any claim.

#### 10.5 Arbitration Fees and Payments

- a) Disputes Involving \$75,000 Or Less. TourBox Tech will promptly reimburse your filing fees and pay the AAA's and arbitrator's fees and expenses. If you reject our last written settlement offer made before the arbitrator was appointed, your dispute goes all the way to an arbitrator's decision (called an "award"), and the arbitrator awards you more than this last written offer, we will do the following: (i) pay the greater of the award or \$1,000; (ii) pay your reasonable attorney's fees, if any; and (iii) reimburse any expenses (including expert witness fees and costs) that your attorney reasonably accrues for investigating, preparing, and pursuing your claim in arbitration.
- b) Disputes Involving More Than \$75,000. The AAA rules will govern payment of filing fees and the AAA's and arbitrator's fees and expenses.
- c) Must File within One Year. You and we must file in small claims court or arbitration any claim or dispute (except intellectual property disputes—see Section 11(a)) within one year from when it first could be filed. Otherwise, it is permanently barred.
- d) Severability. If any part of Section 11 (Binding Arbitration and Class Action Waiver) is found to be illegal or unenforceable, the remainder will remain in effect (with an arbitration award issued before any court proceeding begins), except that if a finding of partial illegality or unenforceability would allow class-wide or representative arbitration, Section 11 will be unenforceable in its entirety.

- e) Conflict with AAA Rules. This Warranty governs if it conflicts with the AAA's Commercial Arbitration Rules or Consumer Arbitration Rules.
