


## 1) User Manual

- FCC Labeling and required disclosure language is inside of the printed User Manual that is shipped with each Lumia system.



## 2) Mobile App

- Labeling is accessible within 3 clicks of the Home Screen of the Mobile app.  
Labeling will persist indefinitely inside of the app.
- As per KDB 784748 D02, "Products that are required to work in conjunction with another product that has a display, such as a smartphone..." qualify for e-labeling. A smartphone is required for normal Lumia operation.
