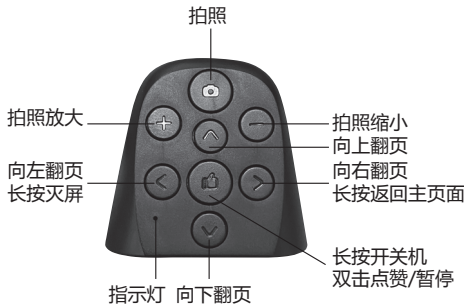

操作说明

1、用户操作说明：

- ① **点赞键**：长按点赞键开/关机（蓝灯闪烁）打开手机蓝牙，搜索BLE-M3连接
- ② **上下左右键**：打开手机状态可上下左右翻页（蓝灯闪烁）
- ③ **加减键**：打开拍照页面，+键拍照放大，-键拍照缩小（蓝灯闪烁）

④ **拍照键**：打开相机状态，单击拍照（蓝灯闪烁）

2、苹果设备用户操作多功能遥控说明(系统不支持加减键放大、缩小使用)

① 打开手机蓝牙，搜索BLE-M3连接（苹果设备用户先打开辅助功能）

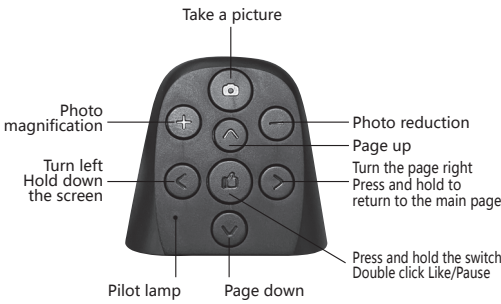

Operation instruction

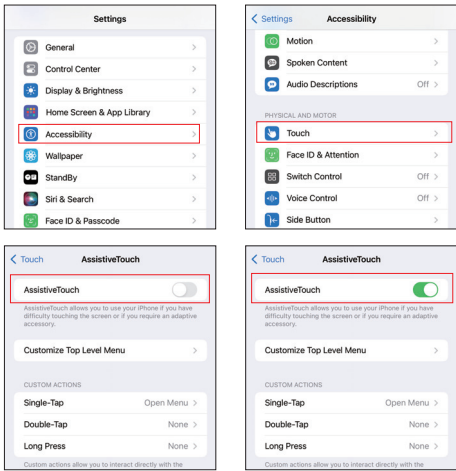
1、User operation instructions:

- ① **"Like" button**: Long press the "like" button to turn on/off (blue light blinking) to turn on Bluetooth and search for BLE-M3 connection
- ② **Up and down left and right key**: open the phone state can turn the page up and down (blue light flashing)
- ③ **Plus or minus key**: open the photo page, + key to zoom in, - key to zoom out (blue light flashing)

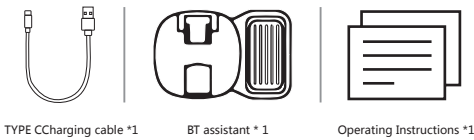
④ **Camera key**: Open the camera state, click to take pictures (blue light flashing)

2、Apple device user operation multi-function remote control instructions (the system does not support the addition or subtraction key to enlarge and reduce the use of)

① Turn on the Bluetooth of the phone and search for BLE-M3 connection (Apple device users turn on the auxiliary function first)
