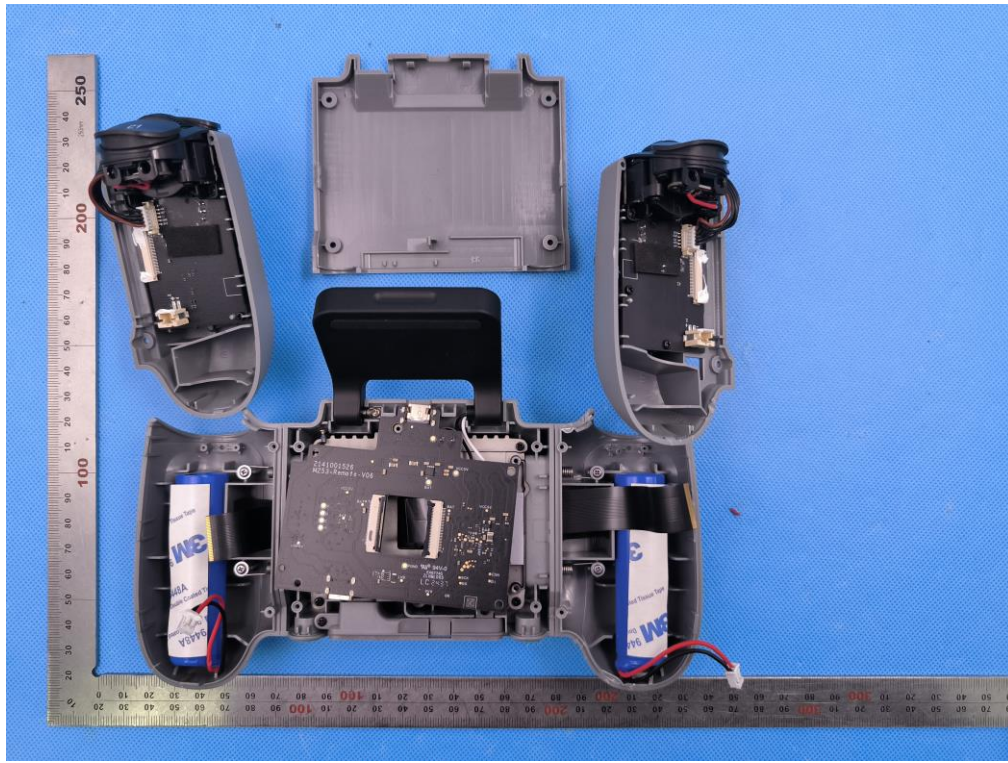
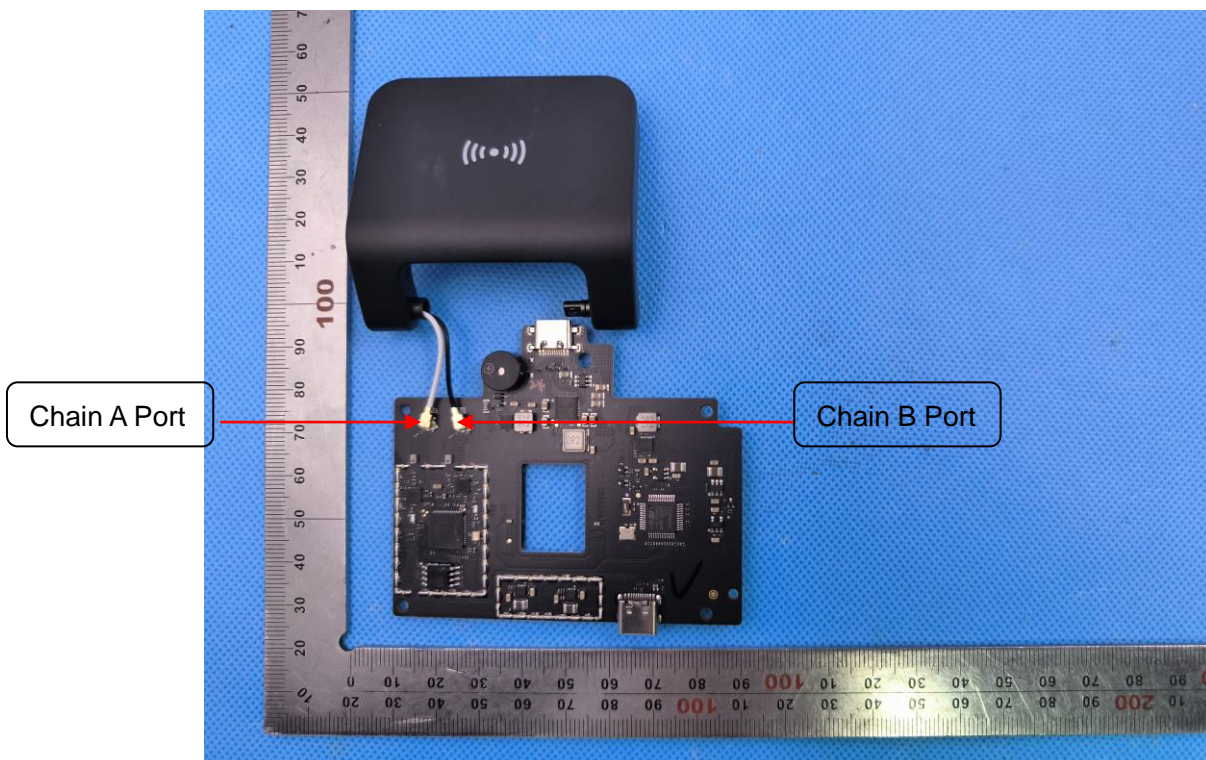

OPEN VIEW OF EUT (FIGURE 1)

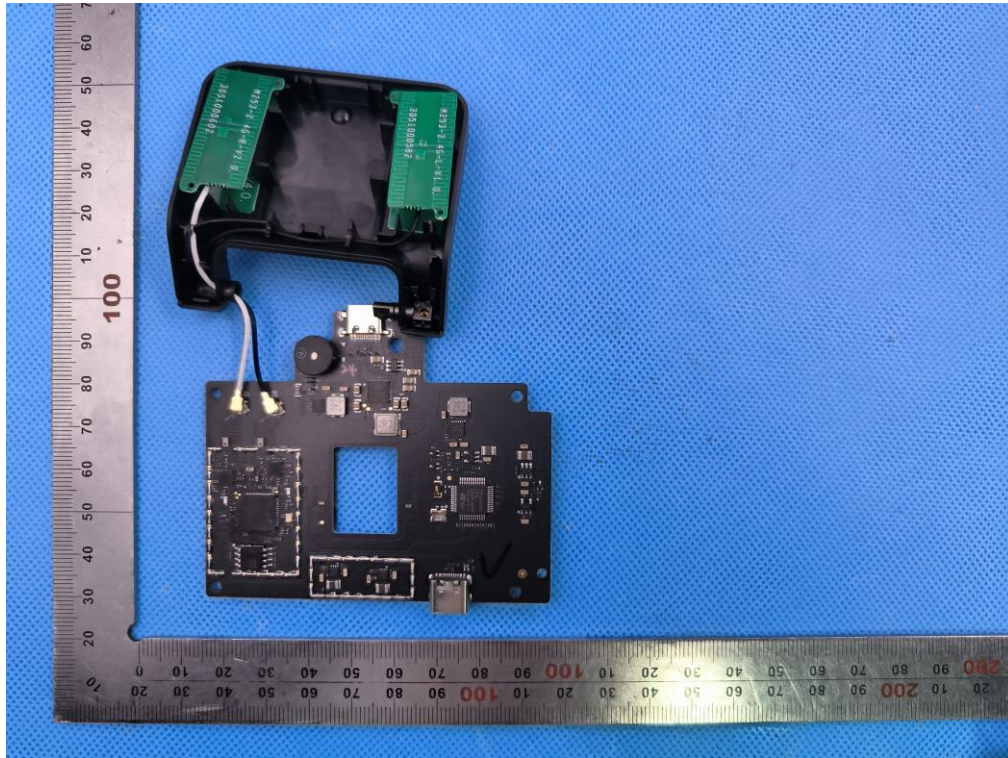


OPEN VIEW OF EUT (FIGURE 2)

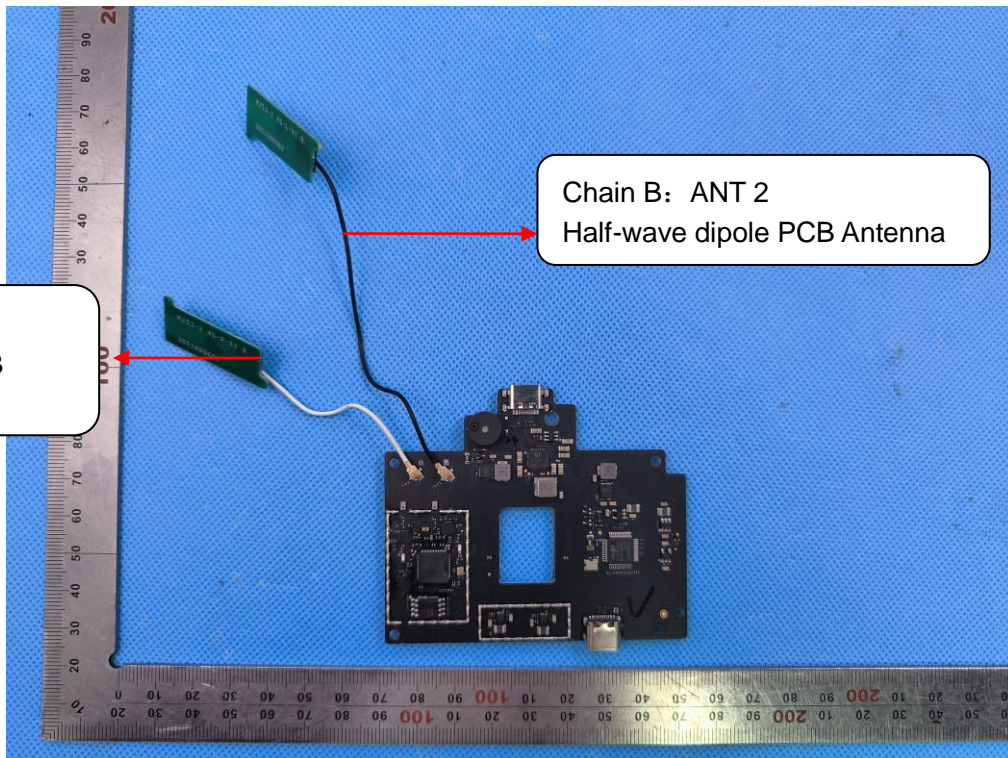

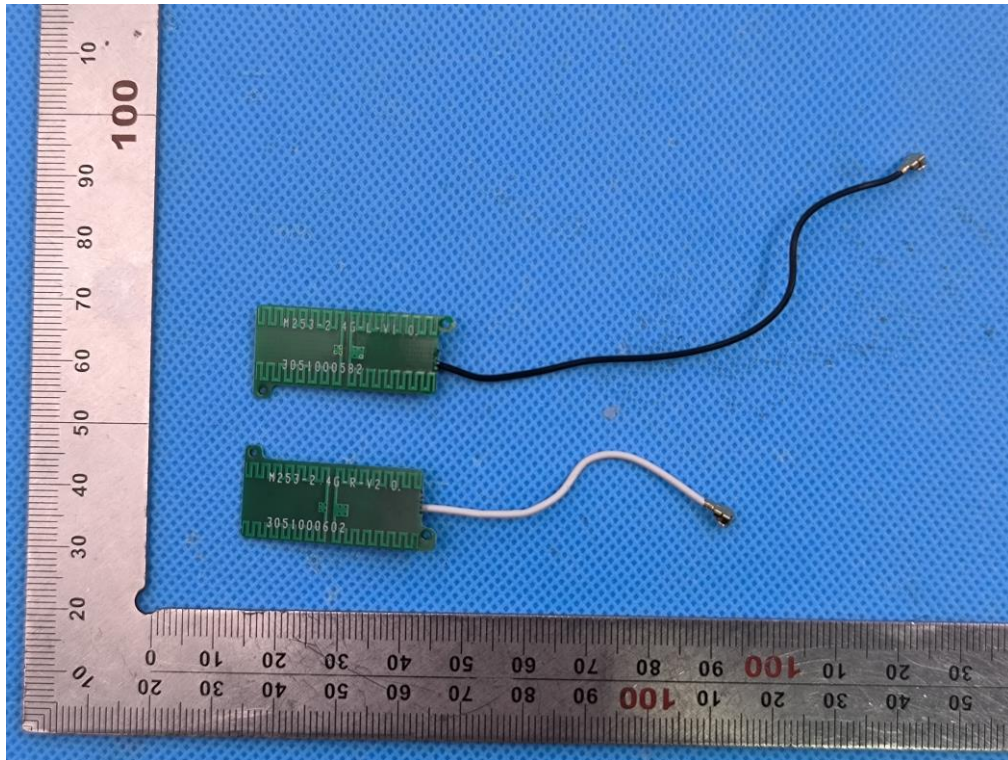
Chain A: ANT 1

Half-wave dipole PCB Antenna

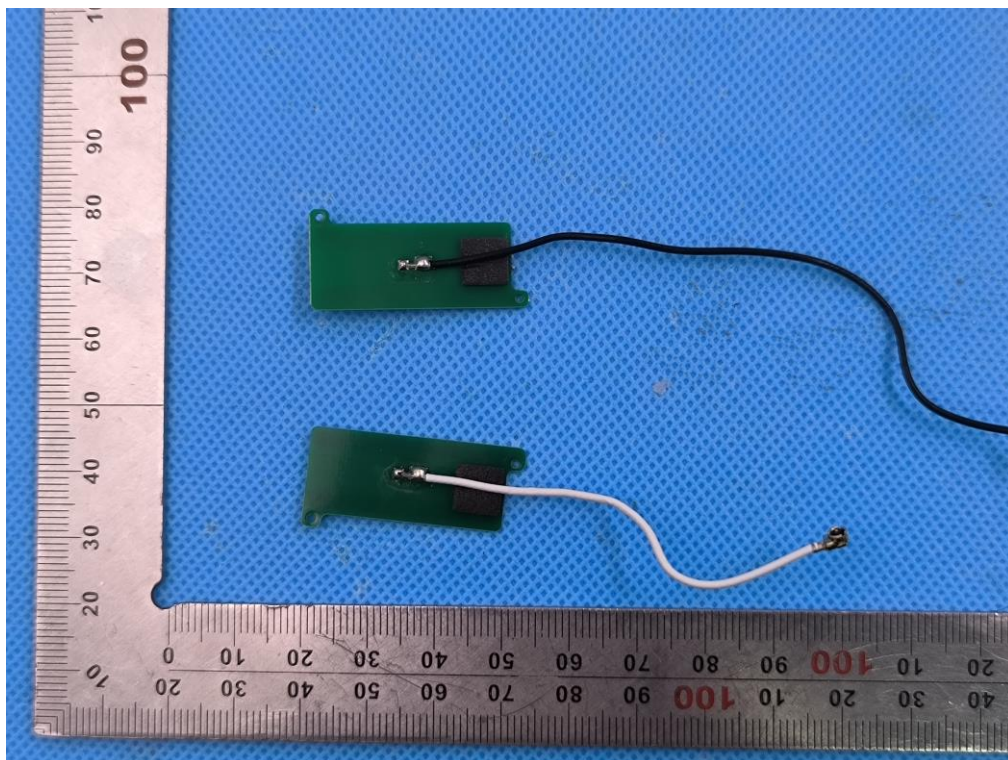

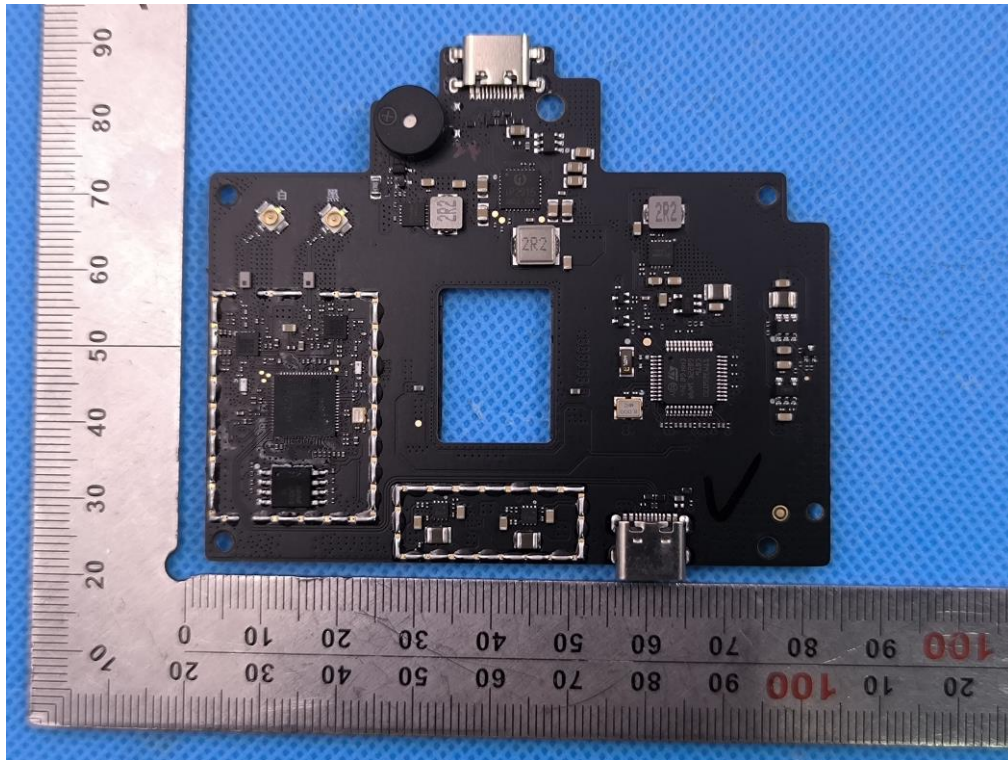

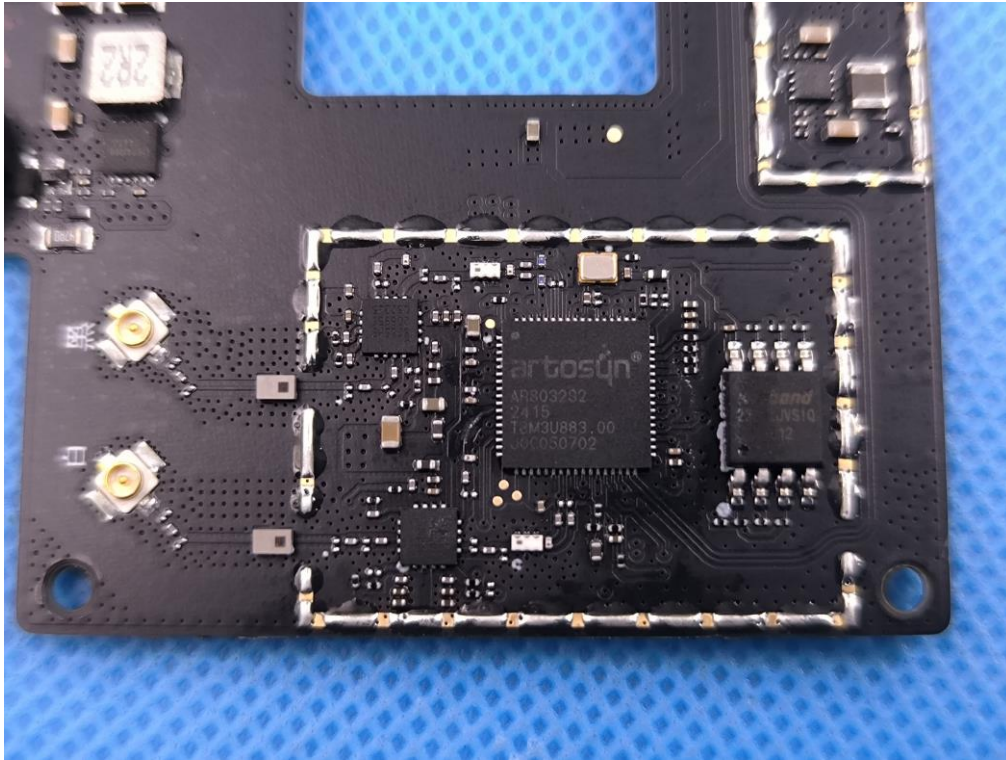


INTERNAL VIEW OF EUT-1 (FIGURE 3)

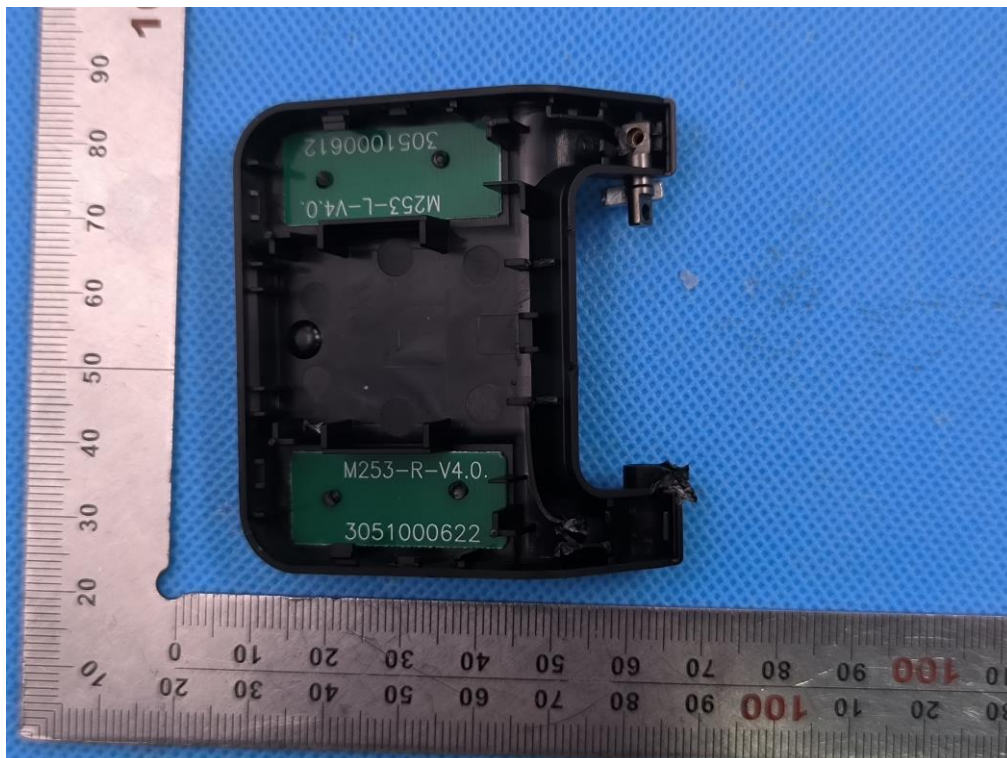

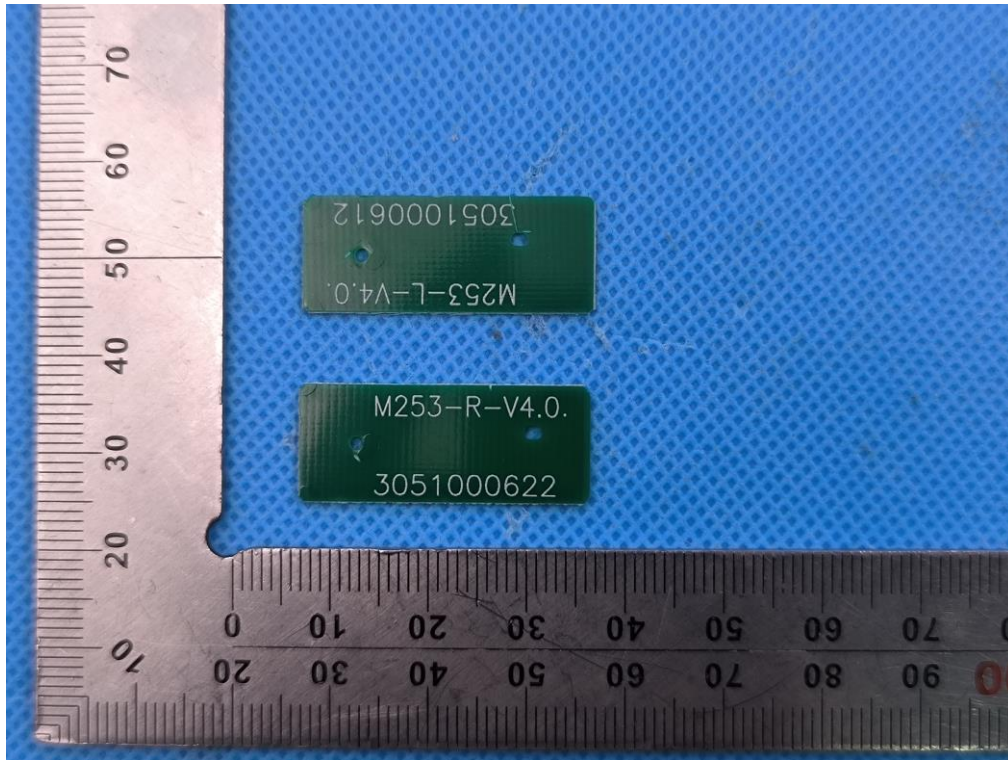

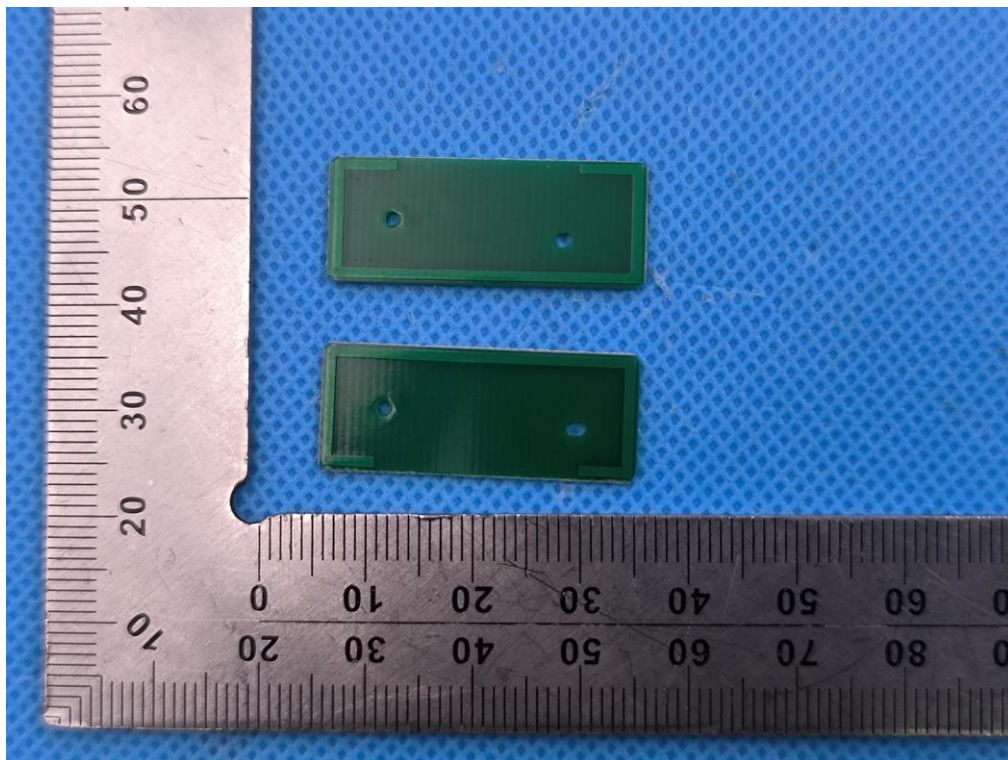

INTERNAL VIEW OF EUT-1 (FIGURE 6)



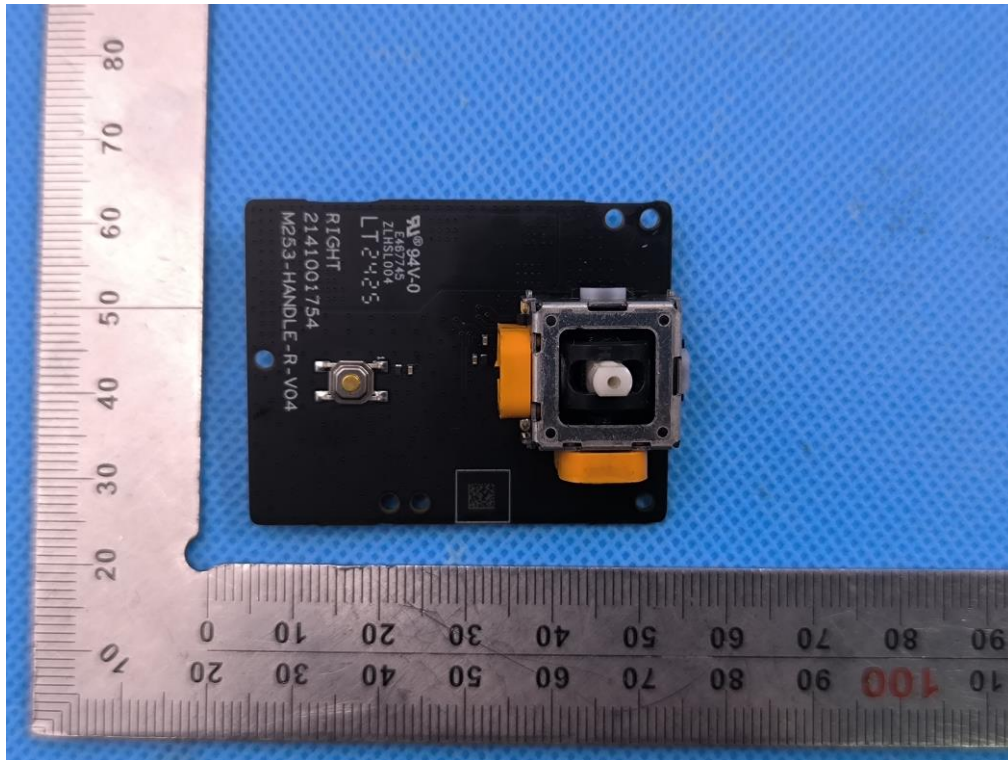
INTERNAL VIEW OF EUT-1 (FIGURE 7)



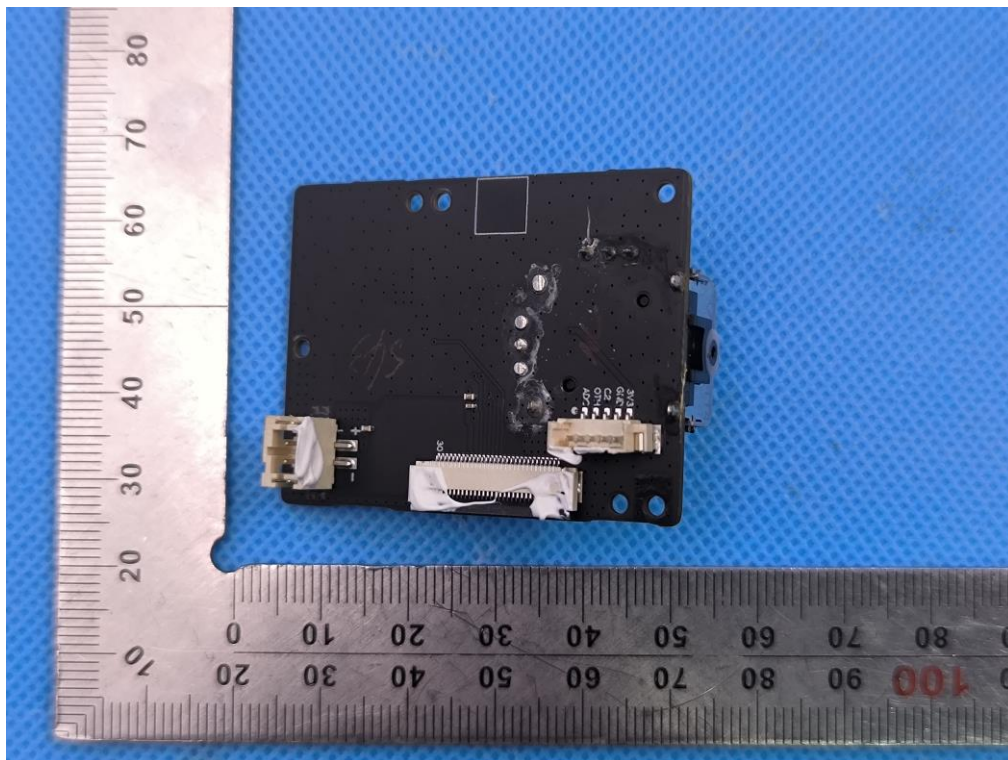

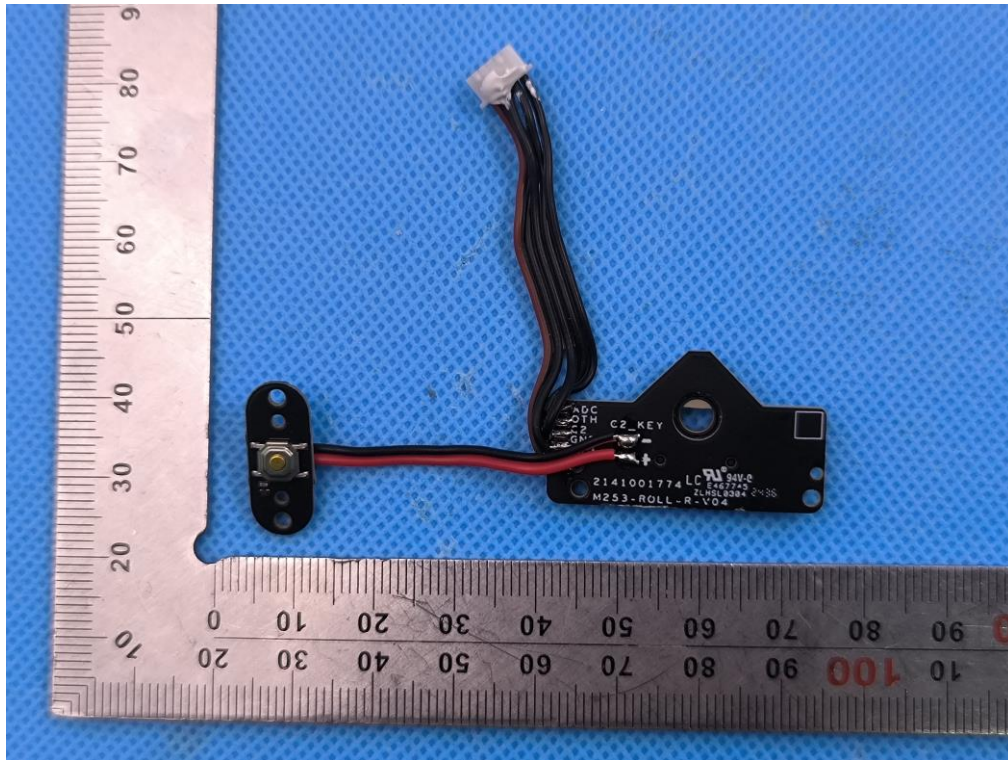

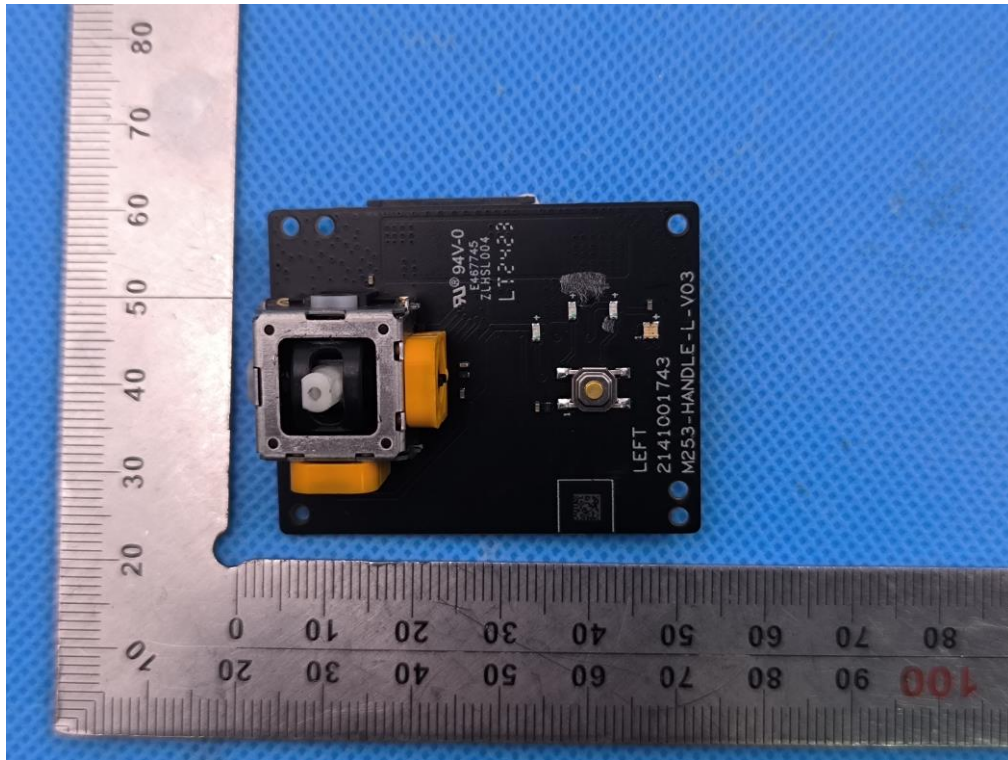

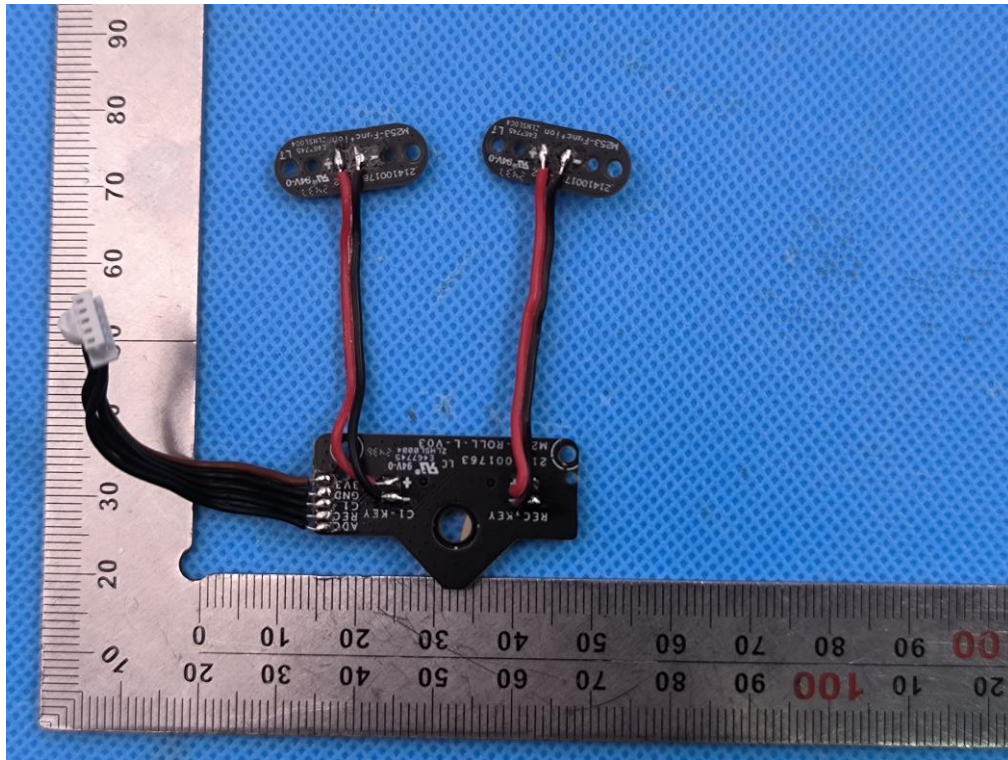
INTERNAL VIEW OF EUT-1 (FIGURE 13)



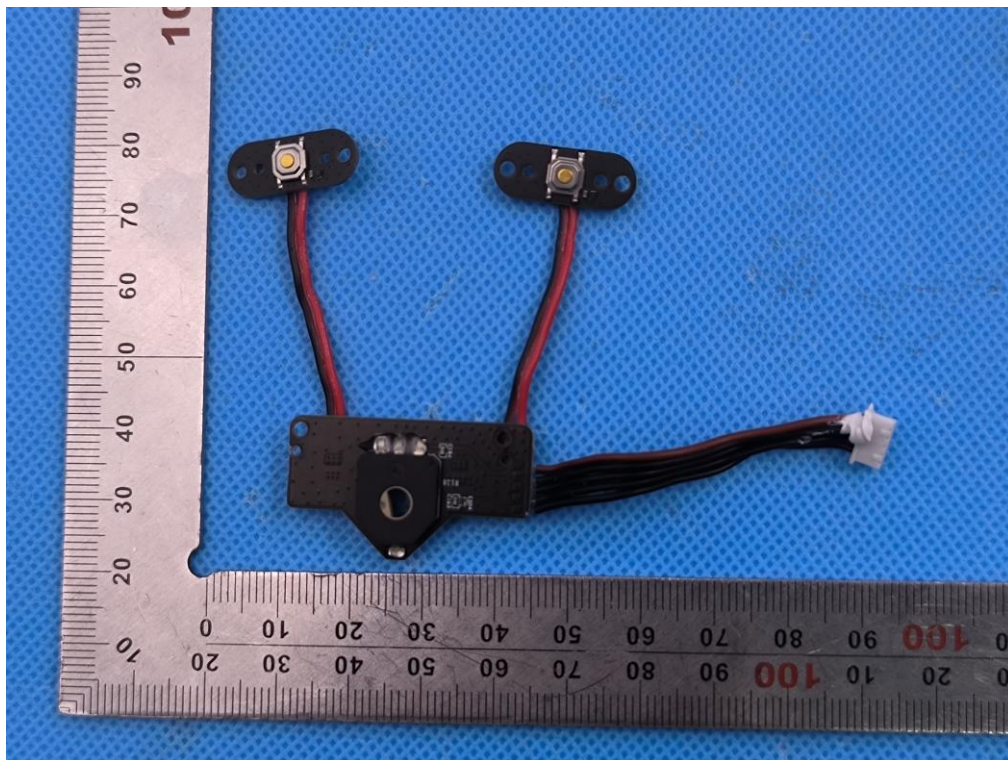

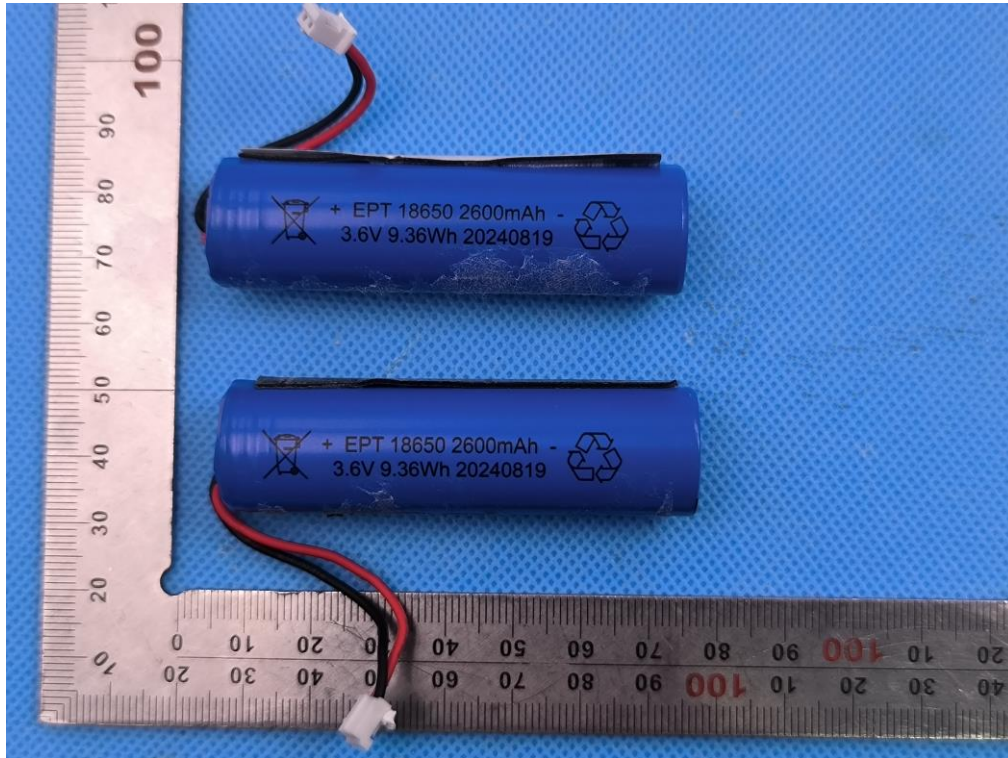


INTERNAL VIEW OF EUT-1 (FIGURE 15)
