

Quick Start guide for the Kids Smartwatch

Before use, please read the instruction manual carefully so that you can install and use it quickly. Product color depends on the actual model.

1. Preparation before use

Please check whether the device is undamaged and whether the accessories are complete.

Please select a 4G SIM Please refer to the carrier for details. (Please turn off the device before you install the SIM card.)

The SIM card needs to enable GPRS function and caller ID display function. Bar code or two-dimensional code is used to register users.

3. Watch introduction

3.1 Status Bar: Pull down the status bar to display signal, battery, date, week, carrier's information and push message of the application.

3.2 Camera: You can click to take photos or videos.

3.3 Gallery: You can click it to view the photos taken by the watch. Photos can be shared, deleted and modified.

3.4 Contact: Display the phone numbers saved by the application, you can click and make calls.

3.5 Video Call: You can make video calling after the watch is bound.

3.6 Phone: You can make calls by the dial.

3.7 Curriculum schedule: You can click in to see the courses set by APP from Monday to Friday. You can click on the course name to view the course time and modify the timetable in app operation.

3.8 Settings: Wireless and network, screen brightness, volume adjustment (call ringtone, system sound, alarm clock), setting screen dormancy time, setting device voice, time and date, restoring factory settings, about device, shutdown, restart (software version, IMEI, etc.).

3.9 Make Friends: Click on the interface, and two watches touch each other to make friends. After making friends, the picture will light up. The watch of this model can make up to four friends. You can click on your friend's head to chat with your friends to send voice and pictures to your friends. You can press the messages sent by your friends for a long time to delete and delete all. You can delete your friends by pressing the "friend picture" for a long time.

3.10 Chat: You can click in to chat with the APP and send voice and pictures to mobile phone app. Be careful: Watch can

not send text messages to mobile phone app, while mobile phone app can send text messages to watch.

3.11 AppCode: Click to display the application code, you can scan and download SeTracker 2 APP.

3.12 RegCode: Click to display the watch's registration code.

Note: Part feature model, the specific in kind prevail

4. Installation instructions - Sim Card


4.1: Separate the watch body and the case so that the watch becomes two independent individuals, as shown in the picture.



4.2: Select the watch body, pull out the card inserter, and insert the SIM card, as shown in the figure.



4.3: Integrate the watch body with the case, then turn on the watch, as the picture shows



Note: The model is for reference only, please refer to the actual product.

5. Power on /off

5.1. Power on: long press the power button to power on the watch when the watch is turned off.


5.2. Power off:

way 1: go to the settings and select power off and click to power off the watch.

Way 2: if the watch is binded and with internet connection, you can choose 'Remote Power Off' in the application to power off the watch.

Way 3: if not insert the sim card in the watch, you can long press the power button to power off the watch.

7.1: Use smart phone scan code tools to scan the **SeTracker 2 APP** code and download.





8: SeTracker 2 APP Introduction


8.1: Register APP Account:

Click 'Sign Up' and following the steps of the APP to register an account and log in.



8.2: Binding the watch:

Log in the homepage of the APP, click the '+' to add the kids watch:



Please scan or input device ID: please scan the Registration Code on the kids watch to bind the watch.

Basic Information: input kids watch's name here, eg: baby.

The first binding account is the Administrator, other family members need the authorization by the Administrator. After the member submits the binding, an authorization pop-up message will appear on the administrator's app. If it does not appear, please exit the administrator account and log in again to open the authorization interface. After authorization, the member is successfully created.

Note: Registration code is the 15 digits not the IMEI number.

8.3: SeTracker 2 Features:

Contacts: add contact phone numbers.

Chat: you can send voice message, photos and emoji to the watch.

Call Device: input the watch's phone number, your phone will call the watch.

Health: open or turn off the step counter of the watch.

Alarm Clock: 3 alarms can be set.

Rewards: you can send rewards to the watch and it will show the love and numbers in the watch's main page.

Activity Schedule: set kids watch's school timetable.

Video Call: you can make video calls after the watch is bound successfully.

SoS Numbers: you can set 3 SOS numbers. Press the SOS button in emergency for 3 seconds, looping to dial the 3 numbers. If no one answers, it ends in two rounds.

Tracking Frequency: you can set the location uploading interval time.

Sounds: you can set the watch's sound, vibration, ringtone or mute.

Do Not Disturb: you can set 4 disturb mode during class time, the watch will be locked during the time.

SMS Alerts: set low battery and SOS alarm notifications, the notifications will be sent by SMS.

Disable Functions: set the dialing interface and GPS function switch of the kids watch.

Time Zone: set time zone, including summer Time and winter Time.

Retrieve Watch SMS: can open and turn off the SMS functions for the related alarm information (SMS charges normally)

Reject Unknown Calls: if turns on, only family members can call the watch, others cannot call the watch. If turns off, any phone numbers can call the watch.

Friend Information: display information about making friends successfully.

Reject Unknown Calls: the default state is off. If turn on, the phone numbers not in the contact cannot call the kids watch.

Remote Shutdown: click it to turn off the watch automatically.

Reset Device: click it to reset to factory mode.

Remote Restart: click it to restart the watch.


Unbind: click to unbind the watch.

LBS+GPS+WIFI Location: click to check the kids watch's location.

SeTracker 2 map interface: green icon represents LBS location, blue icon represents WiFi location, red icon represents GPS location.

Historical Route: check the history route of the watch in the APP.


Safe Zone: set safe zone in the APP, it will alarm when the watch leave the zone.



9: Where you can find the watch's registration code?

9.1: QR Code > RegCode

9.2: the registration code is sticcked on the watch's back.
