
Eye Massager

Must read before use


Unsuitable For

- 1. For people nearsighted with more than 8.0 diopters, please use the product under the guidance of a doctor;
- 2. Patients with severe glaucoma and cataract;
- 3. Children under 7 years old are suggested not to use the eye massager;
- 4. People with stroke sequelae are forbidden to use it;
- 5. Patients with injuries around the eyes and patients who have just gone through surgeries (like double eyelid surgery) are forbidden to use it during the rehabilitation period;
- 6. Those who have undergone major eye surgeries such as glaucoma, cataract and retinal detachment are forbidden to use it; For people who have done the myopic surgery for one year, please consult your doctor for advice;
- 7. People with severe inflammation of eyes are forbidden to use it.

Safety Instructions

- 1. It is recommended to appropriately adjust the product with suitable tightness when using it (the tightness can be adjusted slowly based on the user's experience in use). When it is in use, the user should lean against the sofa or chair for better fitting, more uniform stress, and better effect and comfort!
- 2. It is recommended to use it 1-2 times a day for 10-20 minutes each time. Remember to close your eyes and rest for 3-5 minutes after use, and your eyes will be more comfortable in this way.
- 3. The product can be used after charging.
- 4. Product cleaning: Wipe the mask and cover of the product with a wet towel or a cotton ball dipped in 75% medical alcohol.
- 5. Keep away from fire source, corrosive liquids and various kinds of adverse environments

Operation Instructions

- 1. Press the button (b) for 3 seconds to turn on and off.
- 2. Short press the button **(b)** to switch between different modes, Dynamic mode, Warm mode, Cooling mode, Automatic mode.
- 3. Double-click the button (b) to pause/resume music playback.
- 5. When the Bluetooth \$\frac{1}{2}\$ lights up, it means that the mobile phone has been successfully connected to the product Bluetooth and can play mobile music; When the music \$\int_1\$ lights up, it means that the product's own music is being played and the mobile phone Bluetooth is not connected.

Function Description

- 1.Dual channel output speaker 8R0.8W
- 2. Charging current 900mA.
- 3.Two hot and cold tablets.
- 4.Two 10KR thermistor.
- 5.Horn, air pump, air valve using 1.0MM terminals, battery, hot and cold pieces, temperature resistor using 1.25MM terminals.
- 6. When the battery power is 3.3V, the battery quantity detection and alarm are carried out.
- 7. Charging indicator light charging red light, fully charged blue light.
- 8. The default working time is 10 minutes.
- 9. Warm compress temperature: 39 degrees.
- 10. Cold compress mode temperature is 18 degrees.

- 1.Boot: Welcome to use the smart eye massager.
- 2. Shut down: Thank you for using.
- 3. Working mode: Dynamic mode, Warm mode, Cooling mode, Automatic mode.
- 4. Air pressure: Air pressure soft, air pressure strong, air pressure off.
- 5.Low power alarm: Low battery power.
- 6.Bluetooth Connected: Successfully connected Bluetooth.
- 7.Bluetooth Disconnect: Bluetooth has been disconnected.



Status	Potential causes / treatment methods		
Unable to start the machine	Please confirm whether the battery is low; Please confirm whether the product switch has been turned on;		
Unable to charge or no charging indicator	Please check whether the type-C cable is connected properly;		
The machine suddenly stopped when it is working	Is the product low on power? Or is the massage time up?
