6.1.2 Conclusion

15.203 requirement:

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator, the manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited.

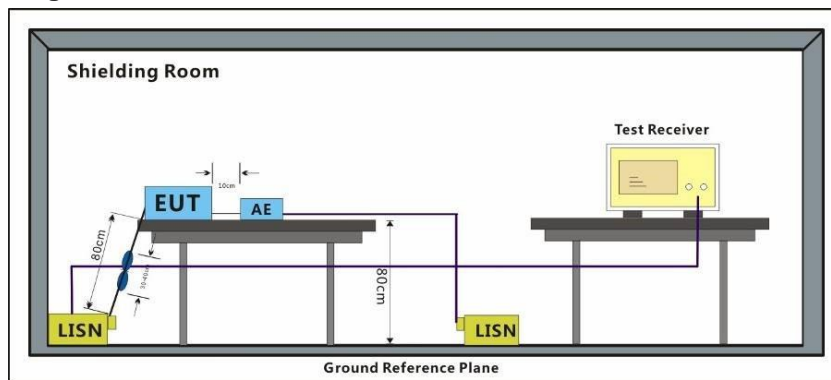

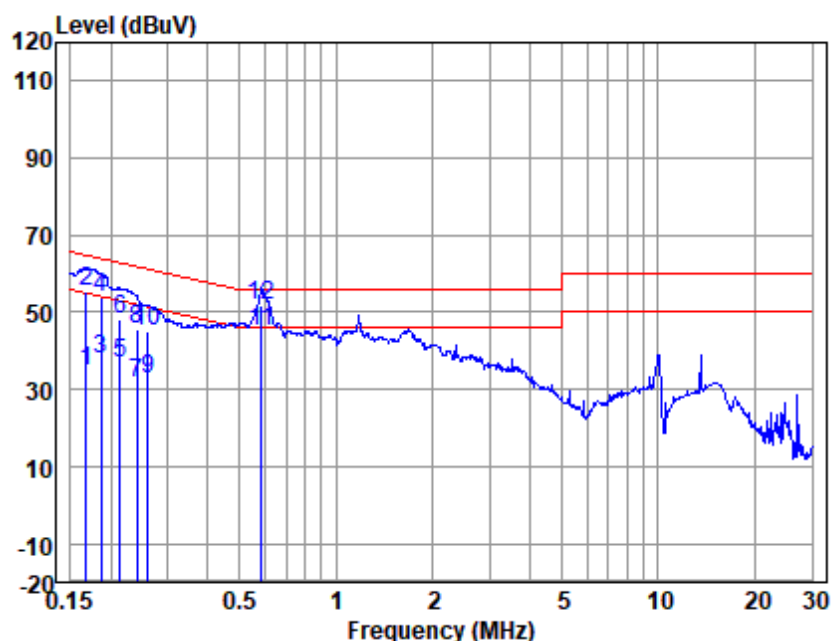


7.1.4 Measurement Procedure and Data

- 1) The mains terminal disturbance voltage test was conducted in a shielded room.
- 2) The EUT was connected to AC power source through a LISN 1 (Line Impedance Stabilization Network) which provides a 50ohm/50μH + 5ohm linear impedance. The power cables of all other units of the EUT were connected to a second LISN 2, which was bonded to the ground reference plane in the same way as the LISN 1 for the unit being measured. A multiple socket outlet strip was used to connect multiple power cables to a single LISN provided the rating of the LISN was not exceeded.
- 3) The tabletop EUT was placed upon a non-metallic table 0.8m above the ground reference plane. And for floor-standing arrangement, the EUT was placed on the horizontal ground reference plane,
- 4) The test was performed with a vertical ground reference plane. The rear of the EUT shall be 0.4 m from the vertical ground reference plane. The vertical ground reference plane was bonded to the horizontal ground reference plane. The LISN 1 was placed 0.8 m from the boundary of the unit under test and bonded to a ground reference plane for LISNs mounted on top of the ground reference plane. This distance was between the closest points of the LISN 1 and the EUT. All other units of the EUT and associated equipment was at least 0.8 m from the LISN 2.
- 5) In order to find the maximum emission, the relative positions of equipment and all of the interface cables must be changed according to ANSI C63.10 on conducted measurement.

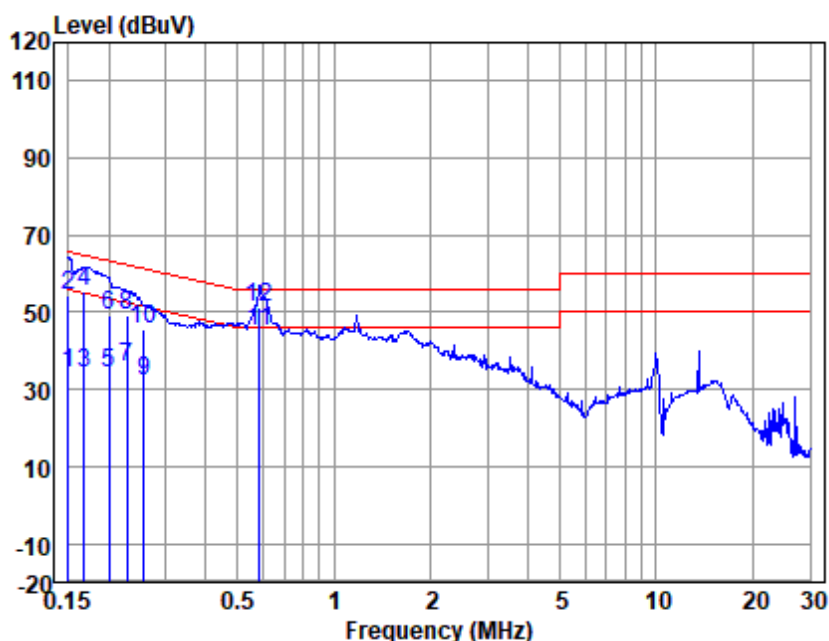

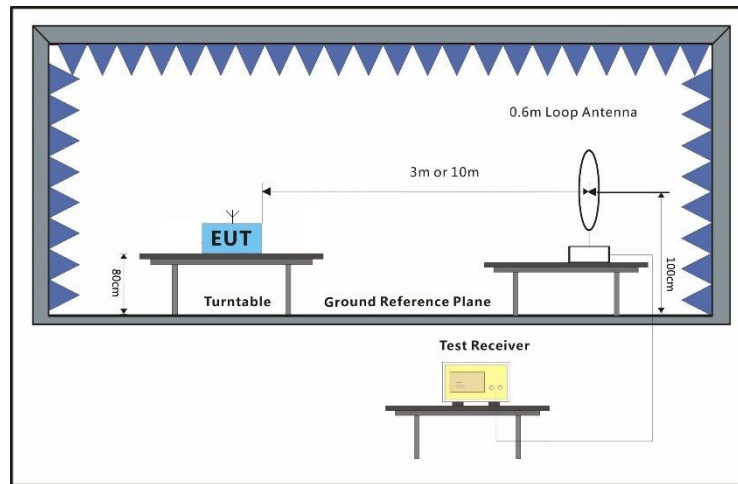

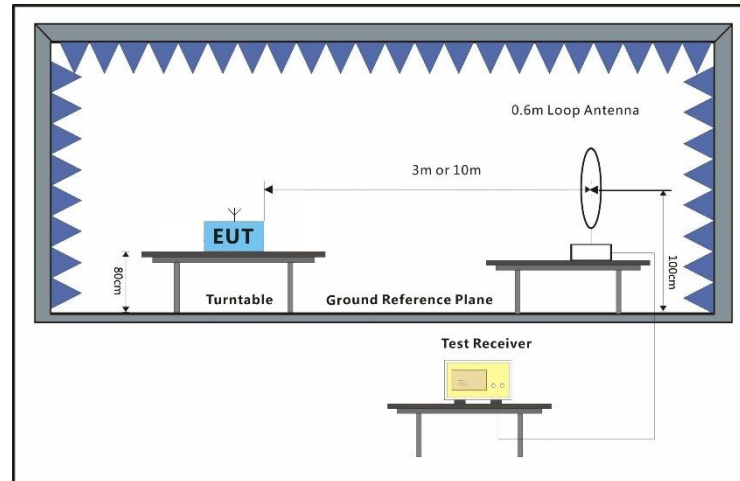

7.3.4 Measurement Procedure and Data

For testing performed with the loop antenna, the center of the loop was positioned 1 m above the ground and positioned with its plane vertical at the specified distance from the EUT. During testing the loop was rotated about its vertical axis for maximum response at each azimuth and also investigated with the loop positioned in the horizontal plane. Only the worst position of vertical was shown in the report.

Note: The test level of the fundamental signal is below the limit of general spurious emission, so the test item doesn't be performed.

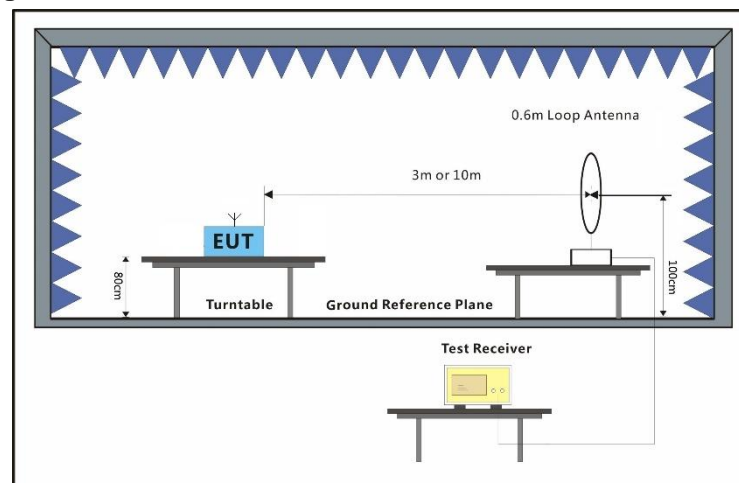

If that point is closer to the EUT than $\lambda/2\pi$ and the limit distance is greater than $\lambda/2\pi$, the measurement shall be extrapolated to the limit distance by conservatively presuming that the field strength decreases at a 40 dB/decade of distance rate to the $\lambda/2\pi$ distance, and at a 20 dB/decade of distance rate beyond $\lambda/2\pi$. This shall be accomplished using Equation (2):

$$FS_{(10m)} = FS_{(30/300m)} + 40\log\{d_{(near\ field)}/d_{(10m)}\} + 20\log\{d_{(30/300m)}/d_{(near\ field)}\} \quad (2)$$

If the single point measured is at a distance greater than $\lambda/2\pi$, then extrapolation to the limit distance shall be calculated using Equation (3):

$$FS_{(10m)} = FS_{(30/300m)} + 20\log\{d_{(30/300m)}/d_{(10m)}\} \quad (3)$$

If both the single point and the limit distance are equal to or closer to the EUT than $\lambda/2\pi$, then extrapolation to the limit distance shall be calculated using Equation (4):

$$FS_{(10m)} = FS_{(30/300m)} + 40\log\{d_{(30/300m)}/d_{(10m)}\} \quad (4)$$

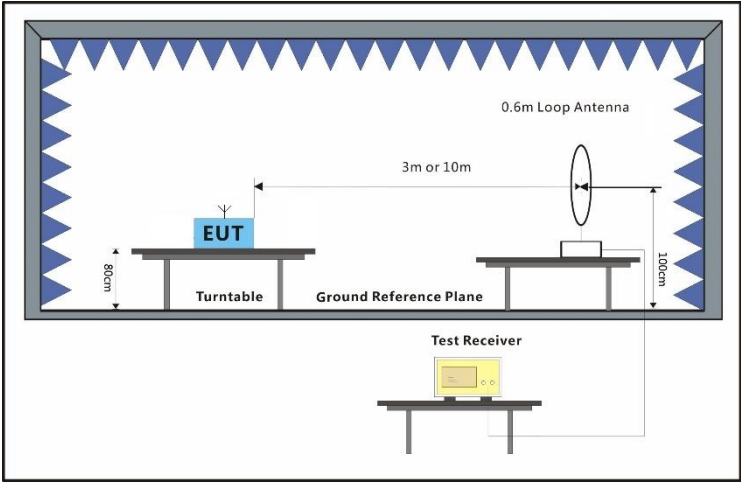

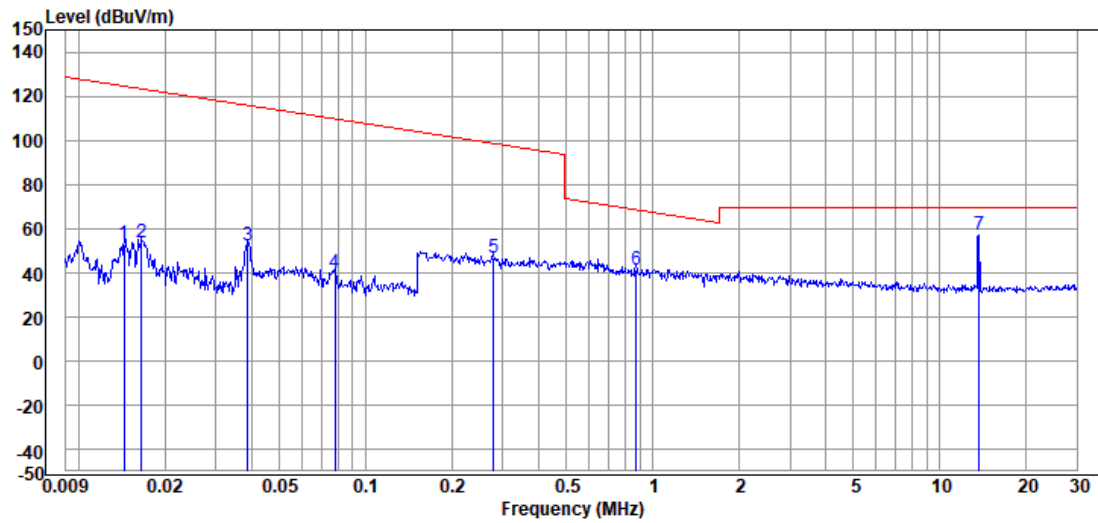
7.5.3 Test Setup Diagram

For testing performed with the loop antenna, the center of the loop was positioned 1 m above the ground and positioned with its plane vertical at the specified distance from the EUT. During testing the loop was rotated about its vertical axis for maximum response at each azimuth and also investigated with the loop positioned in the horizontal plane. Only the worst position of vertical was shown in the report.

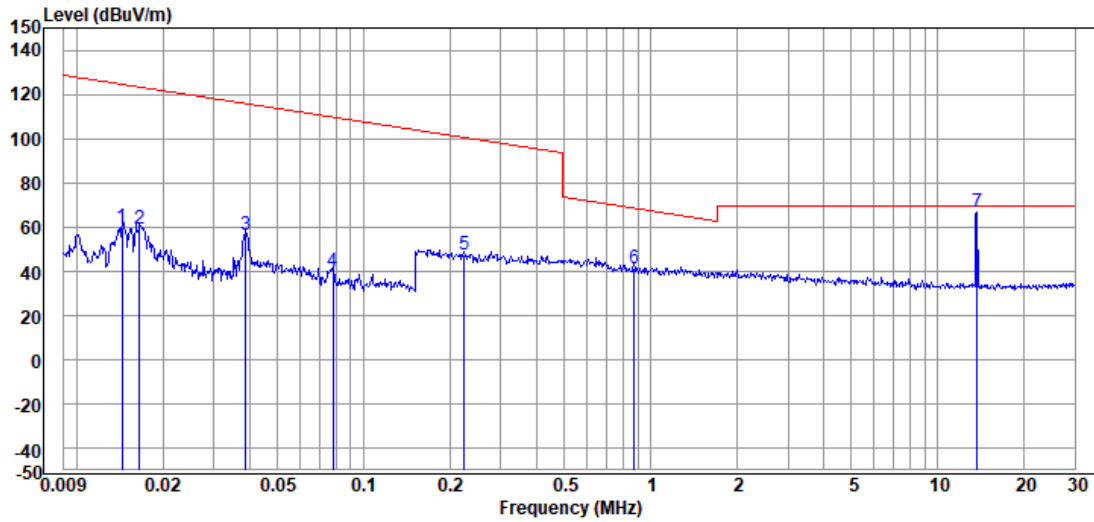

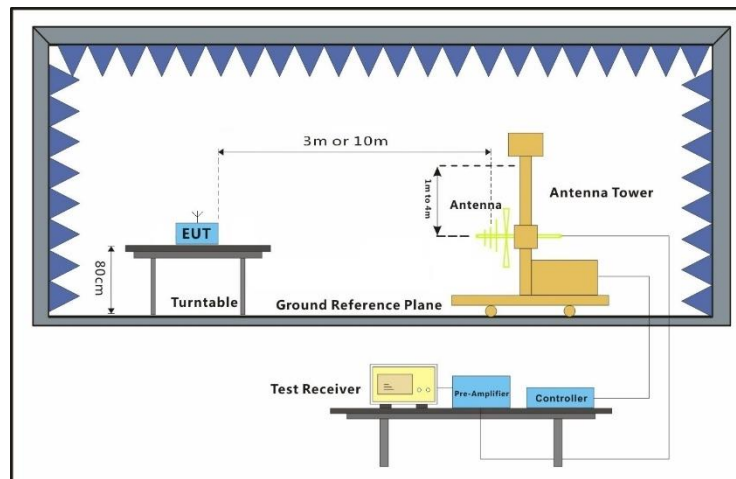

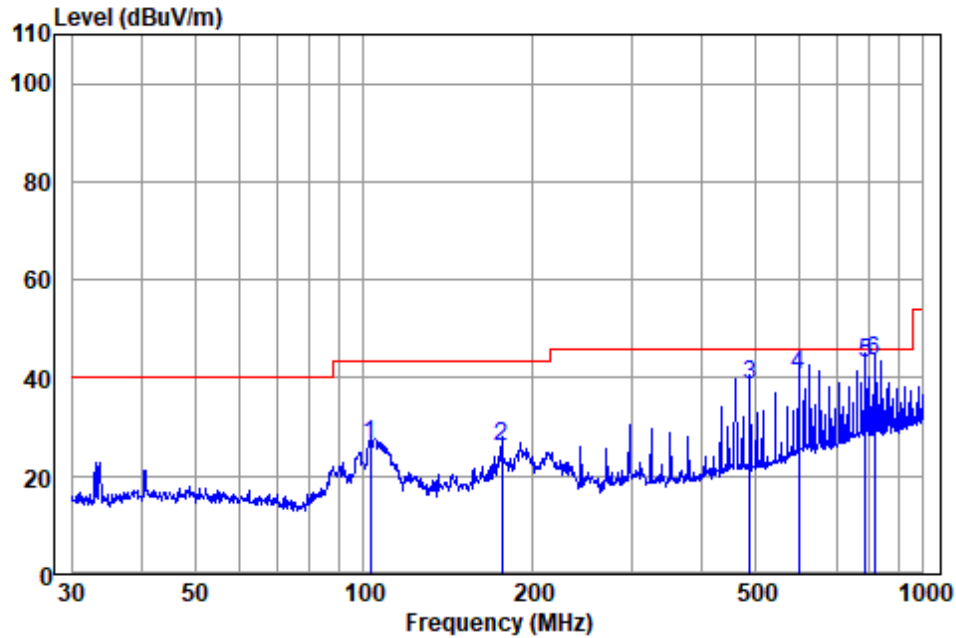
7.6.3 Test Setup Diagram

a. The EUT was placed on the top of a rotating table 0.8 meters above the ground for below 1GHz at a 3 meter semi-anechoic chamber. The table was rotated 360 degrees to determine the position of the highest radiation. b. The EUT was set 3 meters away from the interference-receiving antenna, which was mounted on the top of a variable-height antenna tower. c. The antenna height is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement. d. For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters (for the test frequency of below 30MHz, the antenna was tuned to heights 1 meter) and the rotatable table was turned from 0 degrees to 360 degrees to find the maximum reading. e. The test-receiver system was set to Peak Detect Function and Specified Bandwidth with Maximum Hold Mode. f. If the emission level of the EUT in peak mode was 10dB lower than the limit specified, then testing could be stopped and the peak values of the EUT would be reported. Otherwise the emissions that did not have 10dB margin would be re-tested one by one using peak, quasi-peak or average method as specified and then reported in a data sheet. g. The radiation measurements are performed in X, Y, Z axis positioning. And found the X axis positioning which it is worse case, only the test worst case mode is recorded in the report. 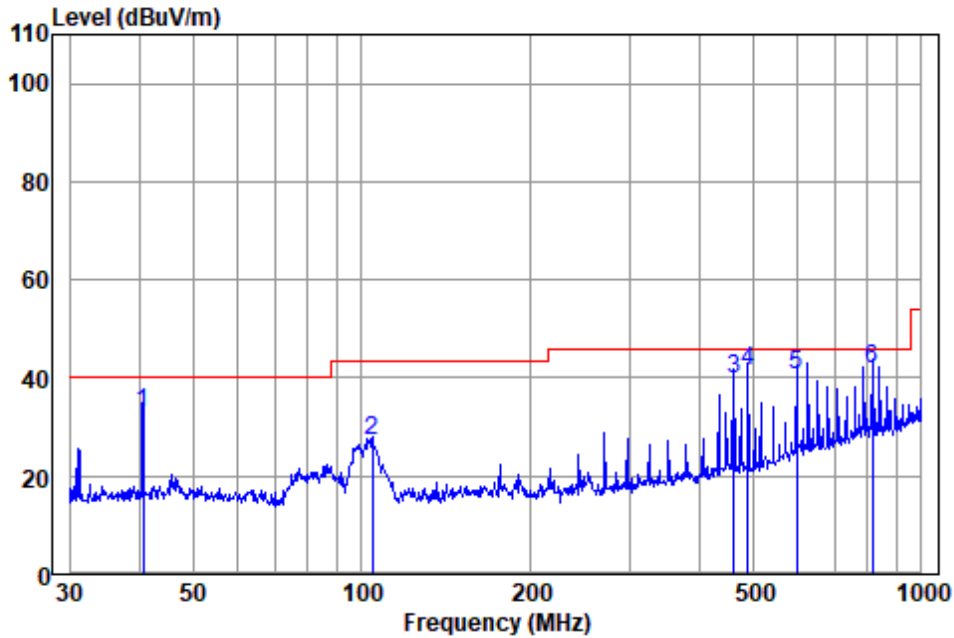
