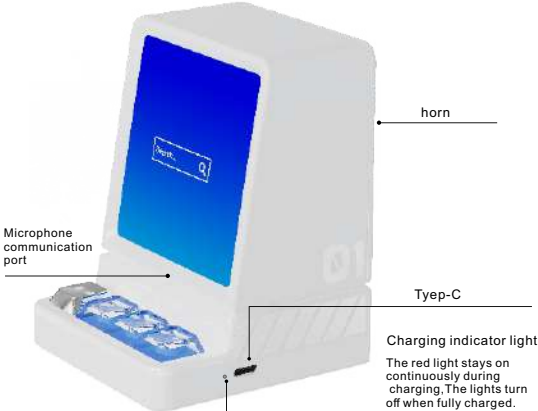
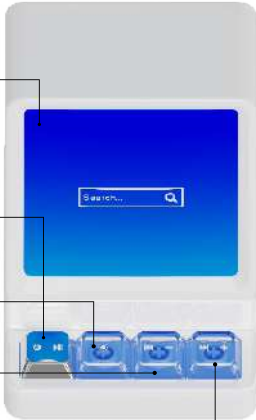
Instructions for
using Bluetooth speaker
Lighting display screen

Power button/Shutdown button/
Pause button/Play button
Long press to turn on or long press to
turn off, Press pause while playing
music, then press play again. On the
first startup, the screen lights up and
the Bluetooth light on the buttons
flashes, After pairing with Bluetooth
model S01, the button light stays on.

Display screen lighting control button
When turned on, the default breathing
color effect changes, Press again to
switch to music rhythm effect. Press
again to turn off the lights. Such a cycle.

Volume reduction/previous song
Press to decrease the volume by one level,
Or press twice to play the previous song.

Volume Up/Next Song
Press to increase the volume by one level,
Or press twice to play the next song.



Note:
