

2.4G ANTENNA:

The entire series is equipped with a 2.4G transmitter and receiver, supporting multiple people playing against each other simultaneously.

INDICATOR LIGHT:

Provides timely feedback on each remote control operation through a red light.

***Spray Edition Water Tank Filling Port:**

Open the car's rear cover and use the included water bottle to fill the tank with pure water, ready for spraying at any time.

available for selection.



FUNCTION KEY 1:

Short press to switch the bumper car sound effects, with two options:
a. Wave sound effect, which can interfere with the opponent's operation;
b. Switch to background music to enhance the gaming atmosphere.

*For the spray version: When playing (a) wave music, smoke will be emitted from the back (for 60 seconds); when switched to (b) background music, the spraying will be paused.

FUNCTION KEY 2:

Short press: Enter the vehicle demonstration function;

Long press: Set the entire vehicle operation to mute, and press again to re-enable the sound effects.

FUNCTION KEY 3:

By colliding with the vehicle, this button is triggered first for the opponent, which can eject the opponent's driver figurine, and the side that does not eject wins!

Note: After the remote control car (or controller) is powered off, it needs to be re-matched. After re-installing the batteries, it can be matched with the nearest remote controller (or car) that has no signal.

FCC STATEMENT
