## Light-up Dancing Challenge Playmat

This unit includes: 1 x Light-up Dancing Challenge Playmat

Before use:

Open the back battery compartment with a screwdriver and install 3 AA batteries (not included). Close the lid and flatten the mat. When the power is on, the mat will play a Power On signal.

### Dance Game Mode

- Press  to enter dance game mode.
- Press   to select background music and difficulty level.
- Follow the lights and hit corresponding dance pads on the mat correctly to get scores.

### Memory Game Mode

- Press  to enter memory game mode.
- Press   to select background music and difficulty level.
- Memorize the lights in sequence and hit corresponding dancing pads on the mat in the same order to get scores.

### Piano Mode

- Press  to enter piano mode and step on dance pads to play tunes.
- Press   to adjust volume.

## Bluetooth Mode

- Press  to connect Light-up Dancing Challenge Playmat to external music device and play favorite tunes.

## Battery Warning and Caution
