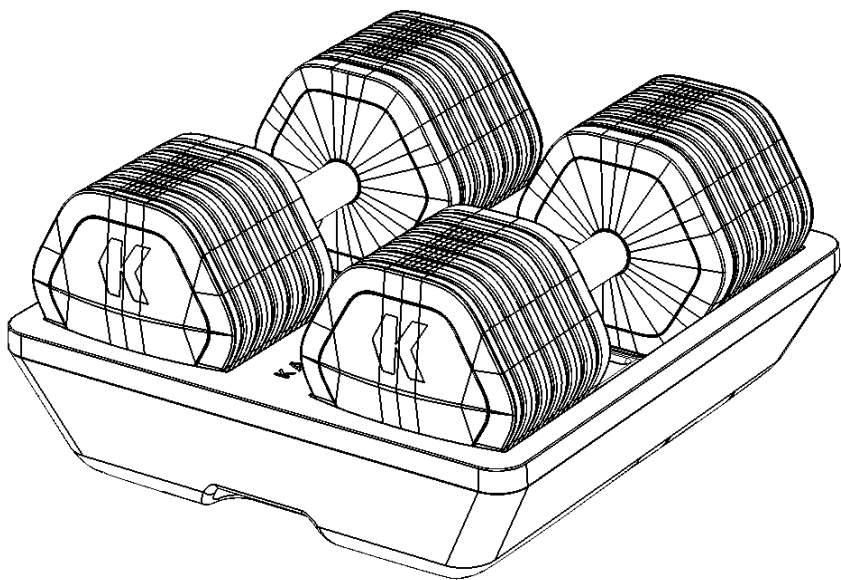

1. It is the responsibility of the owner to ensure that all users of the adjustable dumbbells are adequately informed of all precautions.
2. Before beginning any exercise program, consult your physician. This is especially important for people over the age 35 and/or with pre-existing health problems.
3. Overexercising may result in serious injury or death. If you feel faint, become short of breath, or if you feel pain while exercising, stop immediately. Contact your physician before using the product again.
4. The adjustable dumbbells are intended for indoor, home use only. Prolonged exposure to sunlight and external conditions may cause damage to the unit. **DO NOT** use the adjustable dumbbells in a commercial, rental, or institutional setting.

16. Always wear protective footwear while using the adjustable dumbbells. Never place your fingers between the adjustable dumbbells and the base.
17. Keep body, clothing, and hair clear from all moving parts.

General Considerations

Avoid working out with - or setting down - the base and adjustable dumbbells on uneven areas with clutter.

Avoid liquids near the base and adjustable dumbbells. The product is not waterproof.

Avoid using or storing the product in very hot or cold environments.

DO NOT allow debris to collect in the base or dumbbell mechanisms.

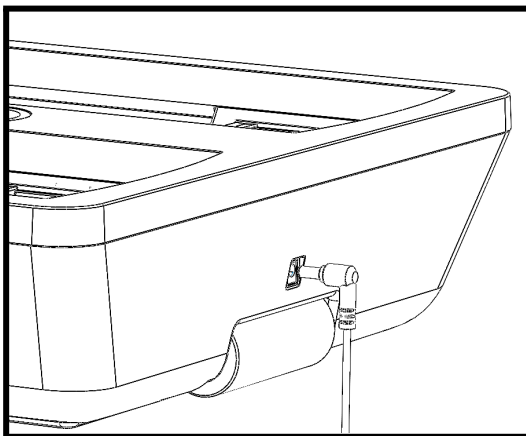


Setup

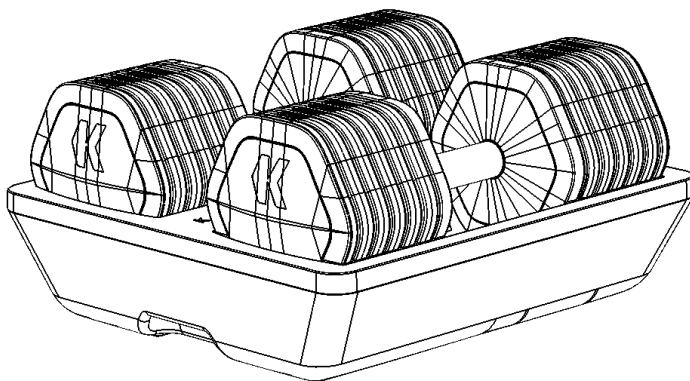
1. Place the base on the floor near an outlet.



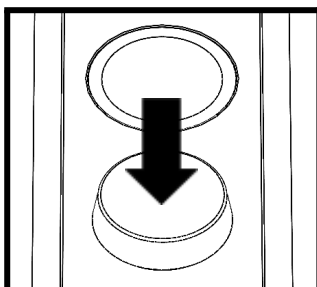
2. Plug the charging adapter into an outlet and then plug into the back of the base. Only use the charging adapter supplied with the product.



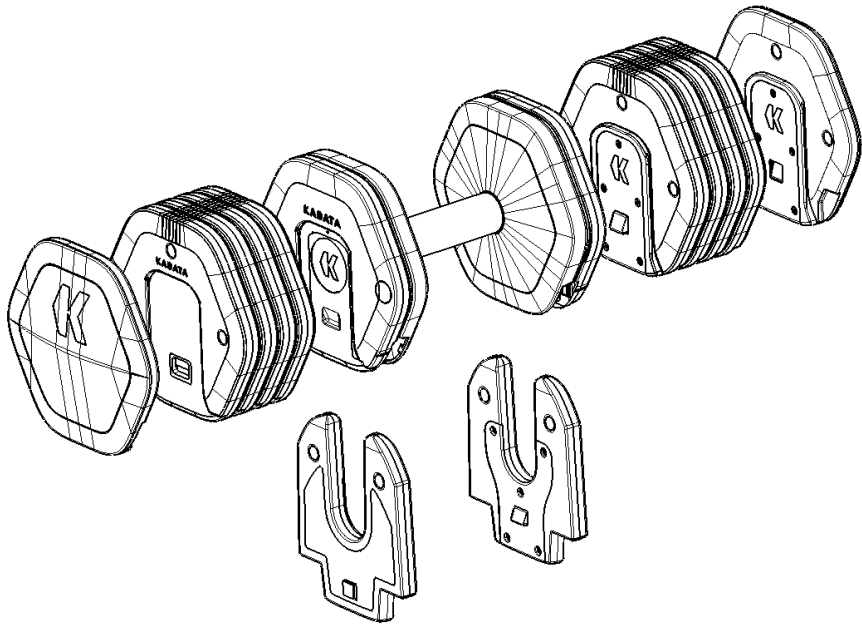
3. Place both adjustable dumbbells into the base as shown.



4. Press the dial to turn on the base.



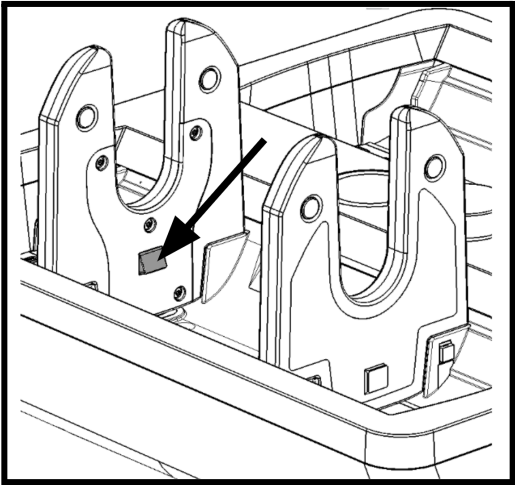
Aligning Weight Plates



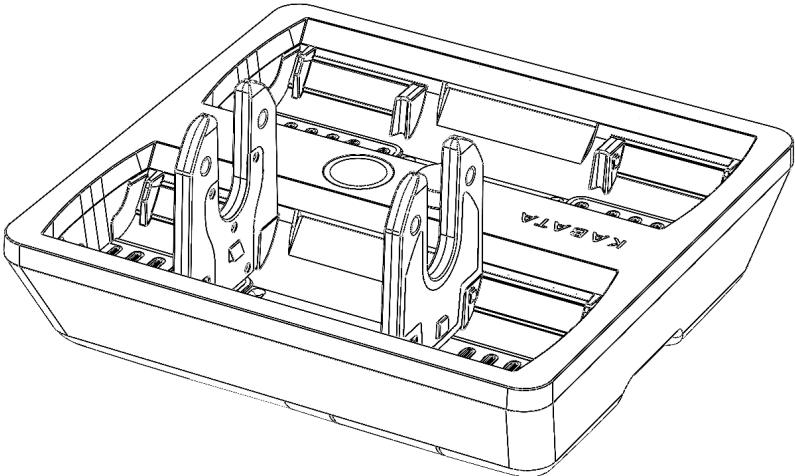
Dumbbells arrive properly assembled. However, if you ever need to reassemble the dumbbells, the weight plates should be placed in the correct order for proper functionality.

Weight plates are designed to be slid onto one another vertically from the outside in. When the weights are placed in the base, the locking mechanism should always be facing inwards towards the center.

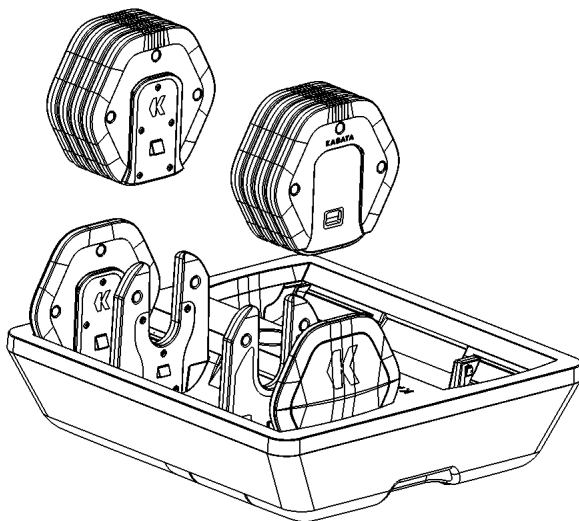
Half weights should be facing inward toward the center. This is noted by the latch, highlighted below, pointing towards the middle of the stand.



Be careful not to place the half weight in the opposite orientation. The handle will not be able to be inserted if the half weights are placed incorrectly.

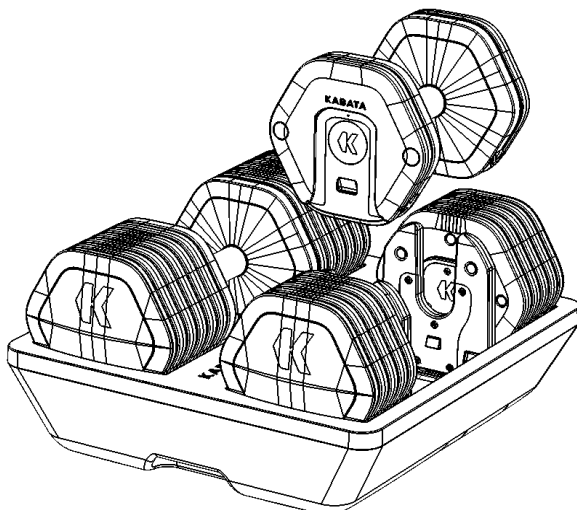


If placing weights individually, then End Weights should be placed first at either end.



Follow up with placing the Full Weights by sliding them downward vertically onto the End Weights. End Weights should now be locked to Full Weight(s).

It is recommended to place Full Weights individually one by one, moving inward and making sure they each attach to the adjacent weight.



Finally, place the handles downward to complete the adjustable dumbbells.

Usage

Navigating the Menu

Press the dial to enter the menu.

Rotate the dial clockwise and counterclockwise to cycle through the options in the menu.

Press the dial to make a selection.

Menu Options

Manual Weight Selection

To adjust weight enter Weight Selection mode:

1. Manually rotate the dial **clockwise** to **increase** the weight.
2. Rotate the dial **counterclockwise** to **decrease** the weight.
3. When weight change is complete, as indicated by the base, lift the handle straight up out of the base.

Lightning Mode

Lightning mode is an automatic adjustment mode that will decrease or increase the weight by a preset interval. This allows for hands-free weight changing for quick sets. Drop sets for burn out are an effective use case in this mode.

For Lightning Mode:

1. Press the dial to enter the menu and rotate into Lightning Mode.
2. Press the dial to enter Lightning Mode and follow the instructions on the screen to select the starting weight and interval.
3. After completing a set, place the weights onto the base. The base will automatically change the weight based on the set interval.

Be sure to wait for the base to finish weight changing before picking up the adjustable dumbbells.

Settings

Light Color

Select a base color for lights.

Light Brightness

Select the brightness of the lights or turn lights off.

Battery

View battery levels for the base and each dumbbell.

Units

Select units in either LB or KG for your weights.

Information

Get basic product software information.

Power

Select to turn off your Kabata base and adjustable dumbbells.

Maintenance

Care

Use a dry cloth to wipe the product down.

Alternatively, you can use mild soap and a damp cloth to wipe down the adjustable dumbbells and base. Wipe dry with a separate cloth.

Troubleshooting

Caution

Make sure you are using official Kabata accessories.

Perform all troubleshooting steps near the floor to prevent potential injury.

Keep your body away from the direct path of the weights.

Base Troubleshooting

Weight Changing Issues

Obstructions

Carefully remove the adjustable dumbbells and weights from the base.

Inspect the base (and underside of the adjustable dumbbells) for any debris or small objects that can be interfering with the system. Remove any foreign objects and clean the surfaces.

Battery

Low or weak battery can cause motors to slow or stall. To charge the base, plug the charging power adapter to a wall outlet and the corresponding connector to the back of the base.

Allow the base to charge 30 minutes prior to use.

How to Restart

If something isn't working right, try restarting your Kabata and its paired mobile device.

To manually restart the base:

1. Navigate to **Power** and turn off your device.
2. Wait 10 seconds and then press the dial to turn on the base.

Force Restart

If you can't turn off your Kabata or if the problem continues, you may need to force your device to restart. Do this only if you're unable to restart your device normally.

To force restart, hold down the dial button for at least ten seconds until the Kabata logo appears.

Base will automatically restart afterwards.

Adjustable Dumbbell Troubleshooting

Battery

If you are having trouble with the adjustable dumbbells connecting to the base or mobile application, then the battery could be low or discharged.

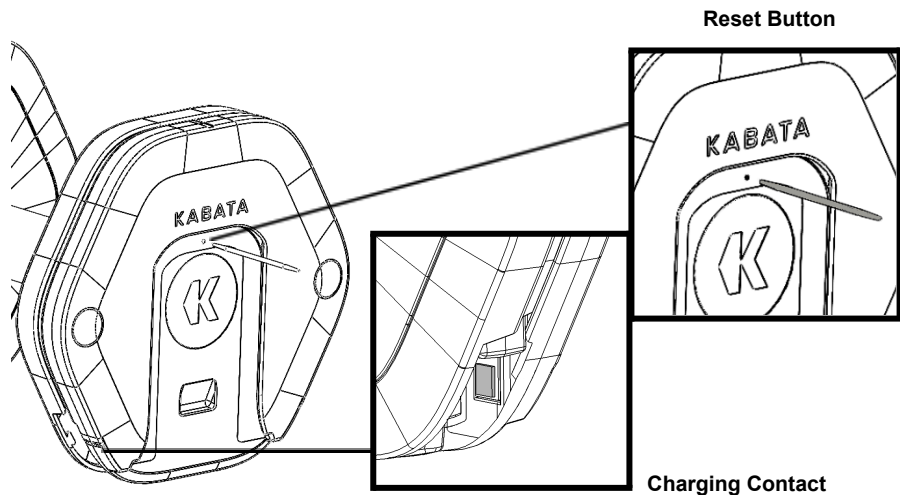
To check battery level of the dumbbells:

1. Place adjustable dumbbells onto the base.
2. Navigate to the **Settings** menu and select **Battery**.

If the battery is low, place the adjustable dumbbells onto the base. Make sure the base is plugged into power and allow the dumbbells to charge for 30 minutes.

How to Restart

1. Place the adjustable dumbbells onto the base and switch to the lowest weight setting (5 lbs).
2. Remove the adjustable dumbbell handle and locate the correct side by identifying the charging contacts on the underside of the dumbbell. You should see two rectangular gold contacts indicating this side contains the reset button.
3. Get a thin tool, like a paperclip or toothpick, and insert it into the small opening on the outside right above the logo.
4. Using the thin tool, press the reset button. You should feel a click when the button is pressed.
5. Place the adjustable dumbbell back onto the base and wait 15 seconds for the dumbbell to restart.

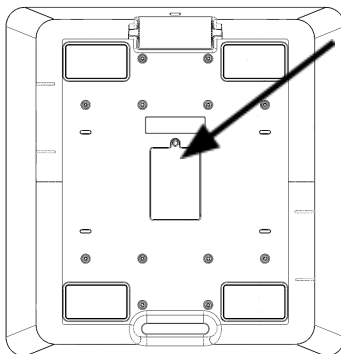

Battery Replacement

Base battery replacement

1. Unplug and turn off the base.
2. Remove the adjustable dumbbells and weights from the base.
3. Turn over and prop the base in order to access the underside without the dial being pressed.
 - 3.1. If the dial is pressed, then the base will power on. Battery replacement should be performed with the base powered off.
4. Use a Phillips screwdriver to remove the battery door screw.
5. Replace the battery by unplugging the connector and swapping the battery with an official Kabata certified battery.
6. Place the battery door while avoiding squeezing the wires and screw the battery door shut.

Return Policy

If you are not satisfied with your Kabata Adjustable Dumbbells for any reason, you can contact Kabata by email at support@kabatafitness.com, within 30 days of delivery.

Returned product(s) must be in good physical condition (not broken or damaged). All product components originally included with your purchase must be included with your return. Returns found to be broken, damaged, and/or missing any part(s) may be subject to additional fees. Shipping and handling charges, gift wrap fees, and taxes paid (such as state, customs, or VAT) are non-refundable. You are responsible for all shipping charges and you assume the risk of loss or damage of the returned product while in transit.

Kabata Limited Product Warranty (USA)

Kabata, Inc. ("**Company**," "**we**," "**us**," or "**our**") warrants to the original purchaser only that any product identified below as a "**Covered Product**" that you purchased from Company, or one of our authorized distributors or resellers (each, an "**Authorized Reseller**"), will be free from defects in materials and workmanship under normal use for a period of twelve (12) months from the date of delivery to the original purchaser ("**Warranty Period**"), as documented by valid proof of purchase. This limited product warranty ("**Limited Product Warranty**") is subject to certain exclusions and limitations, as set forth herein.

Company's sole obligations under this Limited Product Warranty are as specified in the "**What are my remedies under this Limited Product Warranty?**" section below.

1. What is covered by this Limited Product Warranty?

“Covered Products” are any Kabata Adjustable Dumbbells and are sold by us at **kabatafitness.com** or by one of our Authorized Resellers.

This Limited Warranty applies only against defects in Covered Products that are discovered within the applicable Warranty Period and only so long as the Covered Product remains in the possession of the original purchaser, or, for a gifted Covered Product, the original possessor of that Covered Product.

This Limited Product Warranty is valid only in the jurisdictions where the Covered Product is sold by Company itself or by an Authorized Reseller.

2. How long am I covered by this Limited Product Warranty?

The Warranty Period for each Covered Product is twelve (12) months from the date of delivery to the original purchaser, as documented by a valid proof of purchase—e.g., receipt or invoice.

3. What are my remedies under this Limited Product Warranty?

If a defect in the Covered Product arises and a valid claim is received by Company within the Warranty Period, Company will, at its option and to the extent permitted by law, either (a) repair the defective Covered Product at no charge, using new or refurbished replacement parts, or (b) exchange the defective Covered Product with a new or refurbished Covered Product or a product that is reasonably equivalent to the Covered Product. If Company, in its sole discretion, determines it is not reasonable to replace the defective Covered Product, Company may refund to you the purchase price paid for the Covered Product. In the event of a defect, to the extent permitted by law, these are your sole and exclusive remedies. You may be responsible for payment of shipping and handling charges for the delivery of a repaired or replacement Covered Product, except where prohibited by applicable law. Any replacement of a defective Covered Product or parts under this Limited Product Warranty will be warranted for the remainder of the original Warranty Period of the returned Covered Product or for thirty (30) days, whichever is longer, or for any additional period of time that may be applicable in your jurisdiction.

4. How do I make a claim or obtain warranty service under this Limited Product Warranty?

A. If you believe you need warranty service under this Limited Product Warranty, please contact support@kabatafitness.com. To obtain warranty service, you need to obtain a Return Merchandise Authorization (RMA). In your request to support@kabatafitness.com, you must include proof of purchase for the Covered Product, a brief explanation for why you are requesting warranty service, and a description of the steps you have taken to troubleshoot the problem.

B. Once you receive an RMA, you will need to deliver the defective Covered Product, in either its original packaging or packaging providing an equal degree of protection, together with proof of purchase indicating the date purchased, to the address specified by the Company. By sending the Covered Product, you hereby acknowledge that ownership of the Covered Product is transferred to us upon Company's receipt of the defective Covered Product. If Company determines that the claim is justified based on this Limited Product Warranty, Company shall bear the cost of shipping the repaired or replacement Covered Product to you. Any Covered

Product returned to Company without a valid warranty claim or without an RMA may be rejected, returned at your cost (subject to prepayment), or disposed of in Company's sole discretion with no further liability or obligation to you.

Furthermore, this Limited Product Warranty does not apply to any defects or parts requiring replacement due to ordinary wear and tear, corrosion, rust or stains, or cosmetic damage, including scratches or dents, on or to the Covered Product or any damage to the Covered Product caused by any of the following:

- Operating the Covered Product outside the permitted or intended uses described by COMPANY or use of the Covered Product not in compliance with COMPANY's instructions, user manual or technical documentation. This includes non-residential usage of the product.
