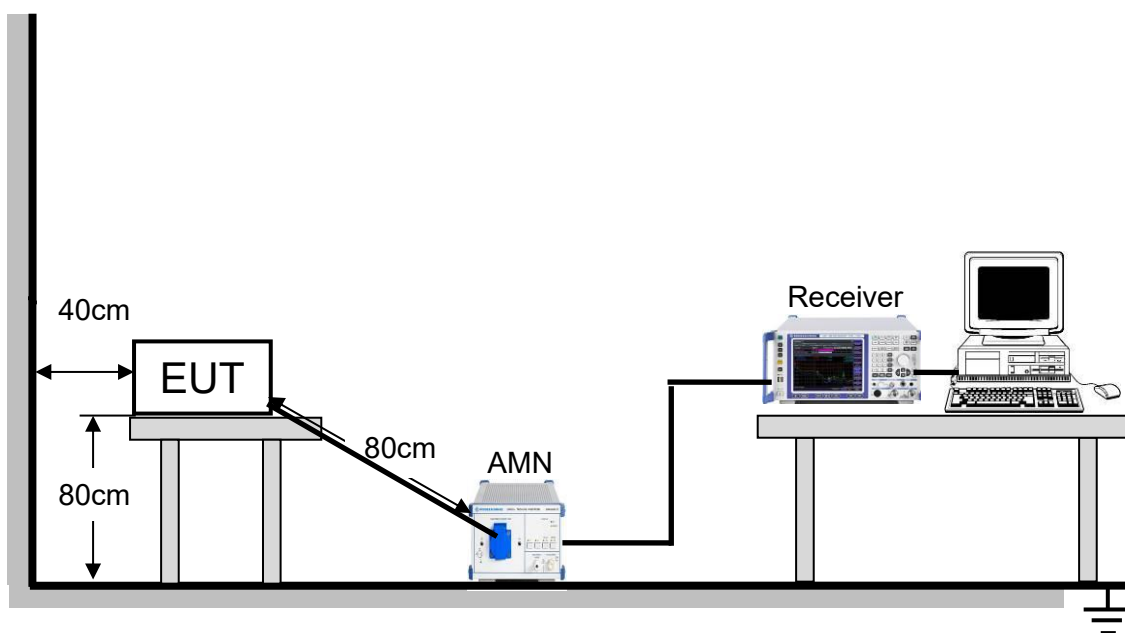

##### 3.1.2 TEST PROCEDURE

- a. The EUT was placed 0.4 meters from the conducting wall of the shielded room with EUT being connected to the power mains through a line impedance stabilization network (LISN). Other support units were connected to the power mains through another LISN. The two LISNs provide 50 Ohm/ 50uH of coupling impedance for the measuring instrument.
- b. Interconnecting cables that hang closer than 40 cm to the ground plane shall be folded back and forth in the center forming a bundle 30 to 40 cm long.
- c. I/O cables that are not connected to a peripheral shall be bundled in the center. The end of the cable may be terminated, if required, using the correct terminating impedance. The overall length shall not exceed 1 m.
- d. LISN at least 80 cm from nearest part of EUT chassis.

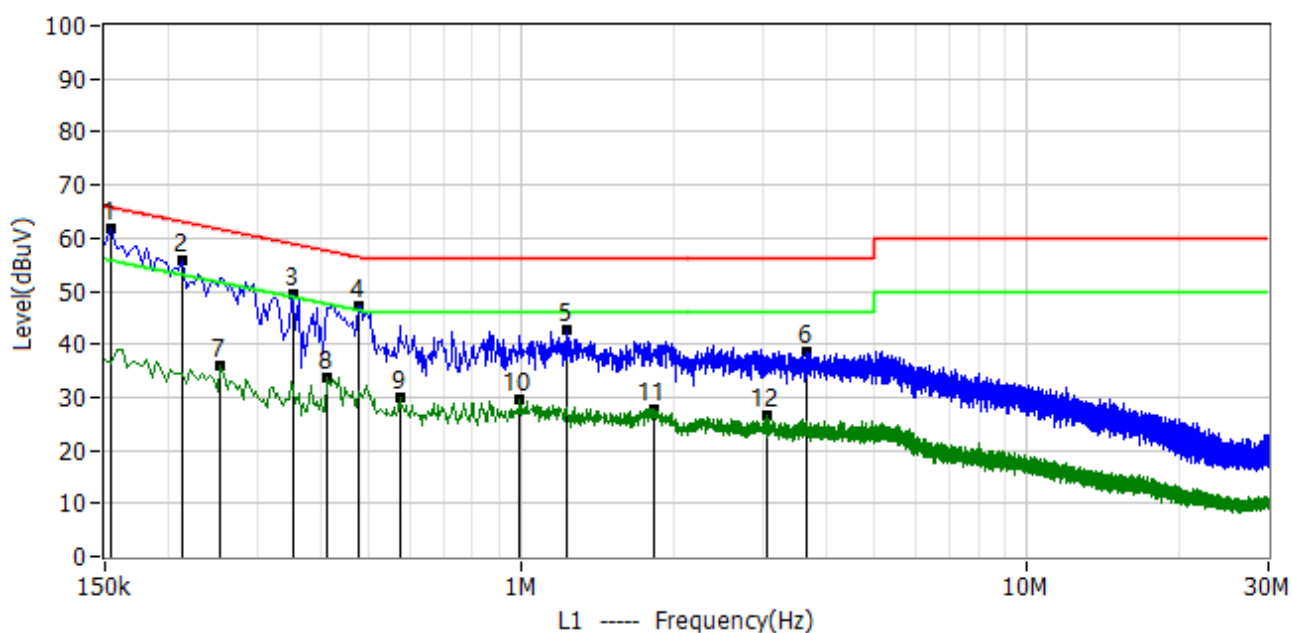

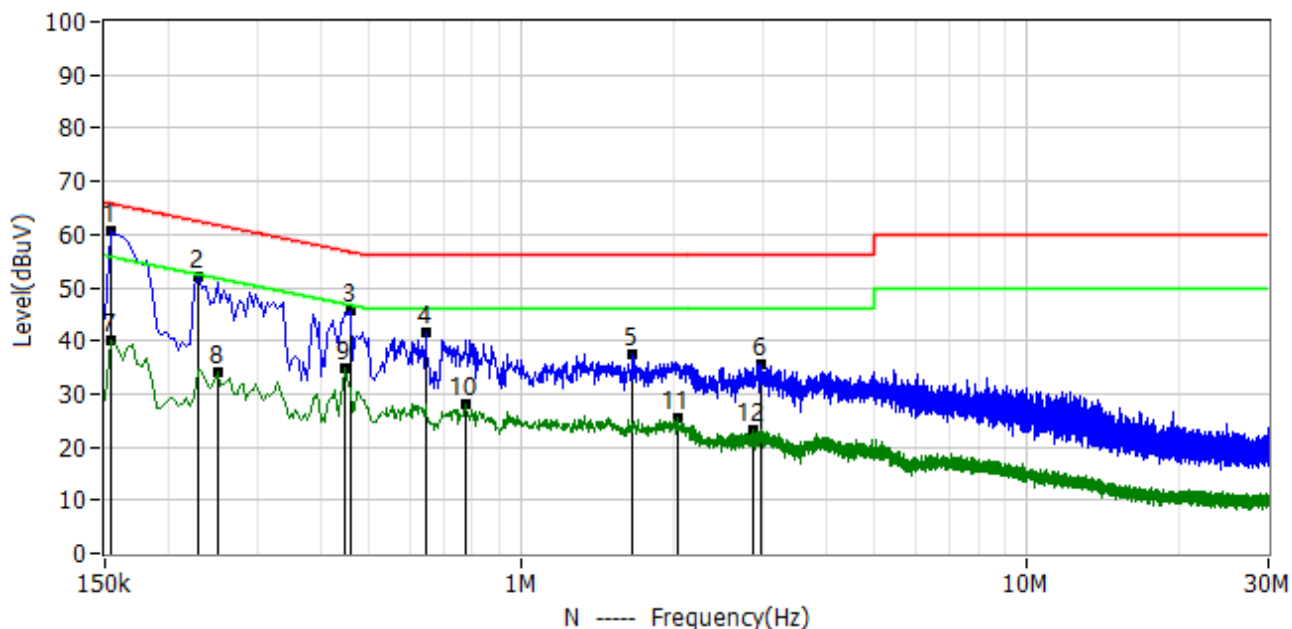

### 3.2.2 TEST PROCEDURE

- a. The EUT was placed on the top of a rotating table 0.8 meter above the ground at a 3 meter semi-anechoic chamber room. The table was rotated 360 degrees to determine the position of the highest radiation.
- b. EUT as the center to the edge of the auxiliary device, the distance from the maximum edge to the center of the antenna is 3 meter.
- c. The height of antenna is varied from 1 meter to 4 meter above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
- d. For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meter and the rotatable table was turned from 0 degrees to 360 degree to find the maximum reading.
- e. The test-receiver system was set to quasi-peak detect function and specified bandwidth with maximum hold mode when the test frequency is below 1GHz.
- f. For the actual test configuration, please refer to the related Item –EUT Test Photos.



The diagram illustrates the experimental setup for measuring the radiation pattern of an EUT. The setup is contained within a Semi Anechoic Chamber, which is lined with pyramidal absorbers. The EUT is placed on a Turntable, which can rotate 360°. The distance between the EUT and the Antenna is 3m. The Antenna is mounted on an Antenna Tower, which is 1m ~ 4m high. The Turntable is 0.8m high. The Antenna is connected to a Receiver, which is connected to a Position Controller, which is connected to a Preamplifier. The Receiver, Position Controller, and Preamplifier are housed in a Cabinet. A computer is connected to the Preamplifier.

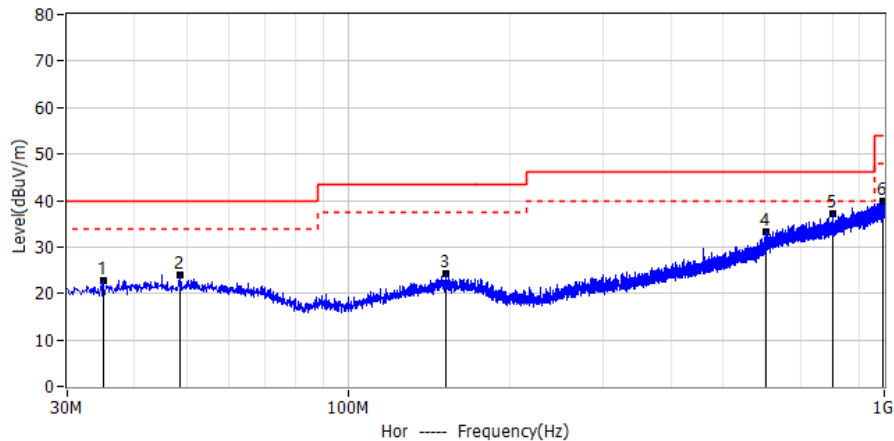
The diagram illustrates a semi-anechoic chamber used for antenna measurements. The chamber is lined with pyramidal absorbers. A test subject (EUT) is placed on a table at a height of 0.8m. 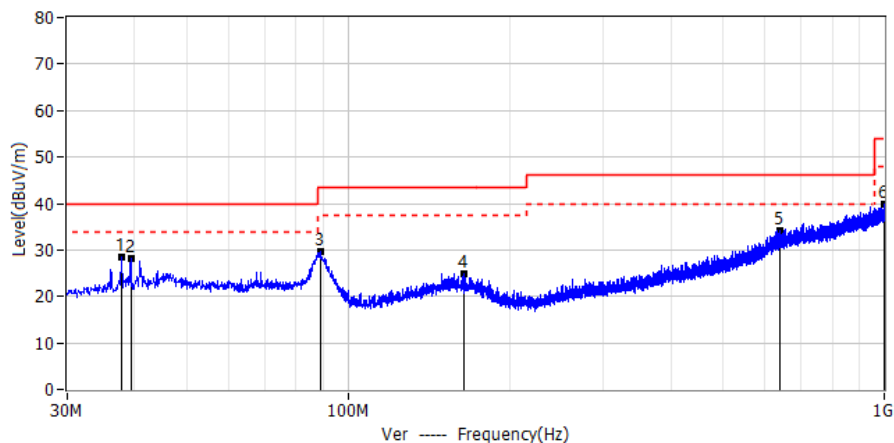

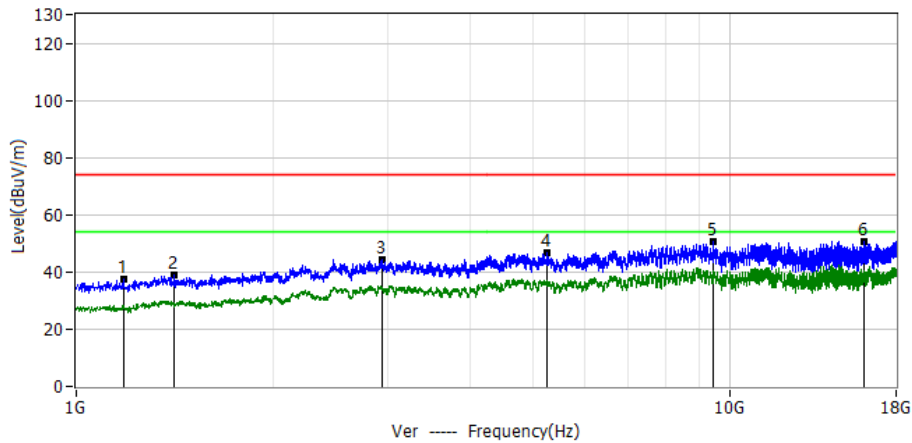

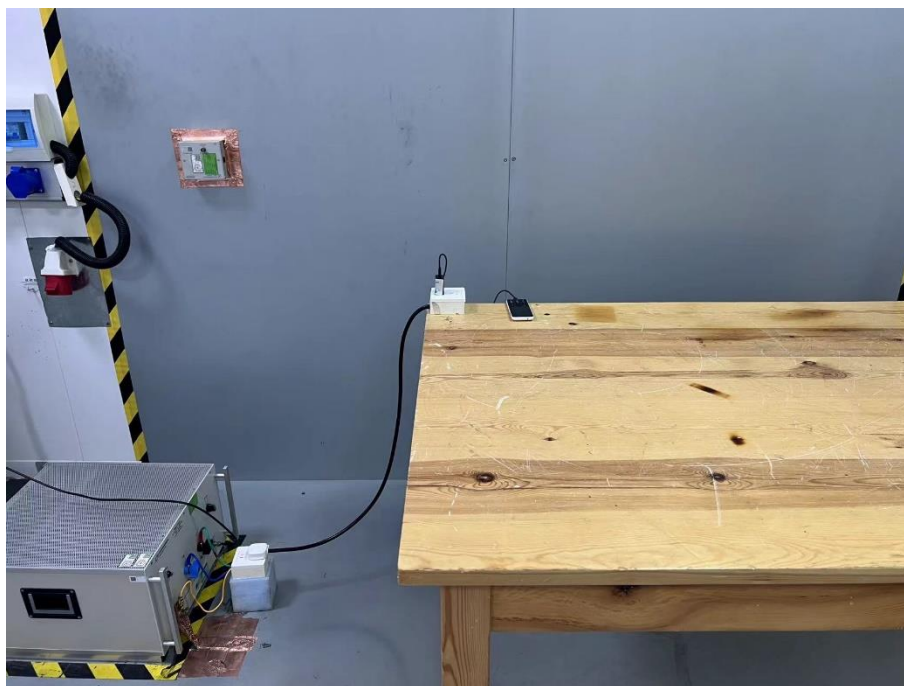

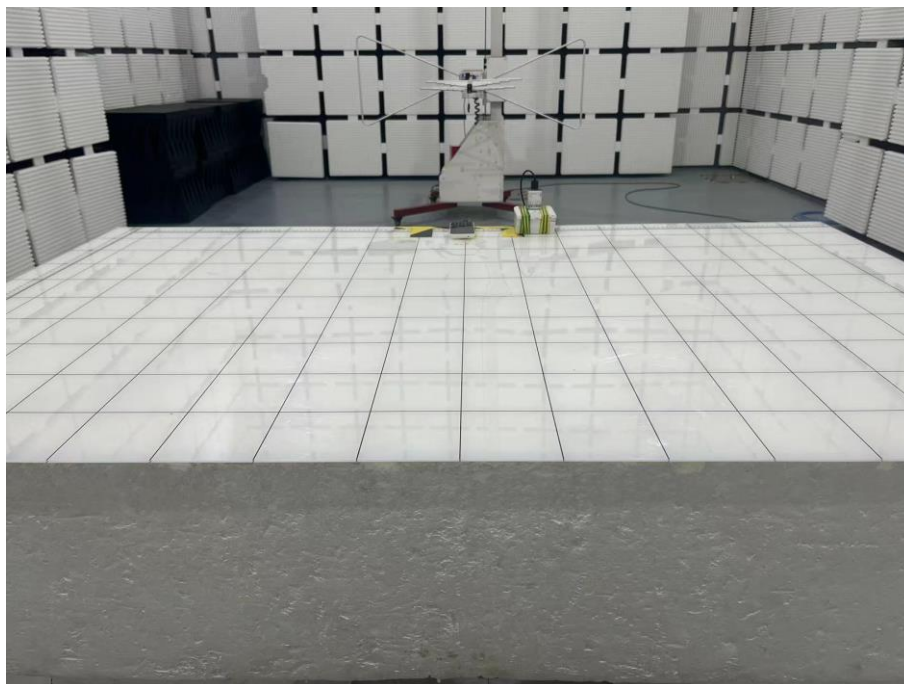
