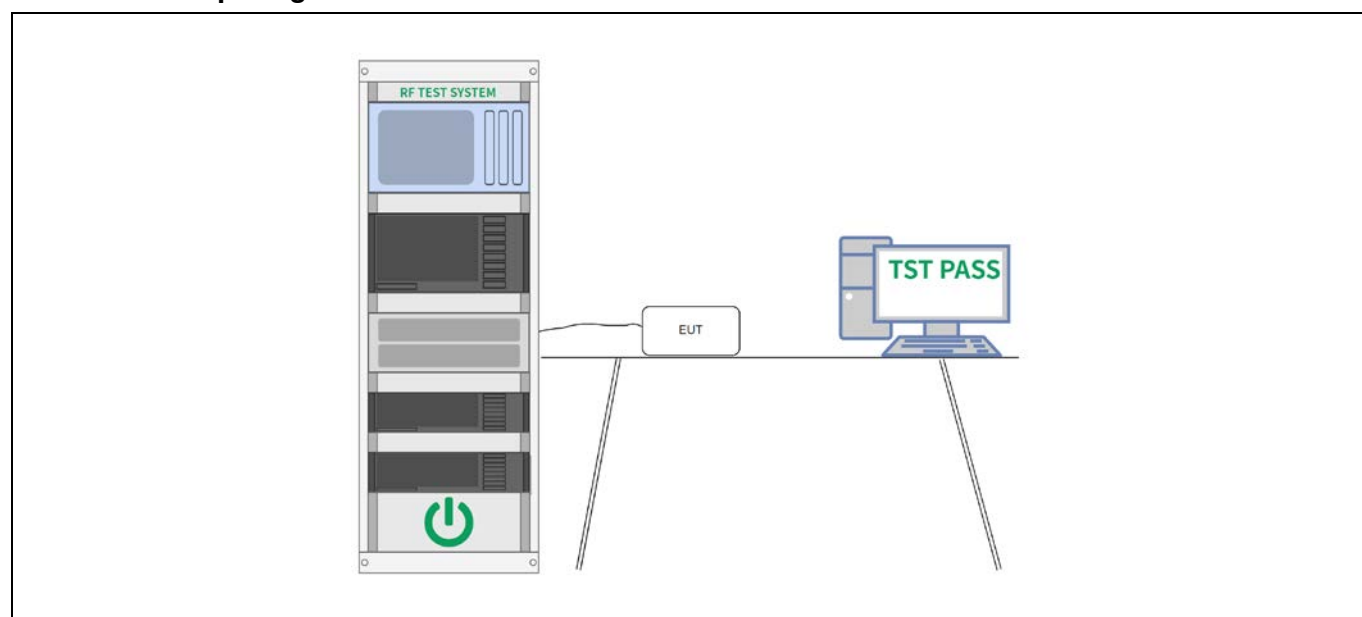
6.2 Maximum Conducted Output Power

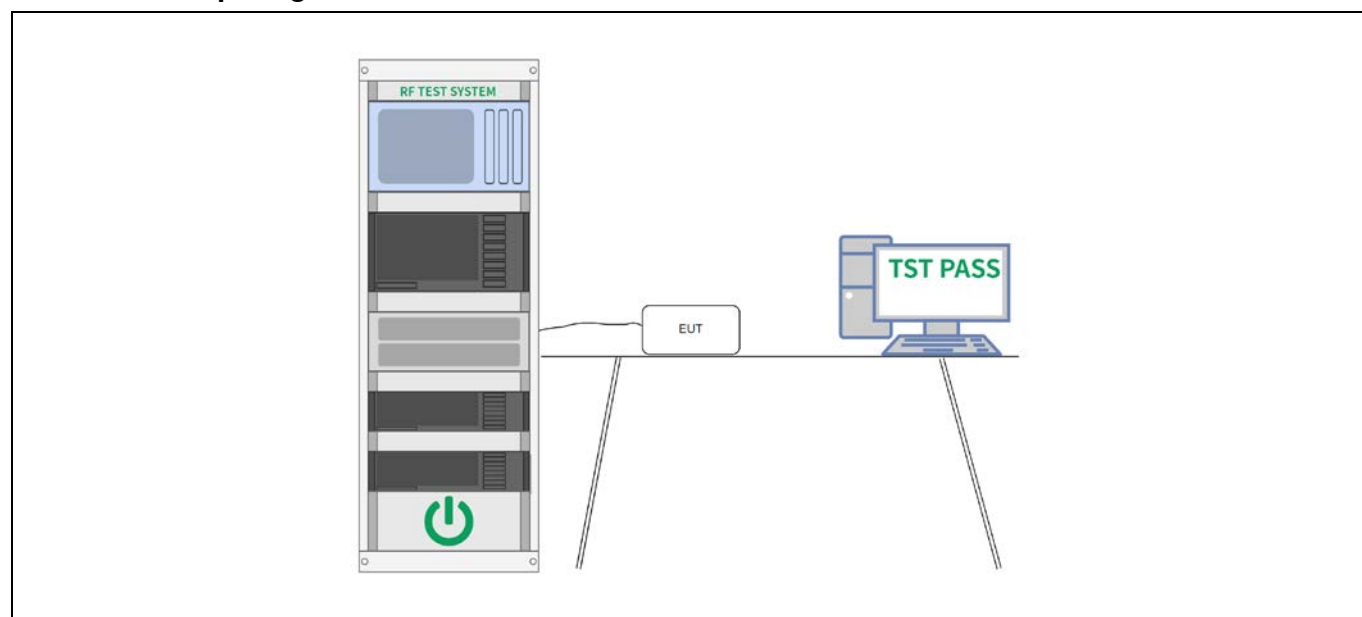

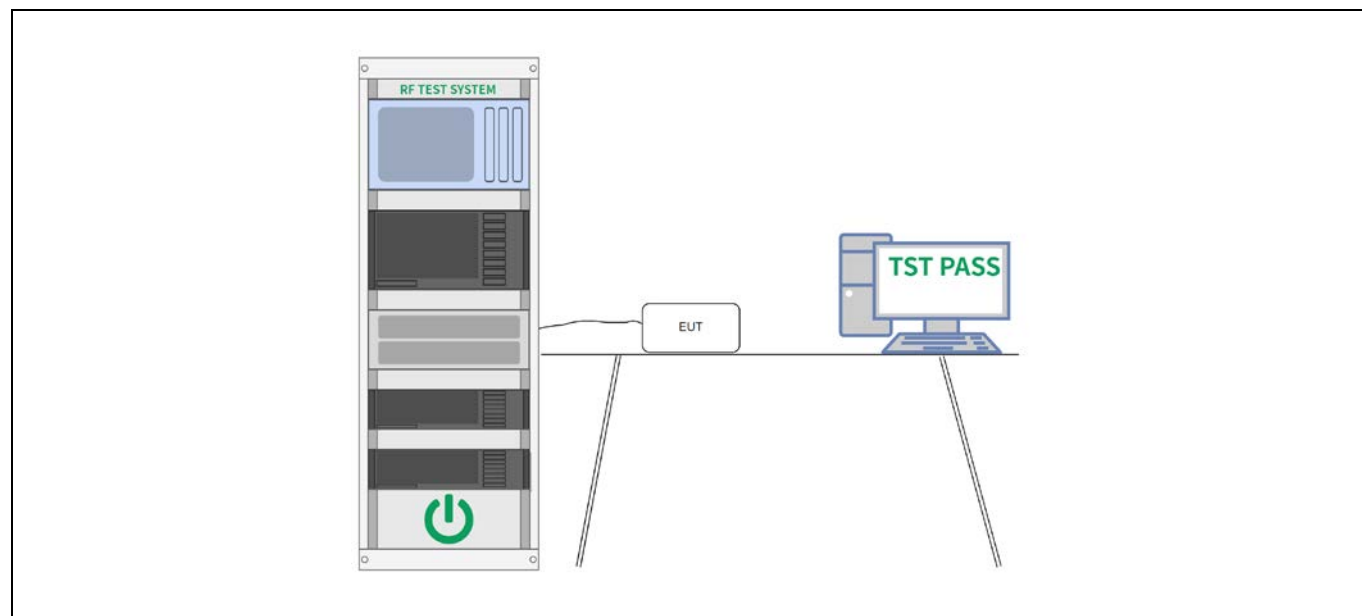
6.4 RF conducted spurious emissions and band edge measurement

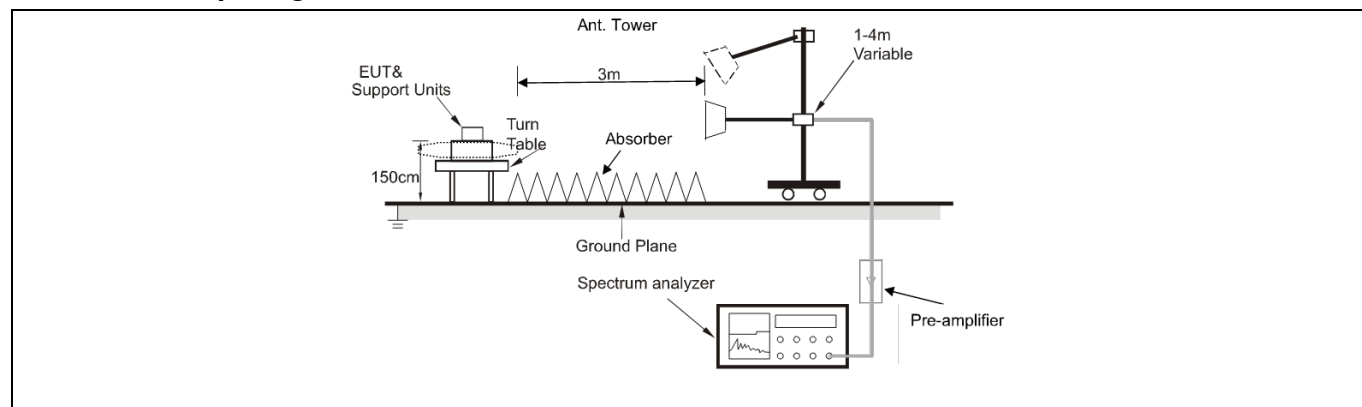

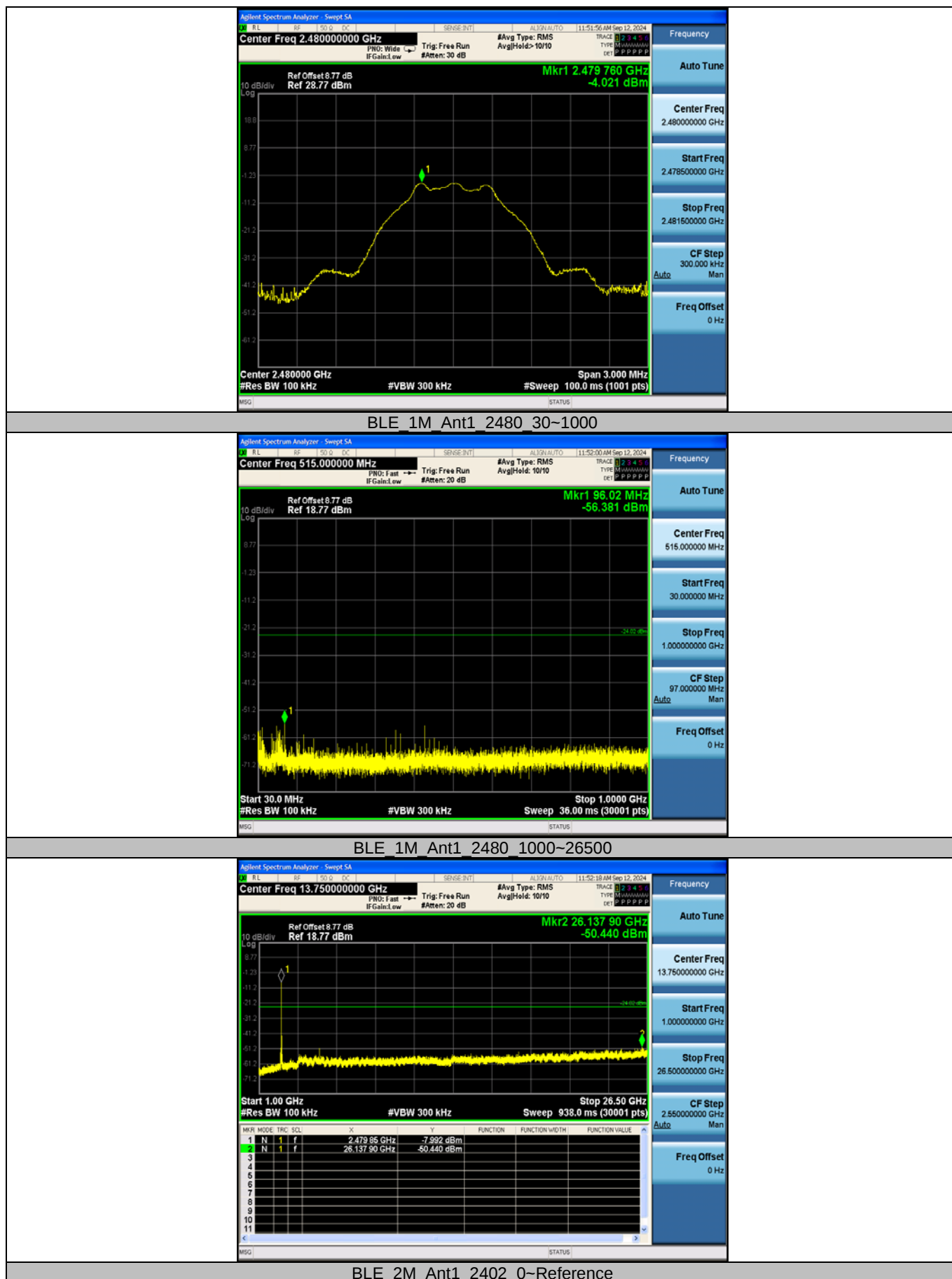
BLE 1M Ant1 2440 30~1000

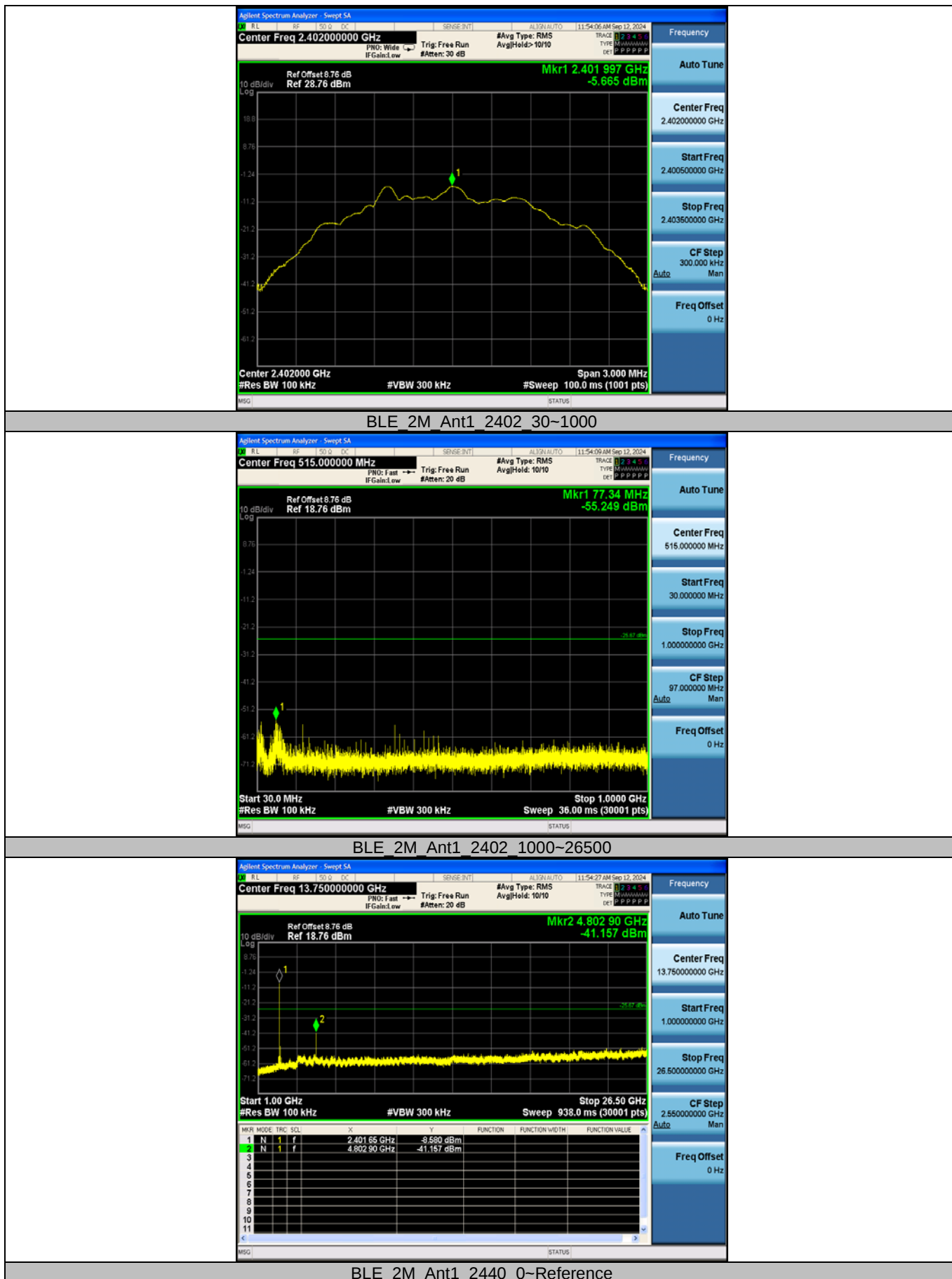


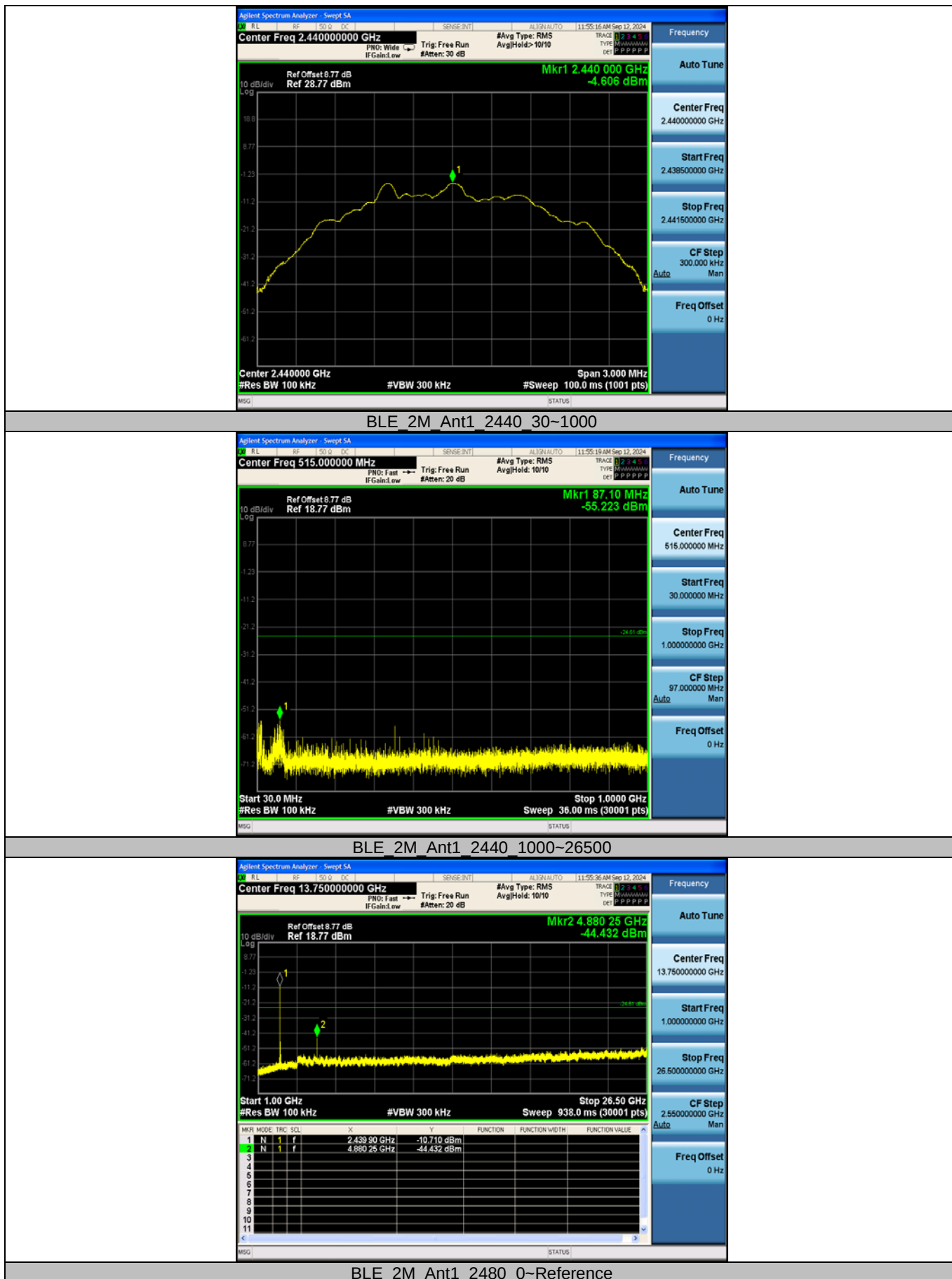
BLE 1M Ant1 2440 1000~26500

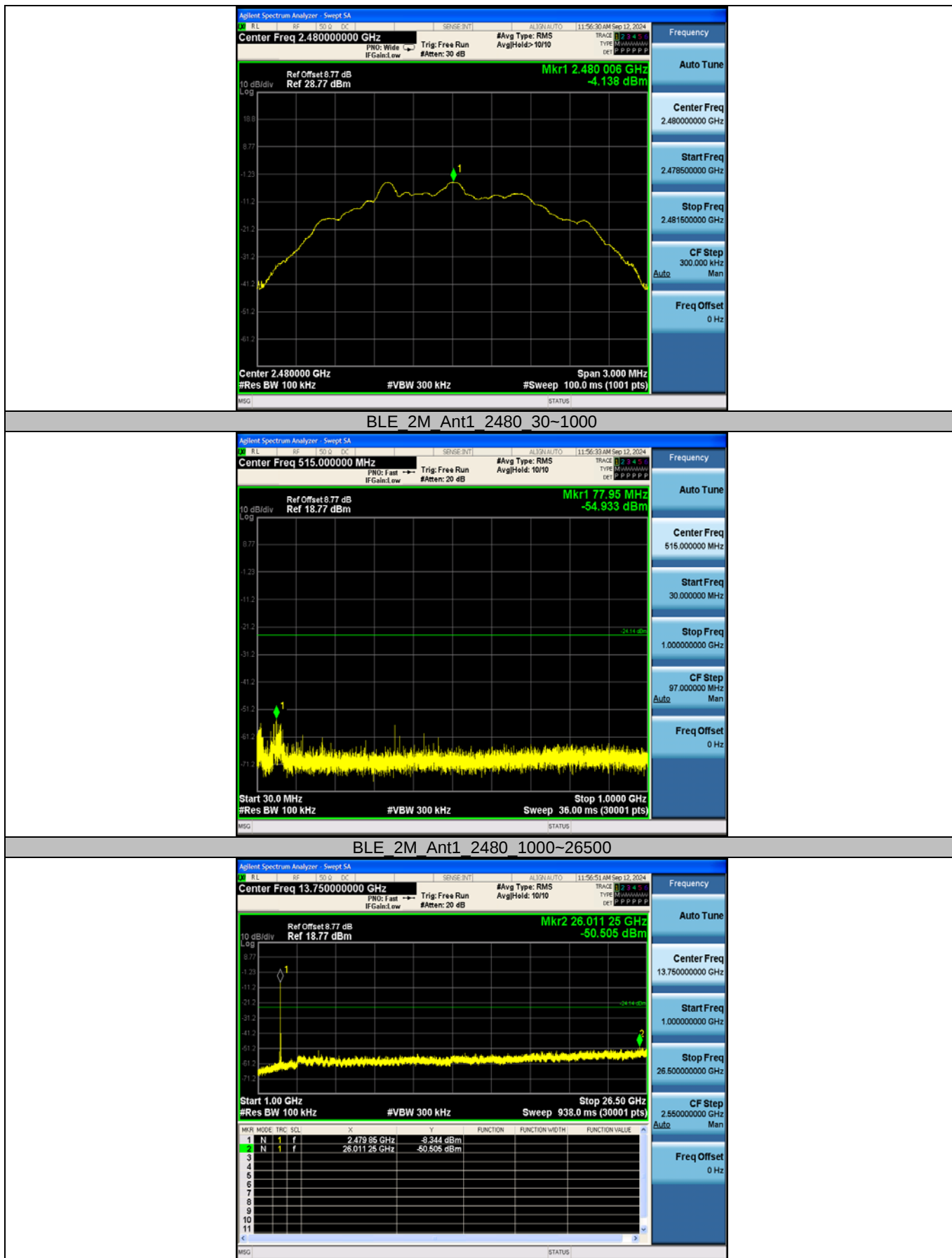

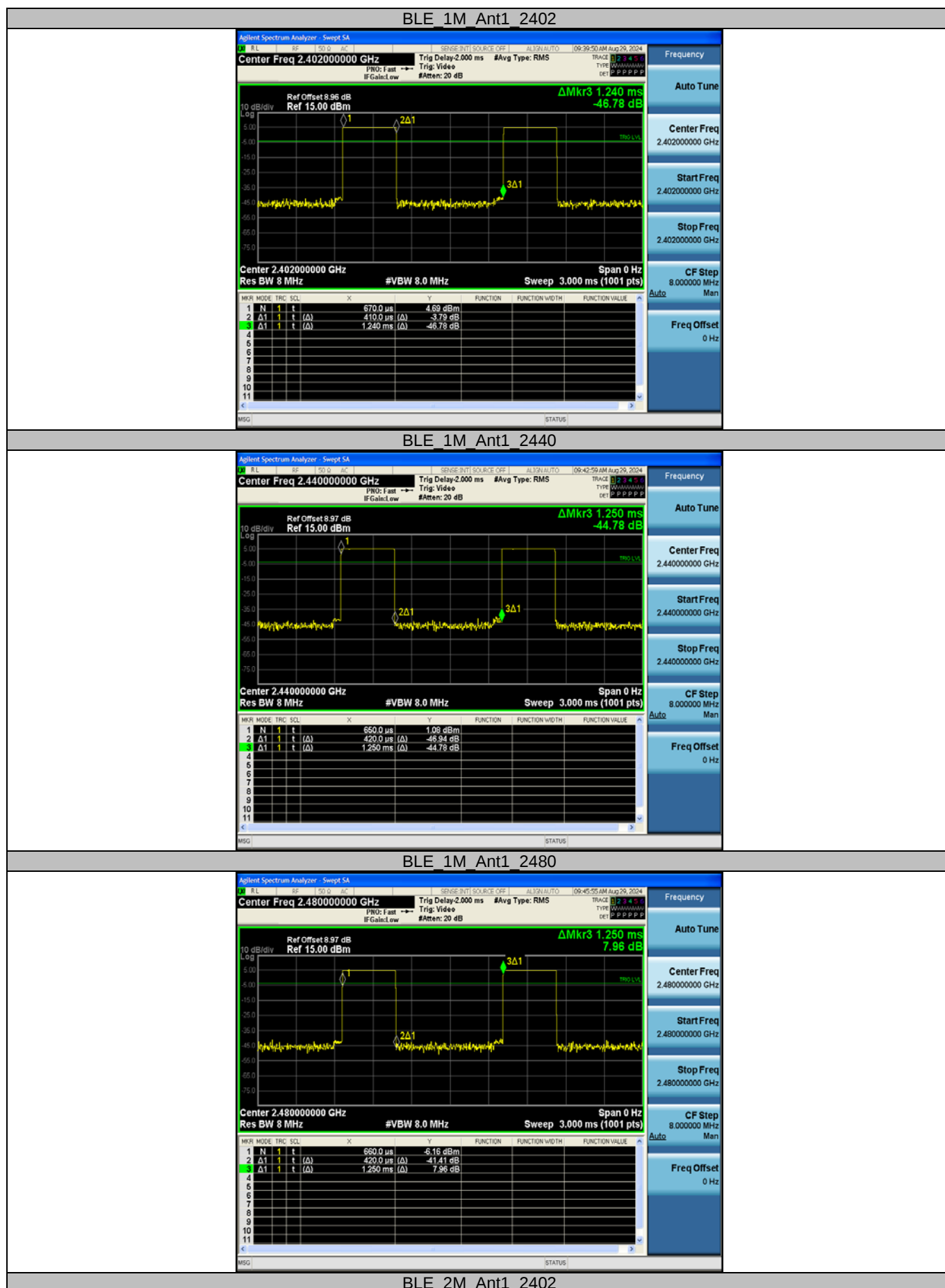


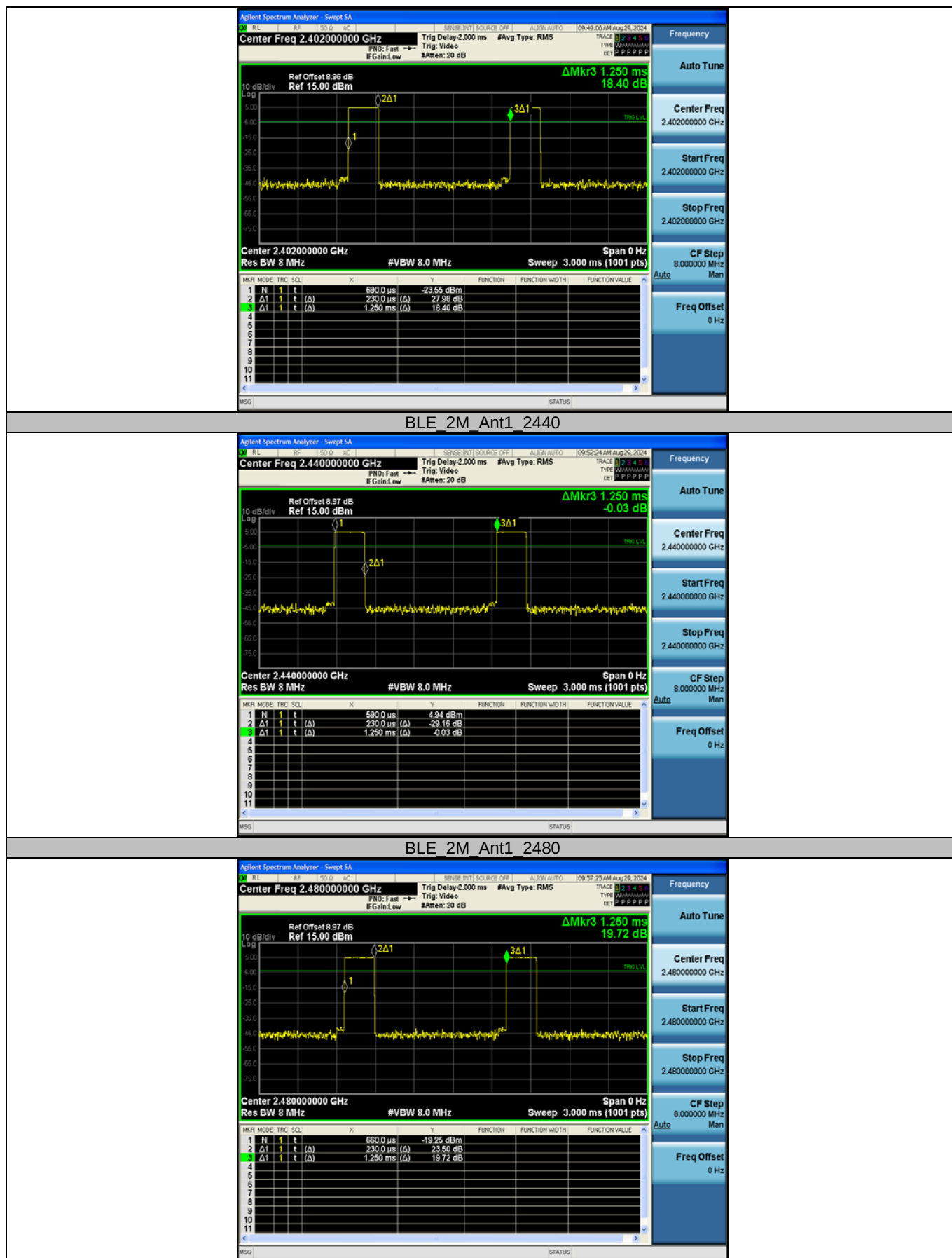
