



## How to use

1. Long press on/off button  to turn on the product. The vibrating and thrusting movement is set off as the product is turned on. Short press  to adjust the speed.
2. When the product is on, it can be controlled by the remote control. Press  on the remote control to change the vibration and thrusting mode. Short press  to change the licking speed. Long press on/off button on the remote control, the product will be in a standby mode.
3. Long press  on the product to turn it off. When the LED light is off, the product is off.

## Installing the Battery on the Remote Control



1. Open the battery lid.
2. Place a battery in the battery bay accordingly.
3. Put the lid back on.

## How to Charge

1. Insert the USB charging cable into the charging port on the product.
2. Connect the USB cable with a USB power outlet. The LED light on the product will be on and keep flashing when charging, and the LED light will stop flashing when the product is fully charged.
3. When the vibration is weak or the product cannot be turned on, please recharge it.

## Cleaning, Storage & Safety

1. The product is for adult use only and cannot be used as a medical device.
2. Do not use the product on wounds or in high temperature environments. If you feel severe discomfort when using the product, please stop immediately and consult your healthcare provider.
3. Please do not use cleansers containing alcohol, petrol or acetone.
4. Please store the product in a dust-free, cool and dry place.
5. Please store the product within the temperature range of 0°C -40°C. Please avoid exposing the product to the direct sunlight or the extreme heat.


