# Fragrance System Introduction

Production Name: Fragrance Module

Your car provides an in car fragrance system for you and your family, allowing you to choose your preferred fragrance and enjoy a fresh and comfortable taste while driving.


We provide you with a variety of fragrances, from which you can choose your preferred fragrance and install it in the fragrance module above the open storage area in the vehicle center console. You can also change the fragrance bottle according to your personal preference.

The installation and replacement methods for fragrance bottles are as follows:

1. Open the cap of the fragrance bottle, insert the thinner end of the fragrance bottle upwards into the inner hole of the fragrance mechanism above the central open storage area, gently press the bottom of the bottle upwards to ensure proper installation.

## ATTENTION

Do not rotate the fragrance bottle during installation.



2. After inserting the fragrance bottle into the hole, it can be attracted in place by the magnet inside the fragrance mechanism.

3. After the fragrance bottle is installed in place, the central control screen will prompt that the fragrance installation is successful and display the fragrance information corresponding to the current hole.

4. When replacing the fragrance bottle, you need to pinch the bottom of the fragrance bottle tightly with your fingers and slowly remove the fragrance bottle from the fragrance mechanism.

After the successful installation of the fragrance, the fragrance type will be identified according to the information of the chip in the fragrance bottle, which can be read by NFC function of the fragrance module. You can enter the air conditioning

settings page on the central control screen, click on fragrance, and on this page, you can see the fragrance type of the installed fragrance bottles. Also, you can control the ON/OFF of the fragrance system, adjust the concentration of the corresponding fragrance, and select fragrances with different installed flavors

## WARNING

- Please store fragrance bottles out of reach of children to prevent them from ingesting and endangering their health.
- Do not allow children to insert their fingers into the fragrance mechanism above the central open storage area to avoid accidents.
- Please do not install or replace fragrance bottles while driving, and pay attention to your driving safety.
- If you experience any physical discomfort while using the fragrance, please stop using it immediately.

## ATTENTION

- Please pay attention to the shelf life of the fragrance before installing the fragrance bottle. The fragrance has a shelf life of 1 year when the packaging is unopened; After unpacking, the fragrance has a shelf life of 3 months. Please use the fragrance within its shelf life and replace it with a fragrance that has expired.
- Some fragrances (such as' wilderness') have a refreshing effect, please use them when necessary.
- When replacing fragrance bottles, please keep your hands clean to ensure the normal operation of the fragrance system.
- There are magnets in the fragrance mechanism. Do not place electronic devices such as mobile phones or tablet PC near the fragrance hole above the open storage area of the central control to avoid affecting the functionality of electronic devices and fragrance modules.
- Spices may undergo chemical reactions with organic matter. Please avoid direct contact between the ceramic fragrance core in the fragrance bottle and plastic parts.

## EXPLANATION

- The fragrance experience may vary depending on the temperature inside the car, air conditioning volume, and individual physiological state.
- Please install ceramic fragrance cores from official channels to avoid damaging the fragrance bottle and ensure the quality of the fragrance.
- After installing the fragrance bottle, if the fragrance is not successfully recognized, please reinstall it.
