

1. Product Introduction

This product is a three-in-one fast wireless charging Station that can support wireless charging of QI standard mobile phones/iWatches and AirPods at the same time. In addition to a foldable and portable design, which is A convenient, practical and indispensable electronic product.

This product adopts a folding design and the product folding method, which is easier to store and carry; the state of opening the charging panel can be multiple devices at the same time. Place the equipment in the charging area to wireless charging your device. You can put your mobile phone vertically or horizontally, not affecting the charging of the phone. You can video chat or watch your favorite film and television while charging.

3. Operation steps

1. When charging other devices, please power this product through the equipped charging cable first. After plugging in the power, the power light will display normally.

2. When charging a mobile phone, i Watch or Bluetooth headset, first place the mobile phone, i Watch and Bluetooth headset flat on the charging area. After 3 seconds, start charging the device. When fully charged, you can directly remove the device; charging. During the process, if the device needs to terminate charging, just take the device off.

3. The product is open, when the mobile phone is charged, it can be charged horizontally and vertically.

4. Precautions

1. It is forbidden to immerse the product into the water to avoid short circuit in the internal circuit!
2. It is forbidden to disassemble or beat products by yourself, so as not to cause product damage!
3. Please place the product away from flammable and explosive liquid, gas or explosive products!
4. Please do not place magnetic cards, magnetic strips and precision machinery too close to this product!
5. Charging warning: When the display light flashes continuously during the charging process, it means the charging warning. At this time, check whether there are metal foreign bodies in the wireless charging area. After excluding foreign bodies, you can usually charge it normally!
