

* Key Function

-  Long press to Power ON/Power OFF; In BT mode, short press to dial/hang up phone, Double press to redial the last phone number.
-  Short press to switch mode;
-  Short press to NEXT, Long press to increase volume;
-  Short press to PREVIOUS, Long press to decrease volume;
-  In MP3/FM/BT mode, Short press to PLAY/PAUSE, In FM mode, Long press to auto band;
