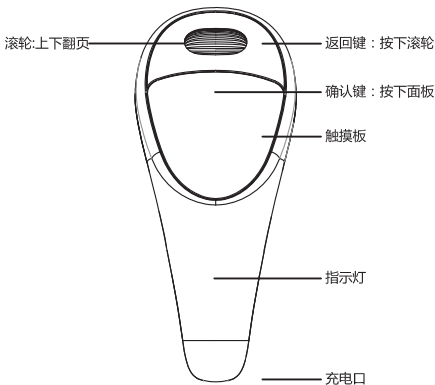

产品说明

智能手机鼠标是一款连接智能手机的掌中鼠标,它可以缓解长时间手腕宽大及厚重的手机所带来的困乏、痉挛等效果

操作说明

- 1.选择手机系统对应匹配的系统鼠标,有鸿蒙系统/IOS系统和安卓系统/IOS系统,支持IOS13以上版本
- 2.连接蓝牙:同时按下确认键和返回键5秒,待绿色指示灯快闪时连接
- 3.滚轮:
功能一:滚轮前后为上下翻页功能。
功能二:滚轮按下为返回键
- 4.触摸板
功能一:鼠标指针方向
功能二:按下触摸板为确认键
触摸板辅助功能,长按两秒钟,设备开机,指示灯亮起
- 5.三十秒无操作,设备自动休眠
- 6.轻触任意键唤醒设备
- 7.设备一分钟无操作,自动关机

充电方式:
建议使用配线对鼠标进行充电,充电时滚轮处常亮红灯充满后亮绿灯,大约1小时左右

鼠标通常问题解决方法

- 1.蓝牙连接不上:
请检查手机是否有打开蓝牙功能,手机没有打开到接收器任务栏的图标是灰色的,打开蓝牙是蓝色的。
- 2.部分APP某些鼠标功能缺陷:
因每个APP定义不同,本产品只适用于大多数APP,比如抖音、百度、网易。像快手,住小邦等APP部分功能会缺陷
- 3.苹果手机反应慢或者很灵敏问题
因IOS系统需要匹配鼠标反应速度,需要在设置-辅助功能-辅助触控-跟踪灵敏度,调节小乌龟的速度,每个用户根据自己的习惯调节,往右是灵敏,往左是不灵敏



售后问题

一、购买产品,出现质量问题

- 1.前往购买产品的经销商处、要求全额退款(7天内)
- 2.前往购买产品的经销商处更换同型号产品(15天内)
- 3.前往授权的服务中心进行维修或更换(15天内)

二购买产品超过15天但仍在保质期内产品出现质量问题

- 1.前往授权的服务中心进行维修或更换。处理流程为:在工作人员的指导下填写用户信息注册单,等待我们的工程师为您检测、维修或更换产品

- 2.如果本地没有授权的服务中心,用户需自行邮寄产品至邻近的服务中心,邮寄费用自理,我们的工作人员在收到您邮寄的产品后会尽快和您联系,并检测、维修或更换产品,返程邮费由公司承担。

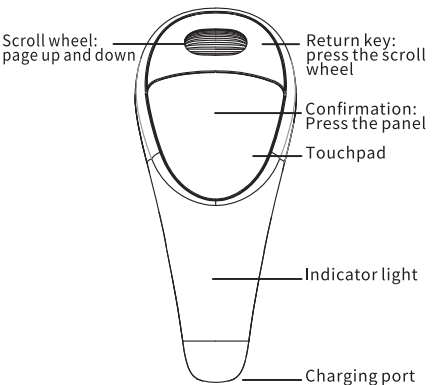

Product Description

The smartphone mouse is a palm mouse connected to a smartphone. It can relieve the effects of sleepiness and spasm caused by holding a wide and heavy mobile phone for a long time.

Instructions

1. Select the matching system mouse corresponding to the mobile phone system, there are Hongmeng system / IOS system and Android system / IOS system, support IOS13 and above
2. Connect to Bluetooth: Press and hold the confirm button and the return button for 5 seconds, and connect when the green indicator flashes quickly
3. Roller
Function 1: The front and back of the scroll wheel is the function of page up and down.
Function 2: Press the wheel to return the key
4. Touchpad
Function 1: Mouse pointer direction
Function 2: Press the touchpad as the confirmation key
Touchpad auxiliary function, press and hold for two seconds, the device is turned on, and the indicator light is on
5. Thirty seconds of inactivity, the device will automatically sleep
6. Touch any key to wake the device
7. The device will automatically shut down if there is no operation for one minute

Battery usage warning!



Charging method:
It is recommended to use the wiring to charge the mouse. When charging, the red light at the wheel will always light up and then the green light will turn on after it is fully charged, about 1 hour.

Common problems with the mouse

1. Can't connect with bluetooth:
Please check whether the mobile phone has the Bluetooth function turned on. The icon on the taskbar of the receiver is gray when the phone is not turned on, and blue when Bluetooth is turned on.
2. Some APPs have some mouse function defects:
Due to the different definitions of each APP, this product is only applicable to most APPs, such as Douyin, Baidu, NetEase. Some functions of apps such as Kuaishou and Zhu Xiaobang will be defective
3. Apple mobile phone is slow or very sensitive problem
Because the IOS system needs to match the response speed of the mouse, it is necessary to adjust the speed of the little turtle in Settings - Accessibility - Assistive Touch - Tracking Sensitivity. Each user adjusts according to their own habits. To the right is sensitive, and to the left is insensitive.

After sales question

- 【1】. Purchase products, there are quality problems
1. Go to the dealer where you purchased the product and request a full refund (within 7 days)
2. Go to the dealer where you purchased the product to replace the same model product (within 15 days)
3. Go to an authorized service center for repair or replacement (within 15 days)

【2】. The product has quality problems after purchasing the product for more than 15 days but still within the warranty period

1. Go to an authorized service center for repair or replacement. The processing flow is: fill in the user information registration form under the guidance of the staff, and wait for our engineers to test, repair or replace the product for you
2. If there is no local authorized service center, the user needs to mail the product to the nearby service center, and the postage cost is at their own expense. Our staff will contact you as soon as possible after receiving the product mailed by you, and test, repair or replace the product. Return postage is borne by the company.
