1 Introduction

The endiio Retrofit-Box is a low-energy Sub-GHz (915MHz) wireless device based on the endiio Wireless Module v2.

It collects sensor data (such as Acceleration, Temperature, etc.) and send it wirelessly to the Gateway or the DIN-Rail Dongle.

2 Product Marketing Information

The endiio Retrofit-Box V2 device contains the radio module “endiio Wireless Module v2”.

6 Certifications and Compatibilities

6.1 *CE RED (Europe)*

The device is RED (Radio Equipment Directive) certified for the Sub-GHz. Frequency band (868 MHz).

6.2 *FCC Part 15 (USA) and ISED RSS (Canada)*

This device is using a wireless module contains licence-exempt transmitter/receiver that comply with Innovation, Science and Economic Development Canada's licence-exempt RSS(s) and complies with part 15 of the FCC Rules. Operation is subject to the following two conditions:
