

# Intelligent fully automatic cat toilet

## Instruction Manual

### ■ The use of safety guidance

- \* Failure to comply with the following terms and conditions may result in the product not being used normally, or other accidental loss.
- Please install and use the equipment strictly in accordance with the instructions.
- Do not use this device for pets within the last six months.
- The device should be placed on a horizontal hard surface, avoid touching walls.
- Do not place other heavy objects on the device to avoid potential safety risks.
- This equipment contains precision electronic
- components, be sure to handle with care, do not drag and move the equipment at will.
- To avoid potential safety risks, do not add sand during device operation.

- This device is suitable for cats weighing 1.5-8kg.
- If children are using this device, make sure to use it under adult supervision and guidance.
- Unplug the power cord if moving this device.
- Do not place the device in a high temperature and humidity environment.
- This device is in low voltage mode, but pets chewing the wire will still cause leakage, please guide the correct use.
- Please use the original power adapter, otherwise it will cause the device to not work properly.
- Do not immerse or soak the base of this product in water
- In case of problems with the use of the product, please contact the customer service of the purchase channel in time.

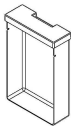

## ■ Quick start(whole machine installation)

1. Install the core module behind the base and fix it with 4screws, as shown in Figure(1).
2. The roller bin is placed on the base, the entrance and exit of the cat and the opening of the stool are in the same direction, the big gear and the small gear mesh, as shown in Figure(2), and the fixed roller clamp pin needs to be inserted as shown in Figure(3)

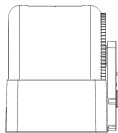

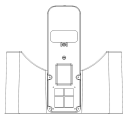

3.Wrap the garbage bag around the bin and place it in the base.

4. Pour the cat litter on the anti-stick cloth from the drum bininlet and outlet, as shown in Figure(4).

**Note: The weight of the cat litter should be less than 6kilograms, and the drum should be handled gently.**

5. Take out the power adapter and insert it into the power adapter jack on the back of the core module, as shown in Figure(5).

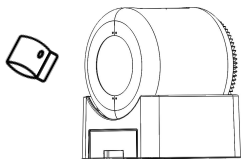

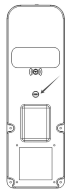

## ■ Quick start (product distribution network)

1.Mobile phone download and install Tuya app, and enter the app login, the device only supports 2.4G wifi, does not support 5GHz band and hotels, airports and other special certification of WiFi.

2. After the machine is powered on, press the button in figure (6) for 5 times continuously. In Figure (7), the network light is on, and the machine is in the state of distribution network.
3. Click the scanning device in the app. When the automatic cat litter box is scanned, click and enter the WiFi password.
4. Wait for the configuration to be successful.
5. One device can only be bound to one account. If multiple users need to use the device, they can share the device with other users through the app.
6. The operation of app video distribution network can be obtained by contacting the customer service of the purchase channel.

## **■ Quickly get started (product use)**

### **Automatic cleaning mode**

After connecting the power supply, the machine will perform a reset operation by default, and the drum will turn to the designated position. It will enter the automatic cleaning mode, and the machine will automatically clean up after the cat goes to the toilet for three minutes by default.

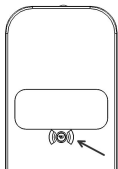

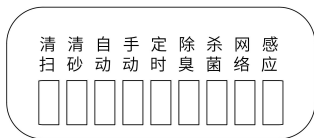

### **Clean up immediately**

In standby state, press the button in figure (6) for a long time and let go after the first sound of "beep". Figure(7)Cleaning green lights up, and the machine cleans up immediately.

### **Remove old sand with one button (Clean sand mode)**

- 1.In the standby state, press the key in figure (6) for a1、 long time, release the hand after the second sound of "beep". In figure (7), the green light for sand cleaning will be on, and the drum will reverse to remove the old sand.
- 2.During the sanding process, please ask the pet parents to take care of the operation, so as to avoid the cat going to the toilet during this period.
- 3.The machine should be reset within 1 minute after cleaning without any other operation, and the cat should be added after the end of cleaning.

### **Manual mode (Baby cat mode)**

In the standby state, press the button in figure (6) for a longtime, and release the hand after the fourth "beep". In Figure(7),the manual green light will be on, and the machine will enter the manual mode. In this mode,

the machine will not automatically clean, but only clean after pressing the key with a drop sound.

### **Business trip/Holiday mode (timing mode)**

In the standby state, press the key in figure (6) for a longtime, and release the hand after the fifth beep. In Figure (7) the timing green light will be on, and the machine will be cleaned every 6 hours by default.

### **Deodorizing mode (optional)**

- 1, the default fan is long open mode, always working. When the machine is running, the fan is suspended.
2. In the standby state, press the button in Figure (6) for along time, and let go after the sixth "beep". In Figure (7), the deodorant green light is extinguished, and the fan is turned off.

### **Germicidal mode**

1. UV germicidal lamp default machine cleaning time start
2. In the standby state, press the button in figure (6) for along time, and release it after the 6th "beep". In Figure(7) the sterilization green light is off, and the ultraviolet sterilization is not started during the operation of the machine.

## ■ Operation description

The machine monitors whether the cat enters in real time through the infrared probe of the core module.

If the cat is using for the first time, it is recommended to use the six-hour cleaning mode (timing mode)

The machine will be paused if the cat re-enters during the machine cleaning.

Note: The basic cat toilet with fresh air system or need detailed installation, you can contact the customer service of the purchase channel.

## ■ Cleaning guidance

### 1. drum cleaning

Drum can be washed, support the removal of anti-stick mat, after cleaning, need to air dry or wipe dry.

### 2. Clean the base of the main engine

The host base can be wiped with paper towels or rags, not washed and must be kept dry

### 3. Clean the bin

The toilet can be washed, after cleaning, need to air dry or wipe dry.
