④ Pairing

Touch and hold the raised touch button for 3 seconds to automatically enter pairing mode.

Ensure connecting mobile / device has Bluetooth turned on. Go to connections on device and search for 'ROKITSSG' and select to pair.

⑤ Multi-Function Button Guide

Turn on	Touch and hold the raised touch button for 3 secs.
Turn off	Touch and hold the raised touch button for 5 secs.
Answer the call	Double touch / click raised touch button.
Reject the call	Touch and hold raised touch button for 1.5 secs.
Hang up	Double touch / click raised touch button.
Play/Pause	Double touch / click raised touch button.
Next song	3 touches / clicks raised touch button.

⑥ Indicator Light Guide

Turn on	Blue light for 1s
Turn off	Blue light for 1s
Charging	Slow flashing blue light
Charge complete	Blue light stays off

⑦ Safety Rules

1. Do not disassemble or modify the glasses for any reason, otherwise it may cause the glasses to malfunction or burn out. This is not covered by the warranty.
2. Loud volume can cause hearing damage, please adjust to the appropriate volume when using the device.
3. Do not use the device during thunderstorms, as thunderstorms may cause the equipment to malfunction and increase the risk of electric shock.

⑧ Note

1. Please put the glasses in the correct position when charging.
2. If the battery is not properly replaced, there is a danger of explosion and it can only be replaced with a battery of the same type. In the case where you need to replace the battery, it is recommended you return the product to the supplier for battery replacement.
3. The battery (battery pack or combination battery) must not be exposed to excessive heat such as sunlight or fire.
