Power on/
off button

Single control mode electronic function.

- ◆ Long press @1.5 seconds in the off state: the indicator light is on, the two motors enter standby mode, short press the button again: the indicator light goes off, the two motors start working, short press again to switch to the next frequency, a total of 10 vibration@tapping modes are cycled in turn!
- ◆ Long press the button @ 1.5 seconds to switch off, the motor stops vibrating!
