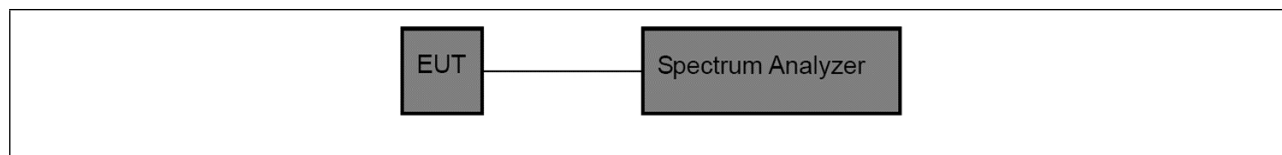
## 5. Maximum Conducted Output Power
