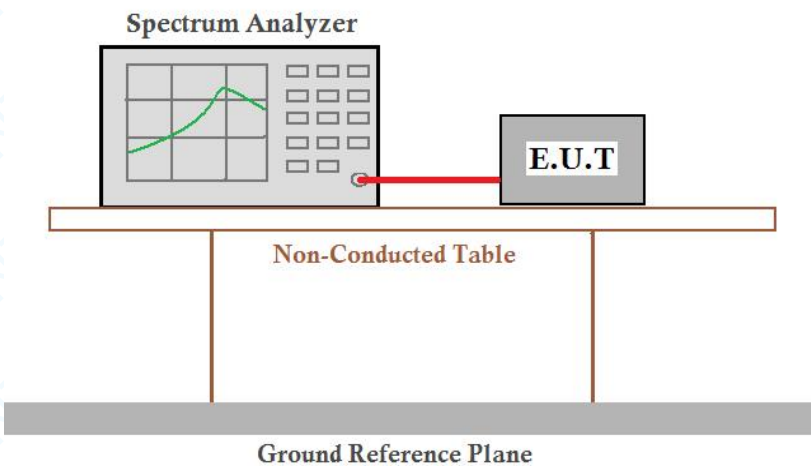
3 Test results and Measurement Data

3.1 Antenna requirements

Standard requirement:	47 CFR Part 15C Section 15.203 /247(c)
An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section. The manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited. This requirement does not apply to carrier current devices or to devices operated under the provisions of §§15.211, 15.213, 15.217, 15.219, 15.221, or §15.236. Further, this requirement does not apply to intentional radiators that must be professionally installed, such as perimeter protection systems and some field disturbance sensors, or to other intentional radiators which, in accordance with §15.31(d), must be measured at the installation site. However, the installer shall be responsible for ensuring that the proper antenna is employed so that the limits in this part are not exceeded.	
The antenna is welded on the main PCB and no consideration of replacement. The best case gain of the antenna is 0dBi.

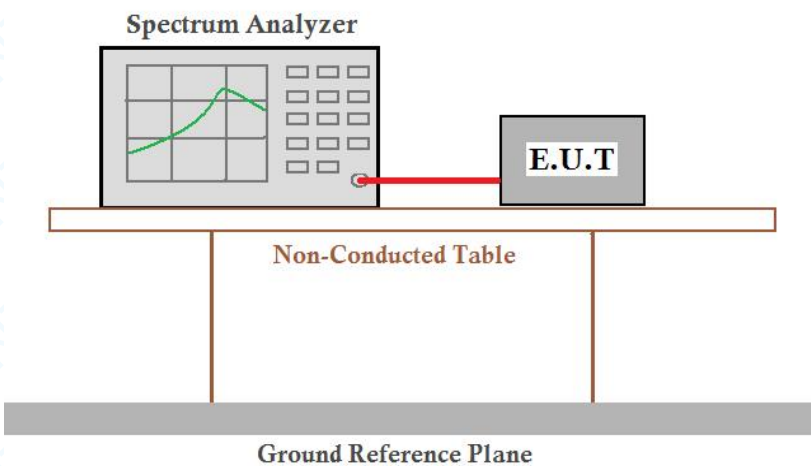

Allow trace to stabilize, use the marker-delta function to measure the on time and off time of the signal. 6. Record the results in the test report.

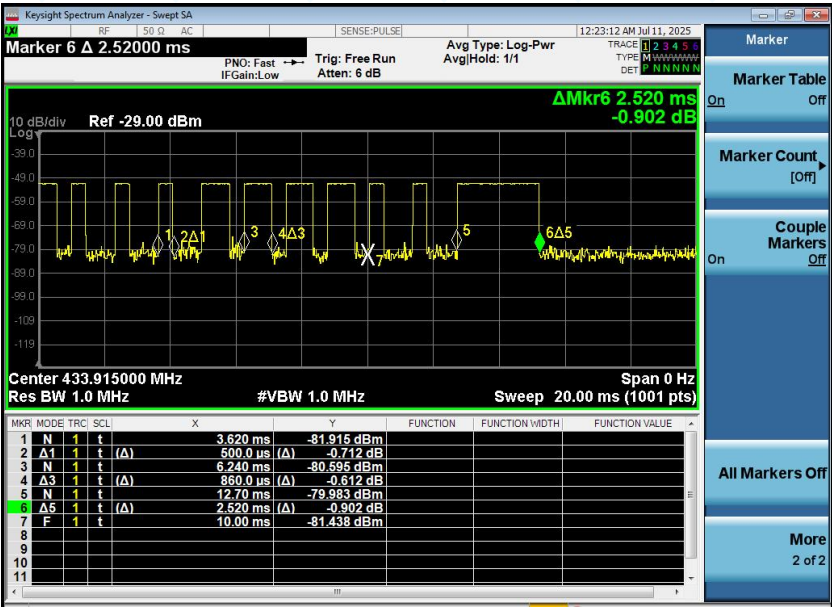
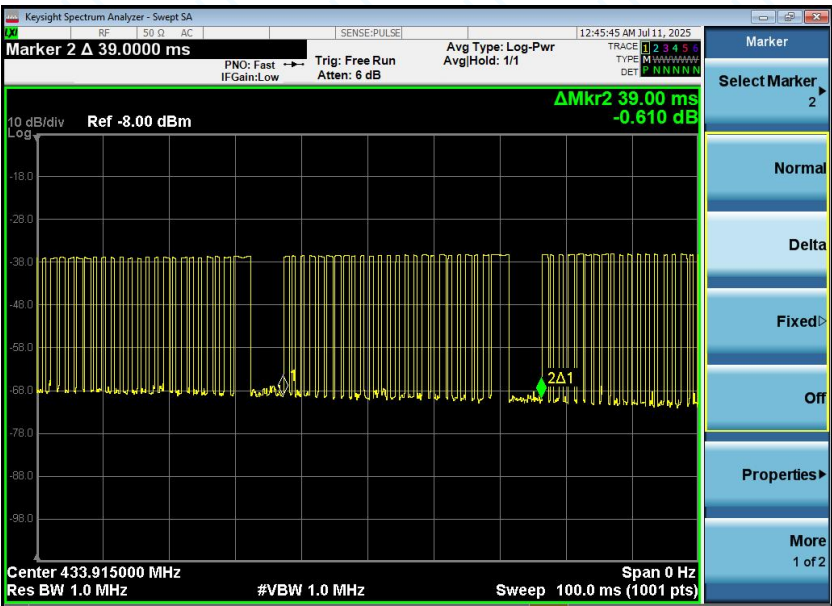

The average correction factor is computed by analyzing the on time in 100ms over one complete pulse train. Analysis of the remote transmitter on time in one complete pulse train, therefore the average value of fundamental frequency is: Average = Peak value + 20log (Duty cycle), where the duty factor is calculated from following formula:

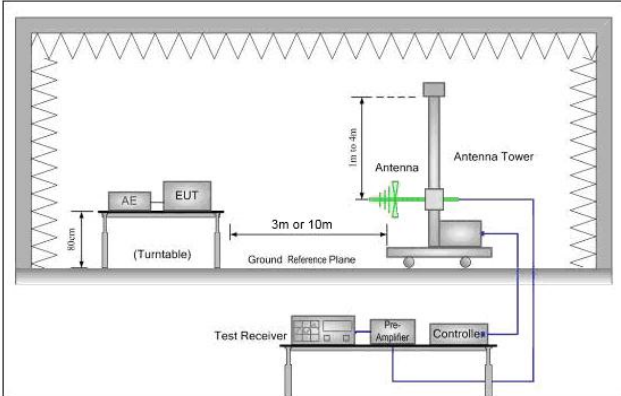
For 433.91 MHz:

$$20\log (\text{Duty cycle}) = 20\log (T_{pulse} / 39) = 20\log (17.24 / 39) = -7.09\text{dB}$$

Here $T_{pulse} = 2.5 + 14 * 0.5 + 9 * 0.86(\text{ms}) = 17.24(\text{ms})$

Test Procedure:	- the EUT was placed on the top of a rotating table 1 meters above the ground at a 3 meter semi-anechoic chamber. The table was rotated 360 degrees to determine the position of the highest radiation - The EUT was set 3 meters away from the interference-receiving antenna, which was mounted on the top of a variable-height antenna tower. - The antenna height is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement. - For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters(for the test frequency of below 30MHz, the antenna was tuned to heights 1 meter) and the rotatable table was turned from 0 degrees to 360 degrees to find the maximum reading. - The test-receiver system was set to Peak Detect Function and Specified Bandwidth with Maximum Hold Mode. - If the emission level of the EUT in peak mode was 10dB lower than the limit specified, then testing could be stopped and the peak values of the EUT would be reported. Otherwise the emissions that did not have 10dB margin would be re-tested one by one using peak, quasi-peak or average method as specified and then reported in a data sheet. - The radiation measurements are performed in X, Y, Z axis positioning for Transmitting mode, And found the X axis positioning which it is worse case. - Repeat above procedures until all frequencies measured was complete.

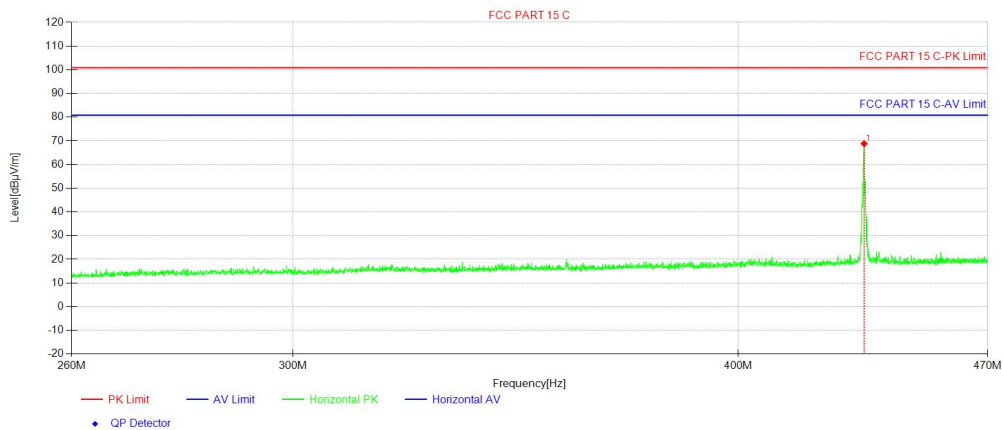

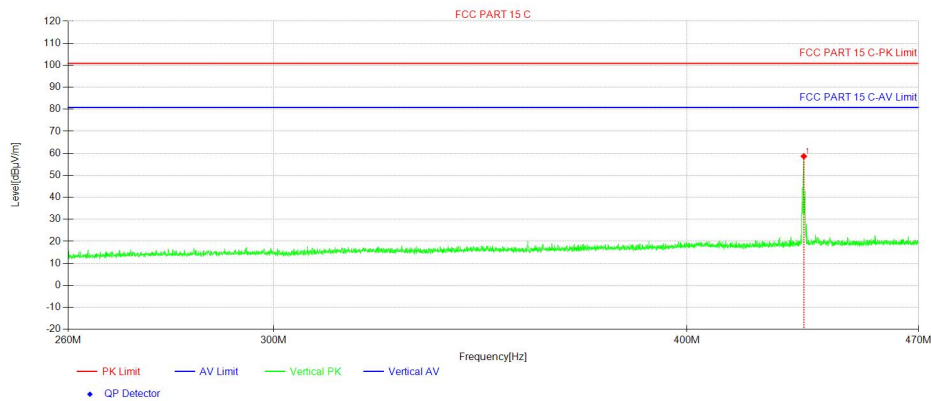

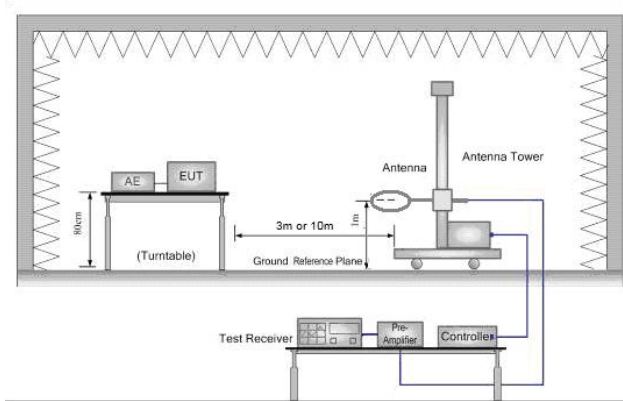


Figure 1. Below 30MHz

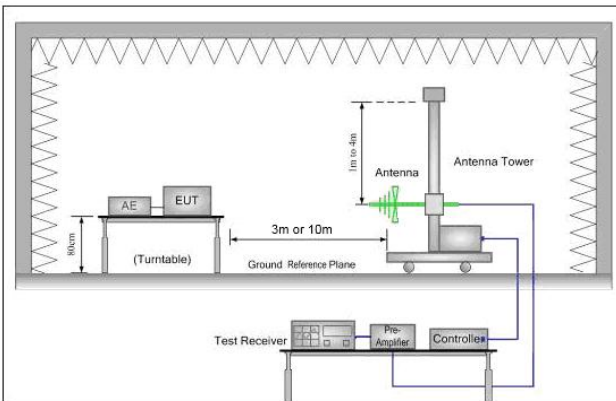


Figure 2. 30MHz to 1GHz

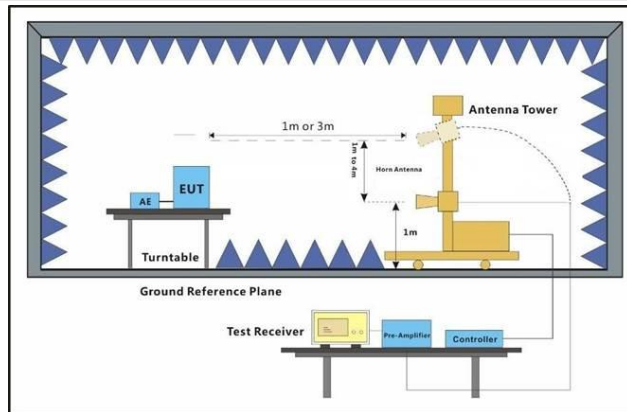


Figure 3. Above 1 GHz

Test Procedure:

- h. For below 1GHz, the EUT was placed on the top of a rotating table 0.8 meters above the ground at a 3 or 10 meter semi-anechoic chamber. The table was rotated 360 degrees to determine the position of the highest radiation.
- i. For above 1GHz, the EUT was placed on the top of a rotating table 1.5 meters above the ground at a 3 meter semi-anechoic chamber. The table was rotated 360 degrees to determine the position of the highest radiation
- j. The EUT was set 3 or 10 meters away from the interference-receiving antenna, which was mounted on the top of a variable-height antenna tower.
- k. The antenna height is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
- l. For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters (for the test frequency of below 30MHz, the antenna was tuned to heights 1 meter) and the rotatable table was turned from 0 degrees to 360 degrees to find the maximum reading.
- m. The test-receiver system was set to Peak Detect Function and Specified Bandwidth with Maximum Hold Mode.
- n. If the emission level of the EUT in peak mode was 10dB lower than the limit specified, then testing could be stopped and the peak values of the EUT would be reported. Otherwise the emissions that did not have 10dB margin would be re-tested one by one using peak, quasi-peak or average method as specified and then reported in a data sheet.
- o. Test the EUT in the lowest channel, the middle channel, the Highest channel.
- p. The radiation measurements are performed in X, Y, Z axis positioning for Transmitting mode, And found the X axis positioning which it is worse case.
- q. Repeat above procedures until all frequencies measured was complete.

Test Procedure:	1) The mains terminal disturbance voltage test was conducted in a shielded room. 2) The EUT was connected to AC power source through a LISN 1 (Line Impedance Stabilization Network) which provides a 50Ω/50μH + 5Ω linear impedance. The power cables of all other units of the EUT were connected to a second LISN 2, which was bonded to the ground reference plane in the same way as the LISN 1 for the unit being measured. 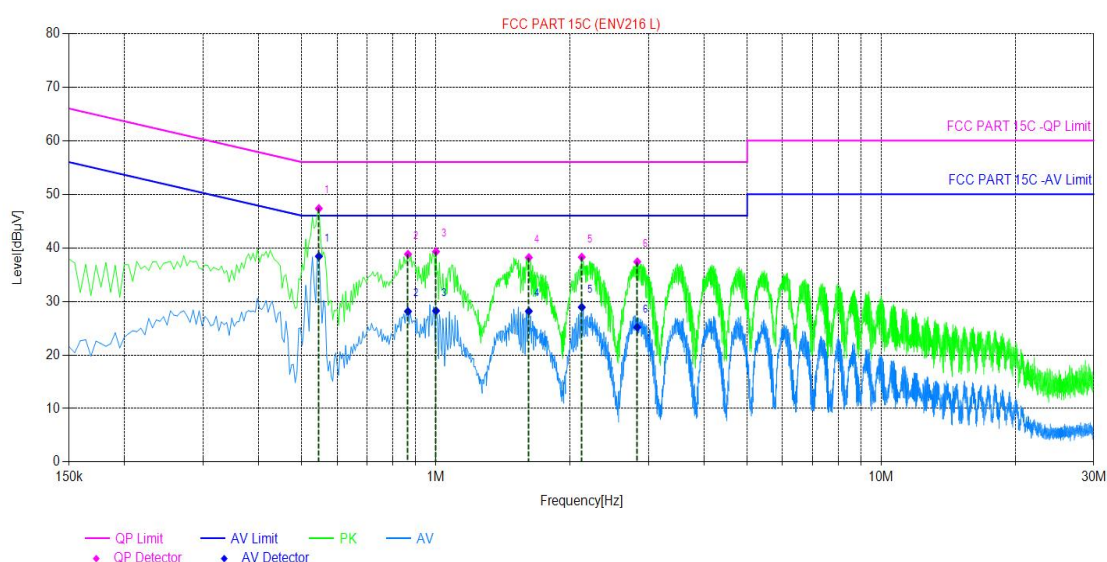

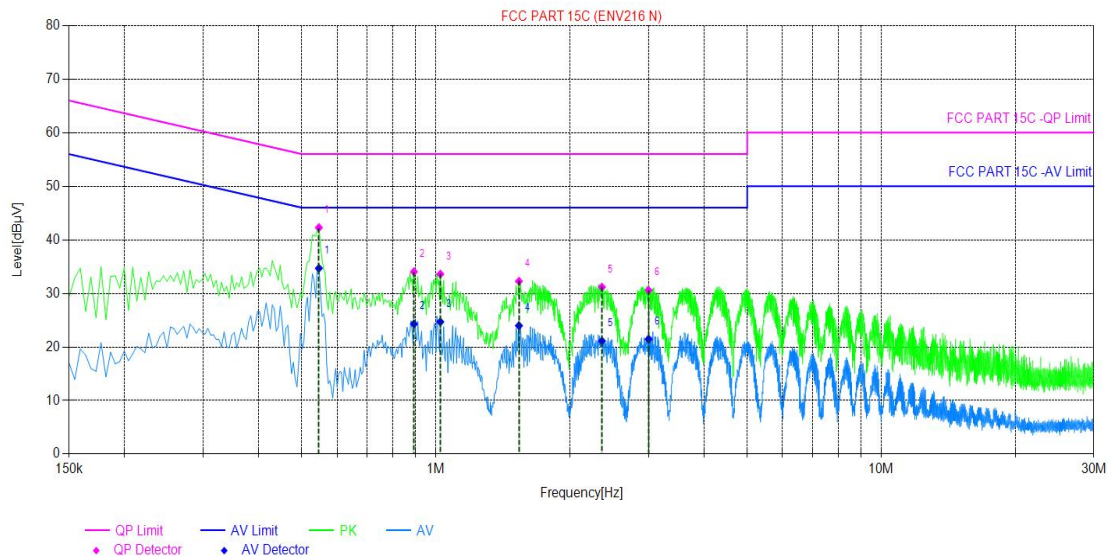
