

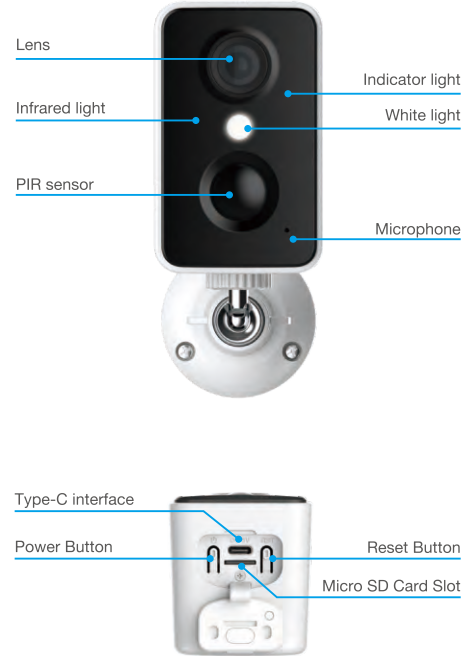

Red light quickly flashing	1.Reset camera to factory setting 2.Camera is upgrading firmware

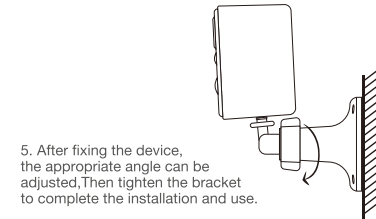
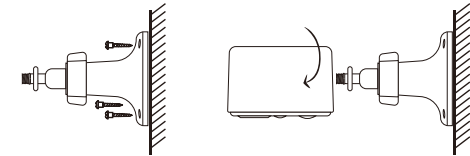
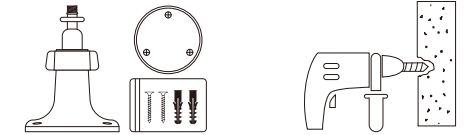
NOTE: The device is hibernating, and the indicator light turns off. To check if the device is powered on, click the reset button to see if the indicator light is on.

Button Controls

Button	Function	Operation Manual
RST	Enter into the network configuration status	After the camera starts, it will default to the network configuration state. If the network configuration is not completed in about 180 seconds, you must click the RST key again.
	Reset	Press and hold the RST button for about 6 seconds, the "DiDi" voice prompt will play, and the red light will flash quickly. The device will restart
Power Switch	Switch ON	Press the power button for around 4 seconds to turn on the device, and start-up music will play.
	Switch OFF	Press the power button for around 4 seconds to turn off the device.

Equipment installation

The wall surface should be installed with a certain thickness and be able to withstand at least 3 times the weight of the equipment.

Please check if the wireless router is working properly or not , then connect your phone to Wi-Fi .
Please connect to 2.4G band if it is a dual band router.

Or scan below QR code to download "AJCloud" to your Android or Apple device.



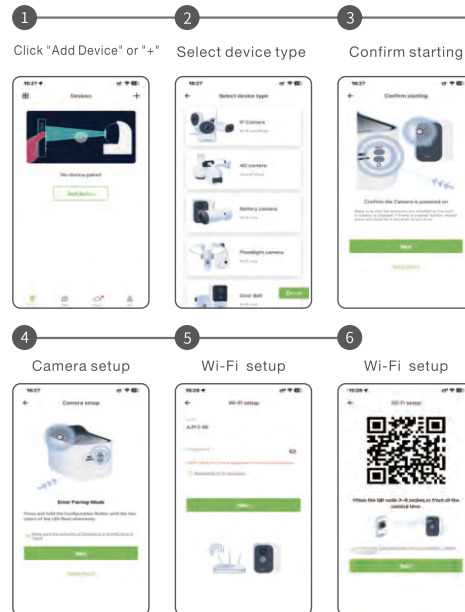
