
Instructions for use






1 Install handle




2 Add snowflake oil




3 Insert power cord, wired controller Turn on the switch



4 Using a controller to operate the machine



When using the remote control, the wired controller must be turned off

6 : Safety precautions for use.....

- When the machine is working, it is normal for the fan to make loud noise
- Use safe and qualified snowflake liquid to avoid counterfeit and inferior Liquid causes machine damage
- Ensure that the snowflake machine is located on a stable horizontal plane, away from hazardous areasFlammable and explosive materials, etc
- Before starting the snowflake machine, check that the snowflake liquid is sufficient to avoid drying out and causing malfunctions or safety problems.
- During the use of the snowflake machine, maintain good indoor ventilation and avoid excessive exposureThe accumulation of foam causes air pollution.
- If a malfunction or abnormality is found in the snowflake machine, it should be stopped Professional maintenance personnel should be contacted immediately for repairs
- After continuous use for about 40 hours, please use 80% pure water and 20% white vinegar to clean the dirt in the heating pipeline, effectively extending the service life of the machine
- Do not dispose of waste batteries at will, they should be sent to a professional recycling facility
- Prohibit minors from operating machines, keep away from children and people with disabilities

7 : Other precautions.....■

- The first time you open the box and find that the liquid inside the oil pipe is protective fluid for the oil well pump, it does not mean that you have purchased a used second-hand product
- When the machine is working, the temperature is high. This is a normal situation, please do not touch the shell directly with your hands
- When the liquid in the oil bottle is about to run out, it then the should be added immediately, otherwise continuing to work will damage the machine.
- This product should be used in a dry place. No liquid should seep into the interior of the machine (limited to the oil bottle). If accidental penetration occurs, please immediately turn off the power and wait for the machine to dry before use.
- Do not consume sprayed foam snowflakes.
