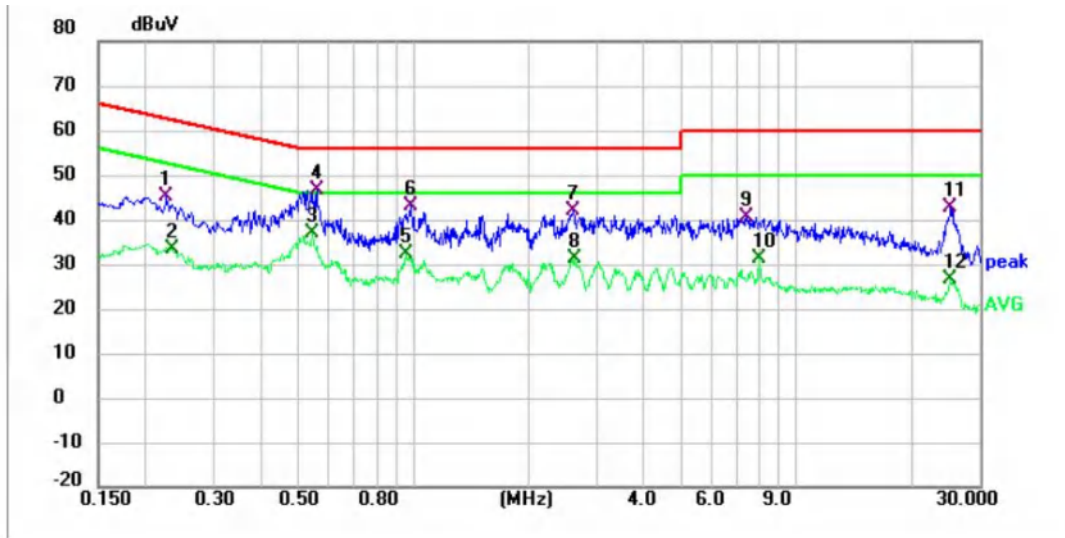

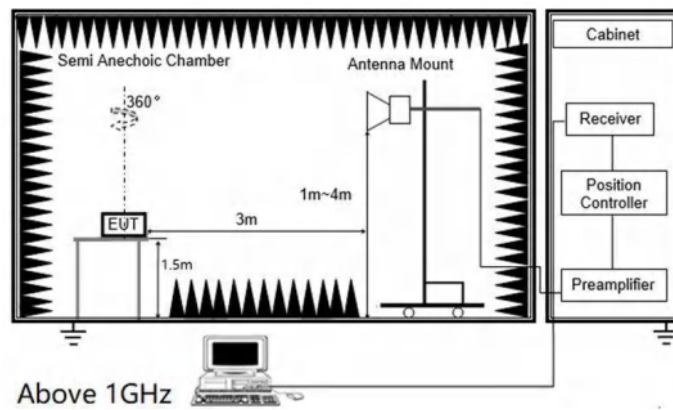

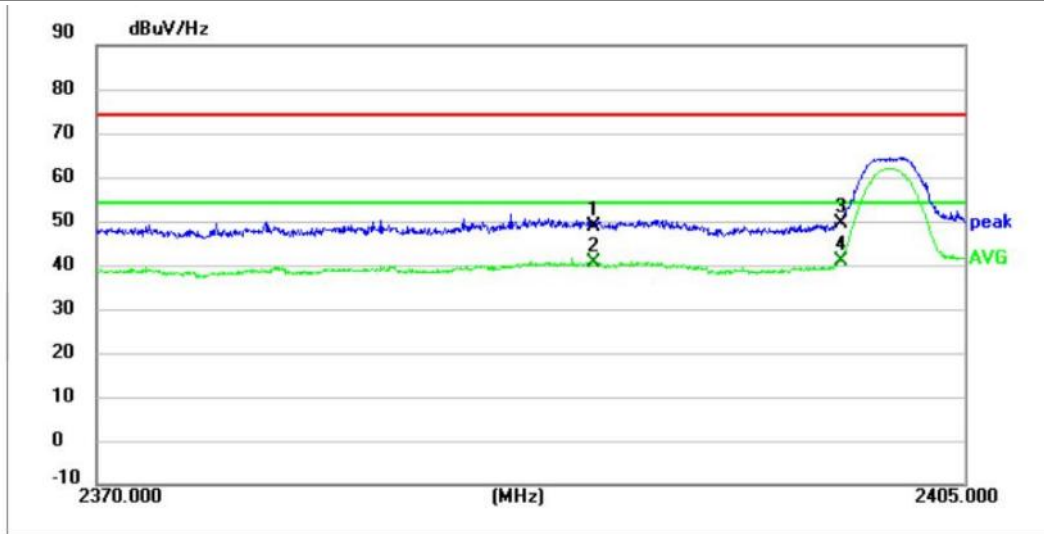

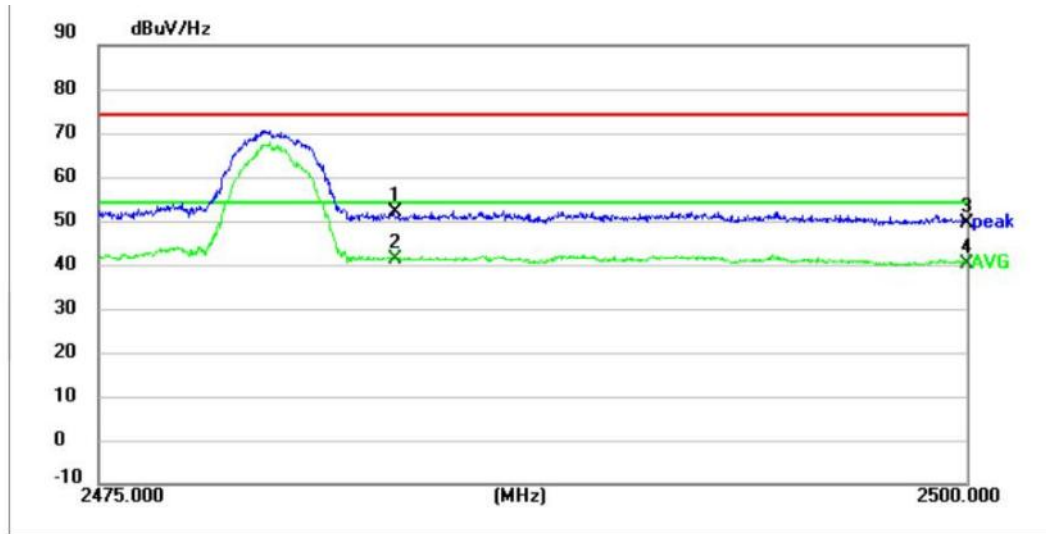

### 5.2.10.2. Test Setup Diagram



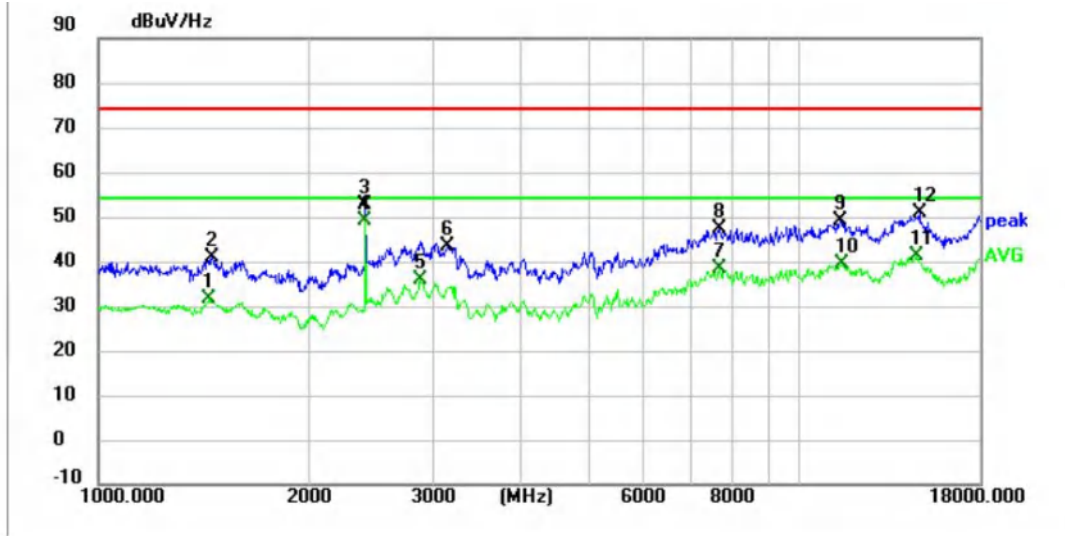

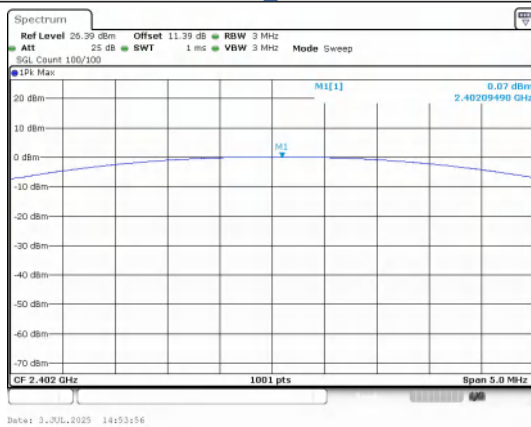




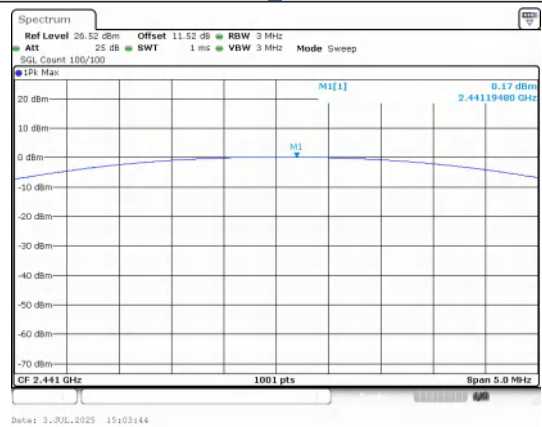
**Peak Output Power  
 $\pi/4$ DQPSK\_Channel 39**



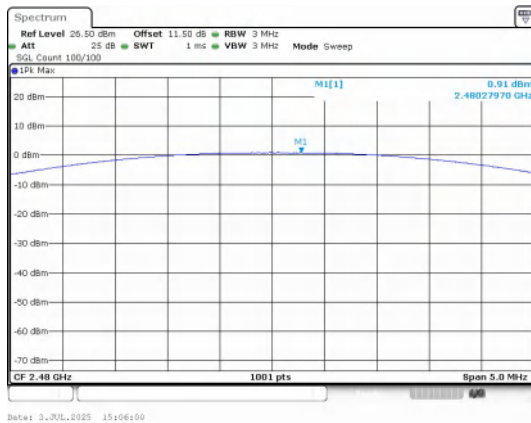
**Peak Output Power
