

How to use

When wearing the product, please remove the contact lens hairpin etc. to avoid discomfort during the massage. After putting it on, adjust the elastic band to a comfortable position and then move the device up and down to align the eye with the visible hole on the back of the product; please put the product on your eyes before turning it on to avoid overpressure of the airbag.

Switching on/off

- Press and hold the button for 2 seconds to switch on the main unit, and turn on the default vibrant mode
- Press and hold the button for 2 seconds to switch off.

Mode Switching.

- Short press the button for 1 second to switch modes;
- press [Vitality mode/Relaxation mode/Sleep mode] to switch in sequence.

Music

- Double click the button to turn off/on the built-in relaxation music;
- Turn on your mobile phone Bluetooth and search for [Eye Massager] to connect to the product and play music from your mobile phone.

Smart reminder

- Power outage reminder

When the remaining power is about 10 minutes, the status light will flash continuously to remind you to recharge; at the same time, the battery will be automatically switched off when the battery is exhausted.

- Charging reminder

When charging, the status light is flashing, the button function is invalid and the machine is not available; when fully charged, the status light is always on.

- Automatic switch-off

Automatic switch-off after 15 minutes by default after switching on.

Points to note

- Children or people with disabilities should only use the device under special supervision; If you experience any physical abnormalities during use, please stop using the device immediately and consult a doctor.
- Do not use if the device, charger or charging cable is damaged;
- Make sure that the charger and the charging socket of the product are dry before charging;
- Do not charge the product or the charger if it is likely to be submerged in water.
- Do not use this device in conjunction with other therapeutic devices.
- It is recommended that you use the product for 15 minutes at a time;
- Do not use if you have eye problems, or if you have had eye surgery, glaucoma, cataract, retinal detachment or other major eye diseases.
- Do not use if you have injuries around the eyes or if you need to rest quietly.
- The appliance has a heat-generating surface, so people who are not sensitive to heat must be careful when using it.
- Do not damage, break, excessively bend, pull, twist, or knot the power cord. If the power cord of the charger is broken, do not dismantle it and replace it yourself, but contact your dealer or a qualified professional for replacement and repair.
