


### light strip Instructions

MODE +: Dimming mode (7-color cyclic dimming)

MODE -: Repeat breathing mode key to adjust breathing color (white- red -green- blue- pink -light blue-yellow -automatic dimming breathing)



DEMO: Repeat flashing mode key to adjust flashing color (white- red- green- blue- pink -light blue -yellow -automatic dimming flashing)

SPEED+/SPEED -: Adjust the speed of changing the dimming mode, breathing mode, and flashing mode (7-speed adjustment)


COLOR+/COLOR -: Single color switching

BRIGHT+/BRIGHT -: Adjust brightness in monochrome mode (7 gears)






**NOTE**  
During use, if the light is interfered with by other remote controls or cannot be remotely controlled, you need to perform code matching or cancellation operations. Before executing code matching or cancellation, please turn off the power first and then turn it back on.  
How to perform code matching operation: Press and hold the start button on the remote control for 3 seconds within 7 seconds of turning on the power, the light strip flashes 3 times with white light, indicating that the code (remote control) already matched.  
How to cancel the matching code : Press and hold the white button on the remote control for 3 seconds within 7 seconds of turning on the power, the light strip flashes 3 times with white light, indicating that the code (remote control) already canceled.
