

#### Note:

1. All the equipment/cables were placed in the worst-case configuration to maximize the emission during the test.
2. Grounding was established in accordance with the manufacturer's requirements and conditions for the intended use.
3. For conducted measurements (Output Power, 20dB Occupied Bandwidth, Carrier Frequencies Separation, Hopping Channel Number, Dwell Time, Spurious Emissions), the antenna of EUT is connected to the test equipment via temporary antenna connector, the antenna connector is soldered on the antenna port of EUT, and the temporary antenna connector is listed in the Test Instruments.

## 4. Test Results and Measurement Data

According to §1.1307(b), systems operating under the provisions of this section shall be operated in a manner that ensure that the public is not exposed to radio frequency energy level in excess of the Commission's guideline.

Remark: 1) **For BLE:** The maximum output power for antenna is 2.08dBm (1.61mW) at 2440MHz, 2.60dBi antenna gain (with 1.82 numeric antenna gain.)  
**For WIFI:** The maximum output power for antenna is 13.54dBm (22.59mW) at 2462MHz, 2.60dBi antenna gain (with 1.82 numeric antenna gain.)  
2) For mobile or fixed location transmitters, no SAR consideration applied. The minimum separation generally be used is at least 20cm, even if the calculation indicate that the MPE distance would be lesser.

### Calculation

$$\text{Given } E = \sqrt{\frac{30 \times P \times G}{d}} \quad \& \quad S = \frac{E^2}{3770}$$

Where  $E$  = Field Strength in Volts / meter

$P$  = Power in Watts

$G$  = Numeric antenna gain

$d$  = Distance in meters

$S$  = Power Density in milliwatts / square centimeter

Substituting the MPE safe distance using  $d=20\text{cm}$  into above equation.

Yields:

$$S=0.000199*P*G$$

WIFI	22.59	1.82	0.008182	1.0	PASS

Note: BLE/WIFI Can be transmitted simultaneously, MPE calculate is as follow,  
 $MPE=0.000583/1.0+0.008182/1.0=0.008765<1$ .
