Band13-5MHz-QPSK-23205-1RB#0-Range1:30~1000MHz

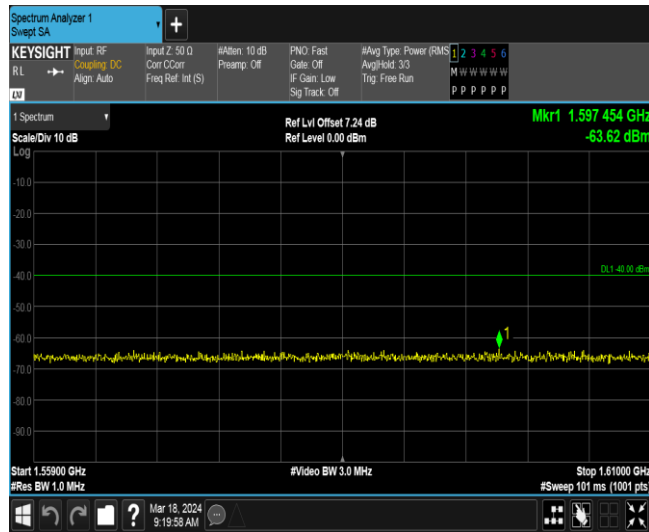


Band13-5MHz-QPSK-23205-1RB#0-Range2:1000~10000MHz

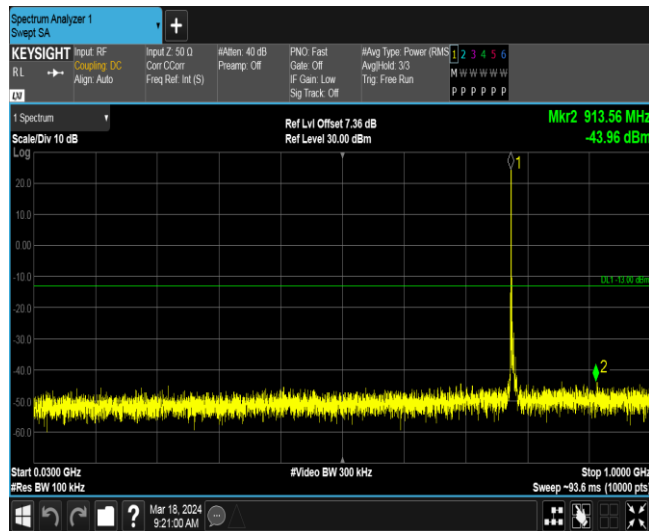
