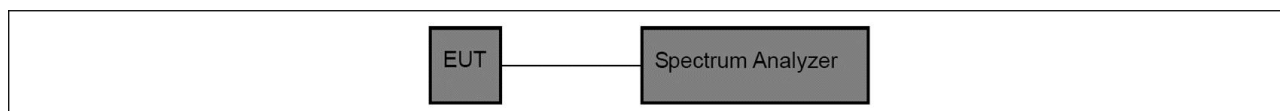
4. 6dB Bandwidth
