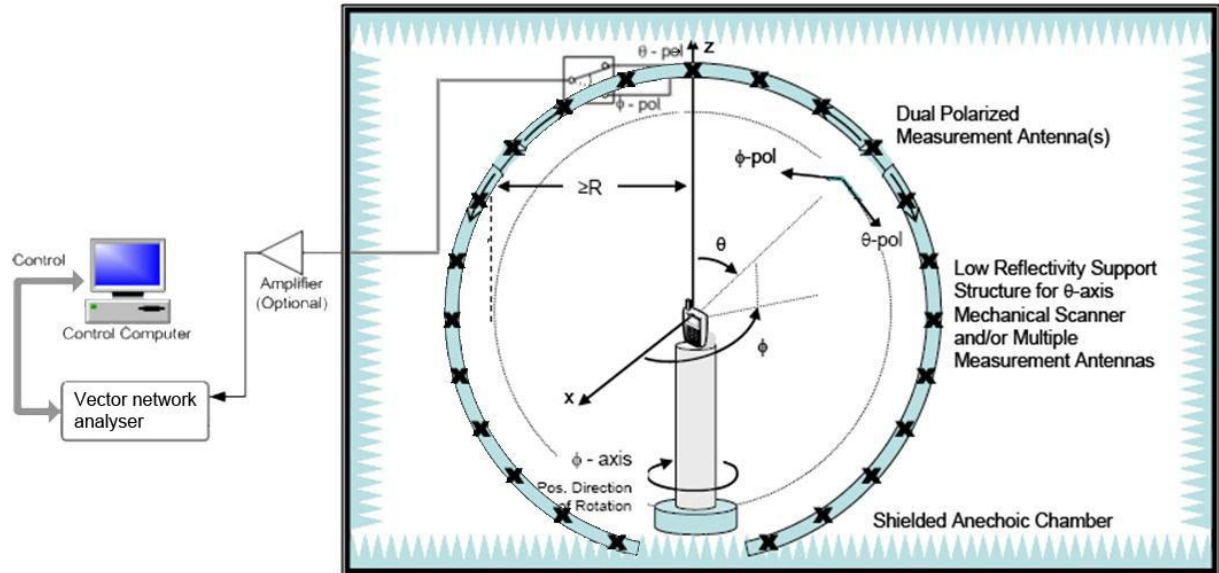

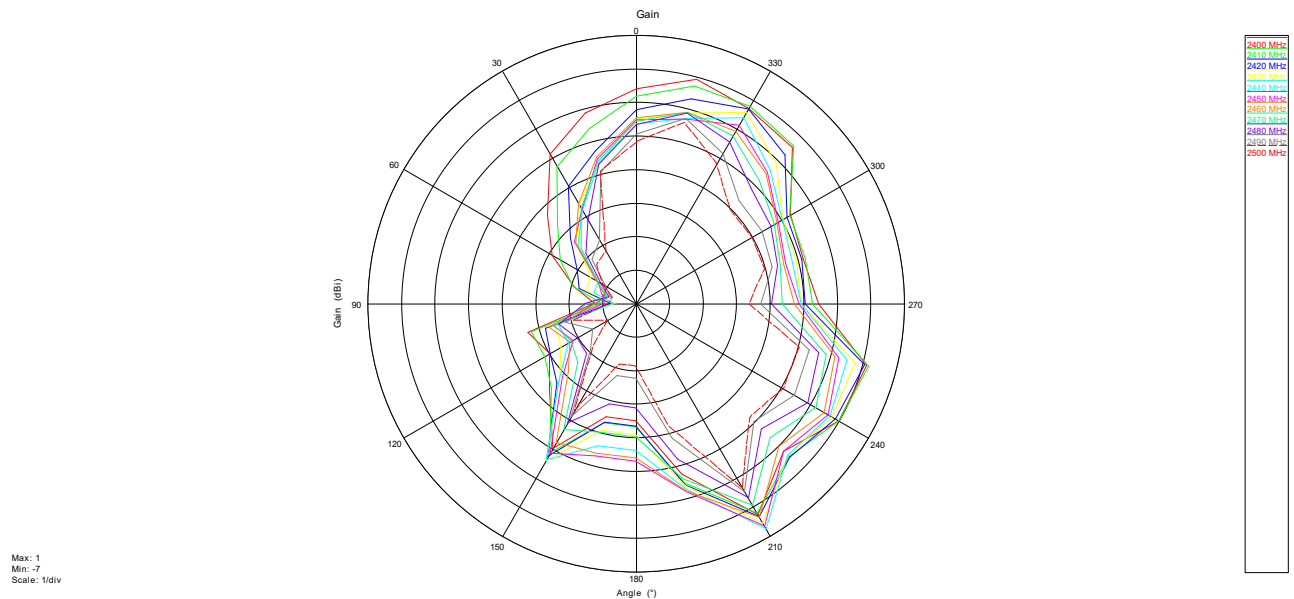




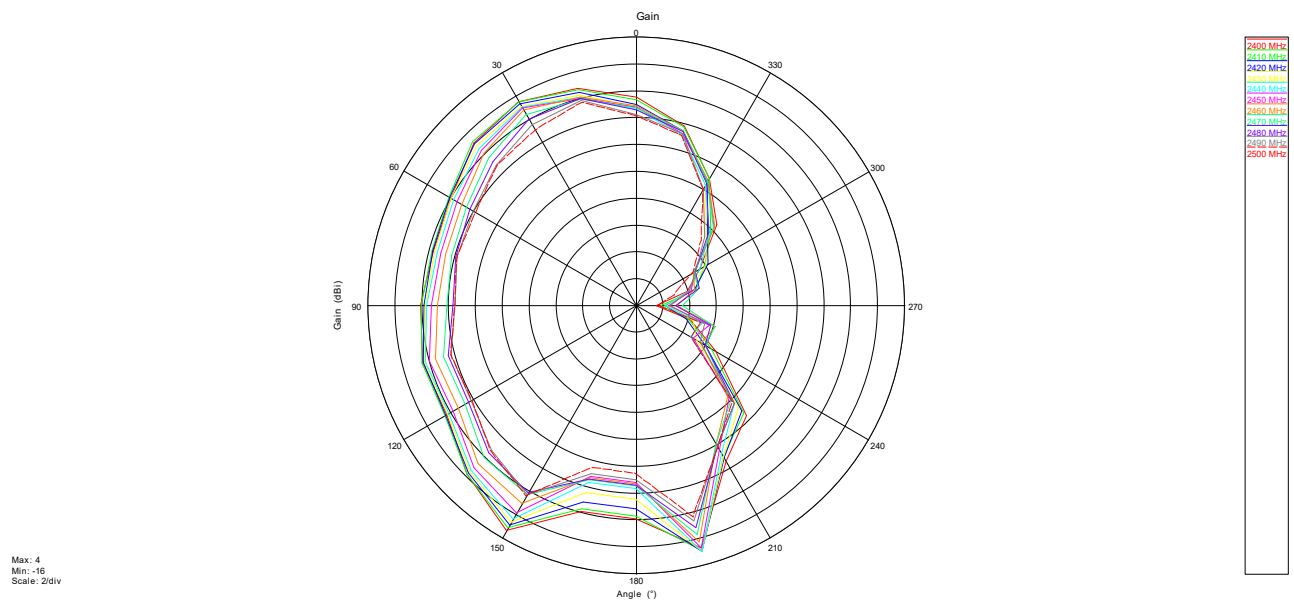

Phi=0°

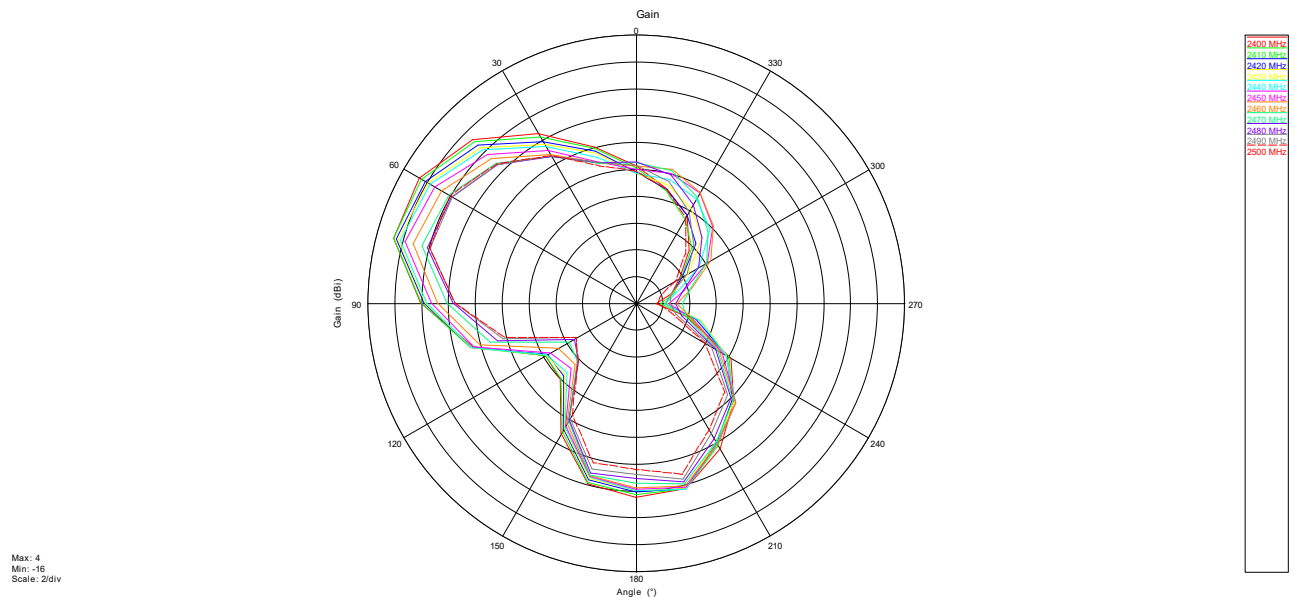


Phi=90°

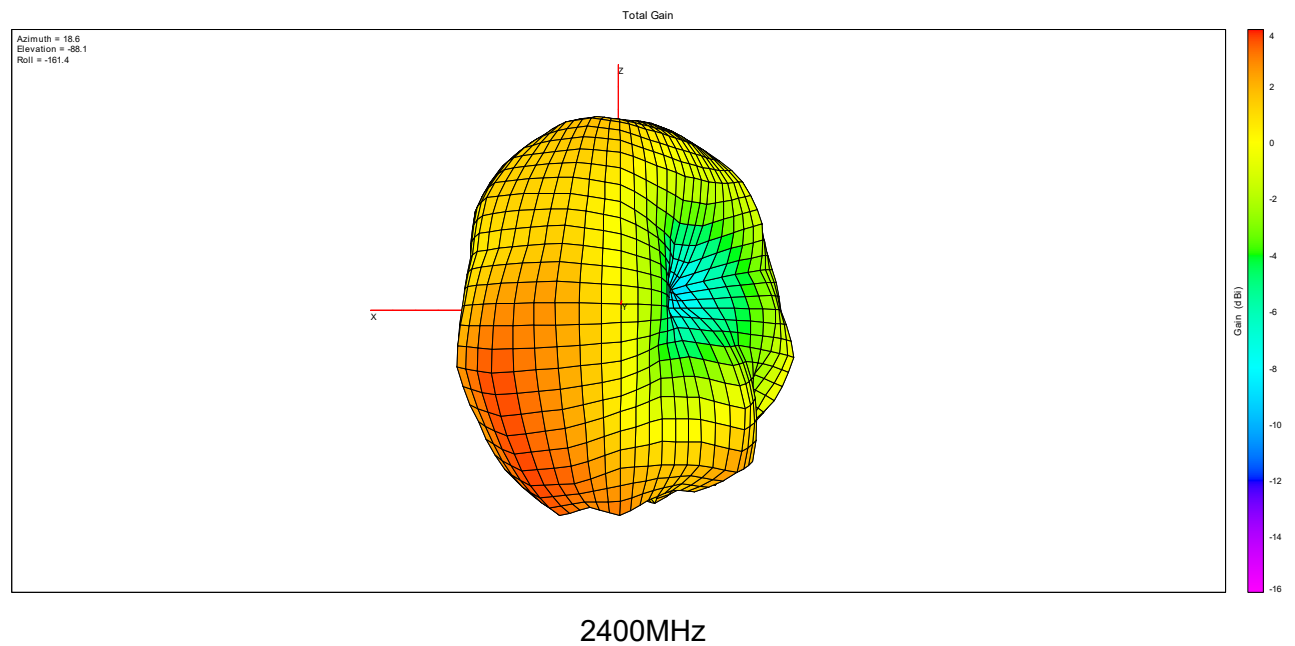


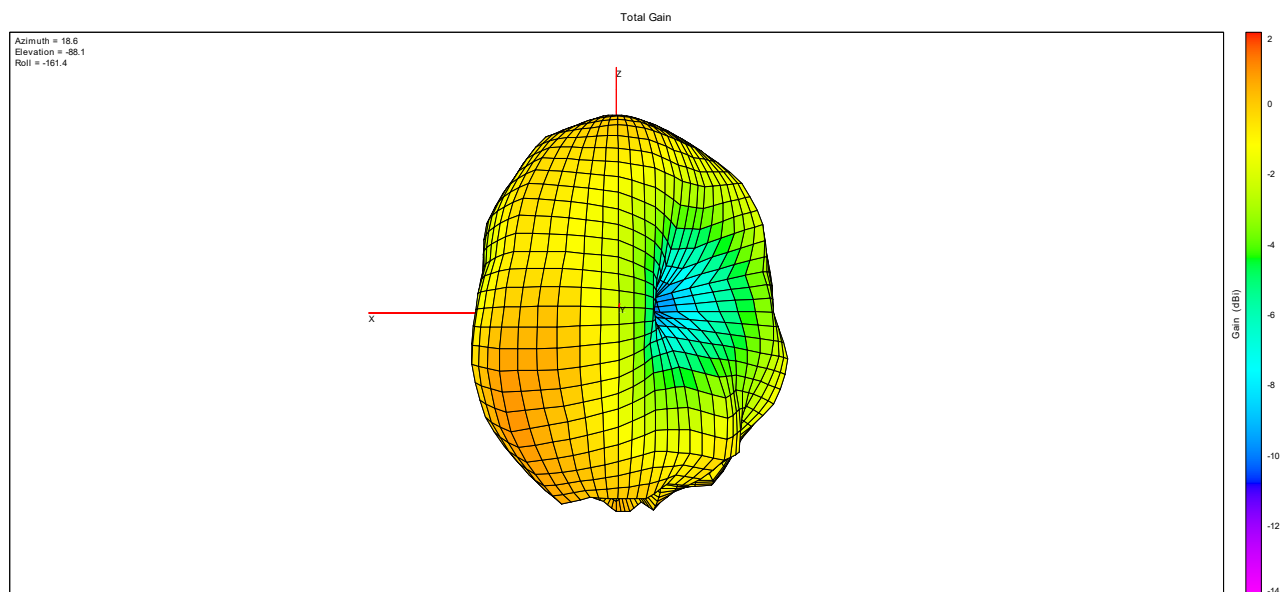
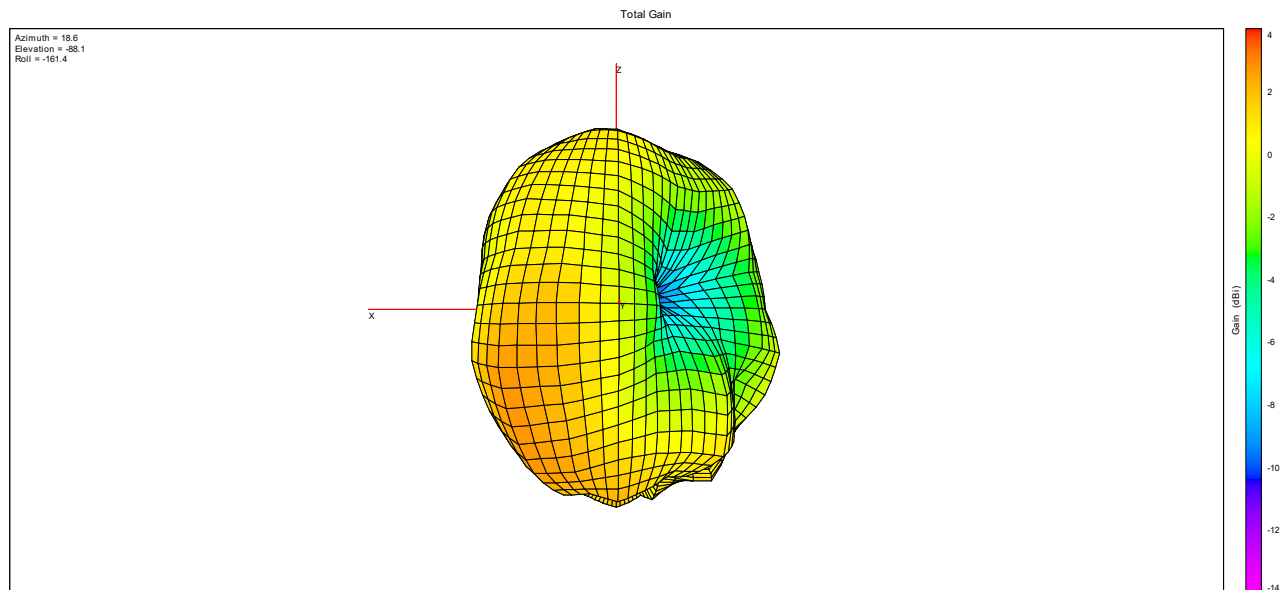


Theta=90°



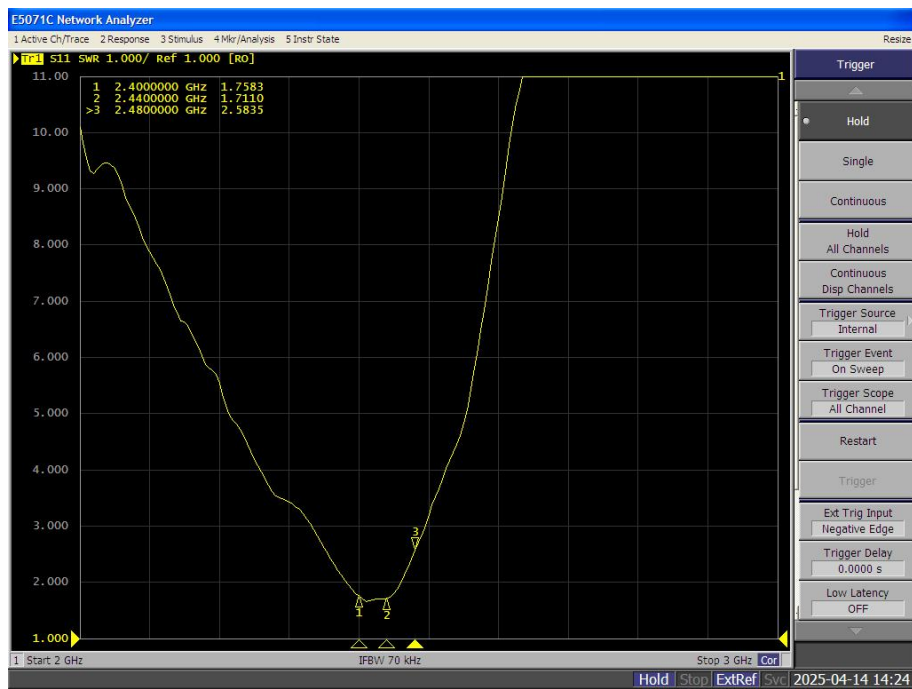
2. 3D Radiation Pattern



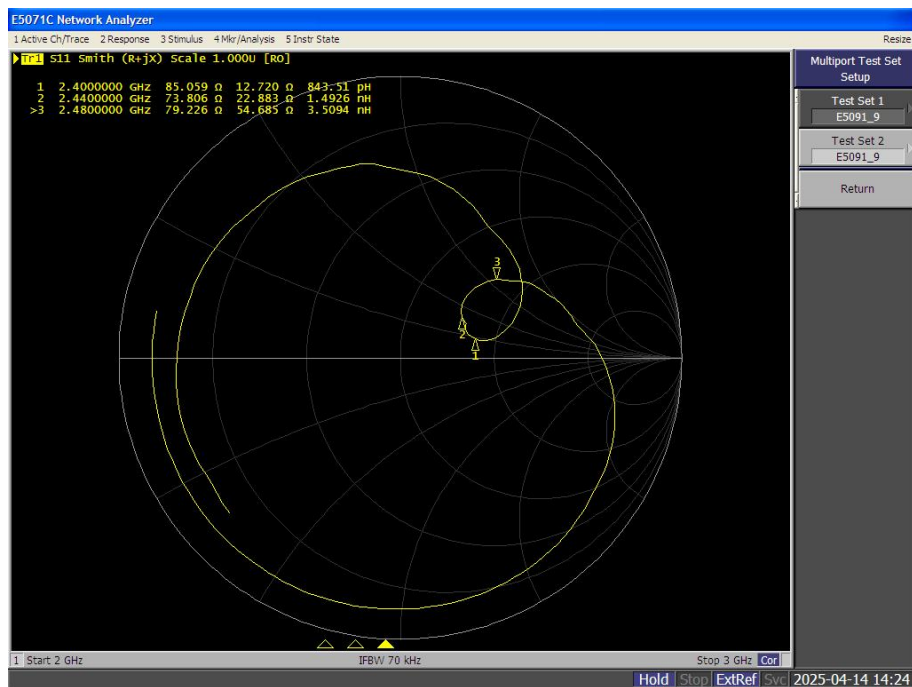
