## Introduction

Thank you for purchasing the eye massager EM 500. This device might benefit those with dry eyes, headache, migraines, eye strain and poor sleep quality. It features air compression massage, heating, music and Bluetooth function.

Please read this manual carefully before using the device and keep it in a safe and secure place for reference.

## Important Safety Instructions

**Read all instructions before using this product!**  
 • When using an electric appliance basic precautions should always be followed, including the following:

## Product Description

## Intended Use

The EM 500 eye massager is intended to help relieve eye strain and provide relaxation for eyes. It features 3 air compression massage intensity levels, 2 heat levels, 3 built-in white noise music and Bluetooth function with automatic timing of 15 minutes. The device is not intended for medical-therapeutic use. It is not suitable for clinics, massage practices, wellness studios, etc. The massage device is not a medical device and is not intended for the treatment of pain, in case of doubt or uncertainty, consult your doctor before use.

## Intended User

The EM 500 eye massager can be used by those with dry eyes, migraines, eye strain and fatigue caused by long-term use of eyes, but mind the restrictions listed in Section "Contraindications".


## Intended Use Environment


## Steps to Wear Your EM 500 Eye Massage



## Bluetooth Connection

- ① Turn on the eye massager and the Bluetooth function is on. Please enable Bluetooth on your mobile device.
- ② Search for "medisana eye massager" via Bluetooth settings and connect it to play the music on your mobile device.
- ③ Short press the power button 2 times to turn on/off Bluetooth function.
- ④ Once paired successfully, the EM 500 eye massager will automatically connect with your device by Bluetooth within a distance of 10 meters each time turned on, followed by a voice prompt "Bluetooth connected".

## Operation Instruction



## Air Pressure Adjustment

Click to switch air pressure intensity levels(Soft pressure—medium pressure—strong pressure—no pressure)

## Music Volume Adjustment

Click to switch music volume levels(level 3—level 4—level 5—no volume—level 1—level 2). Long press to switch the next music. Double click to turn music off. Double click again to turn music on again.

## Heat Function Adjustment

Click to switch heat levels(No heat—high heat—no temperature)

## Power/Mode Button

Default mode: Low Pressure + Low Heat + Music volume at level 3. Click this button to switch the modes in a loop of air pressure plus heat plus music—air pressure only—heat only—heat plus music—air pressure plus music.

## Air Pressure Button

Press to switch in a loop of soft pressure—medium pressure—strong pressure—no pressure.

## Music Volume &amp; Next Song &amp; Music Off Button

Short press to adjust the volume level in a loop of level 3—level 4—level 5—no volume—level 1—level 2. Long press to switch the next music song. Short press 2 times to switch off the music function. Short press 2 times again to switch on the music function.

## Heat button

Press to switch heat levels in a loop of low heat—high heat—no temperature.

## 15-minute Auto-off Timer

The device switches off automatically after approx. 15 minutes unless it is switched off manually beforehand.



**It is not recommended to use the device for more than 20 minutes at a time.**

## Maintenance and Cleaning

## Cleaning and Care

- Before cleaning the device, make sure that it is switched off and the power supply device is disconnected. Allow the device to cool down.
- Cleaning the device: gently wipe the device surface with a slightly damp cotton cloth only. Do not rinse the device. Never use brushes, aggressive cleaning agents, petrol, thinner or alcohol. May not be bleached, ironed or dry cleaned!
- Wait until the device is completely dry before using it again.

## Maintenance

- In the event of malfunctions or damage, do not repair the device yourself, as this will invalidate any warranty claims. Contact your specialist dealer and have repairs carried out only by authorized service centers in order to avoid hazards.
- Only use accessories intended for the device and supplied by the manufacturer.
- Cleaning and user maintenance must not be carried out by children without supervision.

## Storage

- You should ideally store the device in its original packaging and keep it in a clean, dry place.
- Store the device in a safe, clean, cool and dry, well-ventilated place. Secure it against falling and shocks.

## Contraindication and Restrictions of Use

- Persons with reduced physical, sensory or mental capabilities or lack of experience and knowledge should be given supervision or instruction concerning use of the device in a safe way and understand the hazards involved.
- Children must be supervised to ensure that they do not play with the device.
- Children under the age of three must not use this device due to their inability to react to over heating.
- Do not use this device to supplement or replace medical treatment. Chronic complaints and symptoms may be made worse.
- Do not use the EM 500 eye massager, or only after consulting your doctor, if:
  - you are pregnant,
  - you have a cardiac pacemaker, artificial joints or electronic implants,
  - you suffer from one or more of the following illnesses and complaints: Circulation disorders, varicose veins, open wounds, bruises, broken skin, inflammation of the veins.
  - If you experience any pain or discomfort during the usage, stop immediately and consult your doctor.
  - The surface of the device is hot. People who are insensitive to heat must be careful when using the device.
  - Before using the eye massager, consult your doctor regarding any unexplained pain, if you are undergoing medical treatment or using medical equipment,
  - This device contains non-replaceable batteries.

## Safety Instructions

### Power supply

- Only charge the device's battery using the USB charging cable supplied.
- Never charge the device in a flammable environment (e.g. flammable objects, gasoline, flammable gases, paint, etc.)
- Only connect the device for charging so that the cable and power connector are freely accessible.
- The built-in batteries are not intended for replacement or removal by the end user. If problems occur with the power supply, contact the customer service.
- This device must only be supplied at safety extra low voltage (SELV) corresponding to the marking on the device.
- To disconnect the device from the mains, always pull the plug out of the power connector. Do not pull on the cable.
- Do not use a charger that has wire or body damage, replace it in a timely manner.
- Handle the charger with care, do not overextend the wire or allow it to come in contact with heat or sharp objects.

### Before operating the device

- Check the eye massager carefully for damage before each use. Do not operate defective device.

### When operating the device

- The device must only be used for its intended purpose as described in the instruction manual.
- Using the device for any other purpose invalidates the warranty.
- Only use the device in the proper place, that is, around eyes (or alternatively at any of the other parts of the body, as described in the instruction manual).
- Never use the device while driving a vehicle or operating a machine.
- Never put the device down next to an electric stove or other sources of heat.
- Do not allow the eye massager to come into contact with pointed or sharp objects.

### After operating the device

- Do not overcharge. Charge the device for 4 hours maximum to prevent overcharging.

## Troubleshooting

Problem	Possible cause/Remedy
Device cannot be switched on.	<p><b>The device might be out of battery.</b> Please charge the device.</p> <p><b>You just tapped the on/off button.</b> Please press the on/off button for 1.5 seconds to turn on the device.</p>
Device cannot be charged.	<p><b>You might have used your other charging cable.</b> Please use the provided charging cable only.</p> <p><b>You might have used a charger with a voltage higher than 5V.</b> Please use the provided charging cable only.</p>
Low massage intensity or weak air pressure.	<p><b>The battery is low.</b> Charge the eye massager.</p> <p><b>Soft pressure is selected.</b> The default air massage intensity is soft pressure. Please press the air compression button to switch the intensity to medium pressure or strong pressure.</p>

No air pressure.	<p><b>Heat only mode or heat plus music mode is selected.</b> Select the modes with air pressure function.</p> <p><b>"No pressure" is selected.</b> Press the air massage button to choose "soft pressure", "medium pressure" or "strong pressure" as you need.</p>
A weak mechanical or air sound while massaging.	<p><b>It is normal sound of air inflation or air pressure.</b> No need to do anything.</p>
Bluetooth fails to be connected.	<p><b>The eye massager is off.</b> Please turn on the eye massager and then connect to Bluetooth.</p> <p><b>Bluetooth on your mobile device is not enabled.</b> Please enable Bluetooth on your mobile device and connect to "medisana eye massager".</p>
Low heat or no heat	<p><b>The eye massager is connected to another mobile device automatically.</b> The eye massager might have connected to the latest Bluetooth automatically within 10 meters. Please ensure the latest device is fully disconnected or unpaired. Then search "medisana eye massager" Bluetooth and connect to it.</p> <p><b>"No temperature" mode is selected.</b> Please press the heat button to select the heat level of "high heat" or "low heat".</p> <p><b>The eye massager needs time to warm up.</b> Please wait patiently for 2 minutes after powering on.</p>
Music sounds weak.	<p><b>The music volume might be at low levels.</b> Please press the music button to switch the volume level to higher volume. The default volume is at level 3. Please note that the volume switches in a loop of level 3→level 4→level 5→no volume→level 1→level 2→level 3.</p> <p><b>The sound volume of your mobile device might be quite low.</b> Please turn up the volume on your mobile device when Bluetooth connected.</p>
