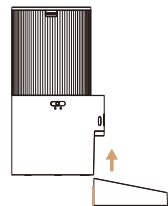


Instructions for Use

1. Open the grain storage bucket and take out the food bowl base and the stainless steel bowl. (After taking them out, clean the grain storage bucket and the stainless steel bowl.)

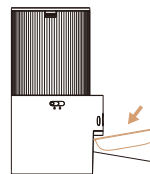


2. Installation Steps
(Please place the device in an appropriate position.)



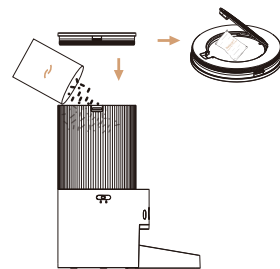
1. Install the food bowl base

Slide the food bowl base upwards along the track.



2. Place the stainless steel food bowl

Tilt the bowl at approximately 30° and pass it under the grain outlet.



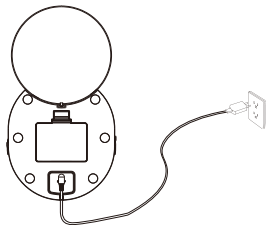
3. Add cat food and install the desiccant

The diameter of the cat food should not be greater than 18 mm.

3. Place it in an appropriate position.

- Place the device on a stable surface and keep it horizontally positioned. Do not tip over the device, otherwise it will lead to abnormal operation.
- Do not place any objects within 15 cm to the left or right in front of the device and within 30 cm in front of it. If objects are placed too close to the device, it will easily interfere with the sensors and affect the recognition of the cat's eating behavior.

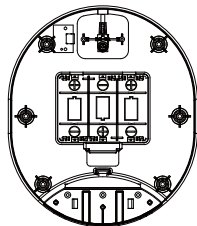
4. Power on and connect the device.

5. Battery-powered mode

- Open the battery cover and insert three No. 2 alkaline batteries into the battery compartment (please pay attention to the positive and negative poles).



- ▶ The batteries need to be purchased by yourself.
- ▶ When the machine is only powered by batteries, remote operation is not supported temporarily.
- ▶ When the device is used while being plugged in, if there are usable batteries installed in the battery compartment, after the power is cut off while it is plugged in, the device will automatically switch to battery power supply and continue to operate normally.

Function Description

1. Set the food dispensing plan (set via the app) – The device can hold cat food with a size within 18 mm at most.

Users can set it according to the feeding situation at home. The app will display the data of "actual/planned". Users can also operate the device to "pause the next planned food dispensing" and "dispense food immediately" according to the feeding situation on the same day.

2. Desiccant replacement reminder and countdown monitoring

The device will automatically conduct a countdown for the usage time of the desiccant based on the time when the desiccant is activated. The app will show the progress of desiccant usage and send reminders. When the desiccant expires, the app will give a reminder, and the indicator light on the device will also flash red to indicate expiration and remind users to replace the desiccant.

3. Feeding data monitoring

The device is equipped with an infrared sensor. After the cat approaches and eats, the device will record the number of times and the duration of eating and display them in the app. Users can check the feeding activities and data comparison of the cat through the app.

4. Grain storage bucket remaining amount detection

The device host has a remaining amount monitoring function. When there is a shortage of cat food, the device and the app will send reminders. Please add cat food in a timely manner.

5. Do-not-disturb setting

In the app, you can set to turn off the device's indicator light or sound for a fixed period of time. However, when the device is abnormal, the indicator light will still give reminders.

6. Child lock setting

In the app, you can turn the child lock of the device on and off to avoid accidental operations by children.

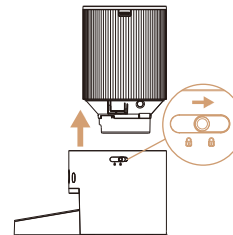

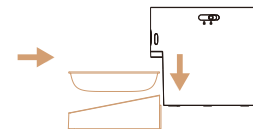
Cleaning and Maintenance

1. Disassembly of the Feeder

*Disassemble and assemble the grain storage bucket in the following order.
(Since silicone is difficult to dry, it is recommended to wipe it with a wet wipe instead of washing it with water.)



Step 1: Push the buttons on both sides to "🔓" and then remove the grain storage bucket.



Step 2: Take off the food bowl base and the food bowl.



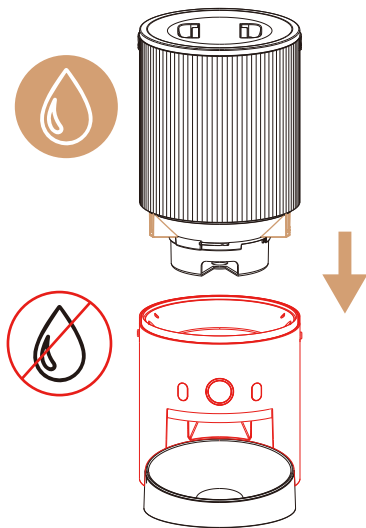
Step 3: Rotate counterclockwise to remove the food dispensing module.

2.The components of the grain storage bucket can be cleaned and maintained all over, while the base of the main unit can only be wiped clean. Water washing and soaking are prohibited!

*It is recommended to clean the components of the grain storage bucket at least once every about 30 days. Usually, you can just add more food when there is a reminder indicating a shortage of food.

*Both the plastic food bowl and the stainless steel food bowl can be disassembled and washed with water. Please put them back to the main unit after they are completely dried.

*It is okay to use a neutral cleaning solution for cleaning, but please avoid cleaning solutions containing alcohol or chemical reagents, as they may corrode the product.



The main body is strictly prohibited from being washed with water!

Frequently Asked Questions

Q: The device doesn't light up or give any indication when plugged in.

A: Power it on again. If there is still no response, please contact customer service.

Q: How much cat food can the grain storage bucket hold?

A: The capacity of the grain storage bucket is about 4 liters, which can hold a common 2-kilogram bag of cat food.

Q: When using freeze-dried treats and cat food together, how can I ensure an even dispensing of food?

A: You can put the freeze-dried treats at the bottom first and then put the cat food on top. This can improve the mixing effect of the freeze-dried treats and the cat food.

Q: What should I do if the device gets jammed while dispensing food?

A: The device supports freeze-dried treats with a maximum size within 18 mm. However, due to the size deviation in the production of freeze-dried treats, there may be a small probability of food jamming. If the device gets jammed while dispensing food, try gently tapping or shaking the device to unjam it.
