




# QUICK START GUIDE

## 1. Setting up your Digital Video Baby Monitor

### A. Connecting the Power Supply for the Camera Unit



- Insert the DC plug of the power adapter into the power socket on the back of the Camera Unit.
- Connect the other end of the power adapter to mains power.
- The Green power indicator lights when the camera unit is on.


**Note:**

Only use the supplied power adapter (DC5V / 1A).

### ⚠ WARNING:

Strangulation hazard. Children have STRANGLED on cords. Keep this cord out of the reach of children (more than 1 metre away). Never use extension cords with AC Adapters. Only use the AC Adapters provided.


7. DC Power Socket

\* Tilt the camera head up to reach the Micro-SD card slot.


## 3. Setting up the Camera Unit For Wi-Fi® internet viewing

### A. Install HubbleClub by Hubble Connected App.



- Scan the QR code with your smart device and download HubbleClub by Hubble Connected App from the App Store for iOS devices or from the Google Play™ Store for Android™ devices.
- Install HubbleClub by Hubble Connected App on your device.

### B. View on Compatible Smartphones and Tablets.



1. Open the HubbleClub by Hubble Connected App on your compatible smartphone or tablet.

2. Follow the in-app instructions to create your Hubble account and connect to your device.

#### What Does this Limited Warranty Cover?

Subject to the items listed below in the section "What is not Covered" HUBLE warrants that this Hubble connected branded product ("Product") will be free from defects in material and workmanship under normal use for a period of 2 years from the date of purchase and that any certified accessory ("Accessory") sold for use with this product will be free from defects in materials and workmanship under normal use for a period of 90-days from the date of purchase. This Limited Warranty is your exclusive warranty and is not transferable.

#### What is not covered?

This Limited Warranty excludes and does not cover:
