This device is mobile device, and the applicant declares that the minimum separation distance is greater than 20cm. Therefore, MPE measurement or computational modelling should be used to determine compliance.

Antenna Gain: -1.09 dBi for Bluetooth & 2.4GHz Wi-Fi, -1.12dBi for 2.4GHz.

**d) Simultaneous transmission MPE**

Per KDB 447498 D01 v06, simultaneous transmission MPE test exclusion applies when the sum of the MPE ratios for all simultaneous transmitting antennas incorporated in a host device, based on calculated or measured field strengths or power density, is  $\leq 1.0$ .

The product has multiple transmitters, the Simultaneous Transmission possibilities are listing below:

As the sum of MPE ratios for all simultaneous transmitting antennas is  $\leq 1.0$ , simultaneous transmission MPE test exclusion will be applied.

**e) Conclusion**

Therefore the maximum calculations result of above are meet the requirement of Radio Frequency Exposure (MPE) limit.

### 3.1.1.2 RSS-102 Exemption Limits for Routine Evaluation – RF Exposure Evaluation

The EUT shall comply with the requirement of RSS-102 section 6.6.

#### Exemption from Routine Evaluation Limits – RF Exposure Evaluation

RF exposure evaluation is required if the separation distance between the user and/or bystander and the device's radiating element is greater than 20 cm, except when the device operates as follows:

at or above 300 MHz and below 6 GHz and the source-based, time-averaged maximum e.i.r.p. of the device is equal to or less than  $1.31 \times 10^{-2} f^{0.6834}$  W (adjusted for tune-up tolerance), where  $f$  is in MHz;

In these cases, the information contained in the RF exposure technical brief may be limited to information that demonstrates how the e.i.r.p. was derived.

Both e.i.r.p. for Bluetooth & Wi-Fi & 2.4GHz are less than the RF exposure evaluation exempted power. So RF exposure evaluation is not required.
