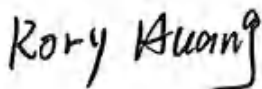

5. TEST RESULTS

5.1. Evaluation Results (Evaluation)

5.1.1. Antenna Requirement

Test Requirement:

Refer to 47 CFR Part 15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section.

The EUT antenna is PCB(2.54dBi), the directional gain of the antenna less than 6dBi. It comply with the standard requirement. In case of replacement of broken antenna the same antenna type must be used. Antenna structure please refer to the EUT internal photographs antenna photo.

Test Method:	ANSI C63.10-2020 section 6.2		
Procedure:	1. The EUT was setup according to ANSI C63.10 requirements. 2. The EUT was placed on a platform of nominal size, 1 m by 1.5 m, raised 80 cm above the conducting ground plane. The vertical conducting plane was located 40 cm to the rear of the EUT. All other surfaces of EUT were at least 80 cm from any other grounded conducting surface. 3. The EUT and simulators are connected to the main power through a line impedances stabilization network (LISN). The LISN provides a 50 ohm /50uH coupling impedance for the measuring equipment. 4. The peripheral devices are also connected to the main power through a LISN. (Refer to the block diagram of the test setup and photographs) 5. Each current-carrying conductor of the EUT power cord, except the ground (safety) conductor, was individually connected through a LISN to the input power source. 6. The excess length of the power cord between the EUT and the LISN receptacle were folded back and forth at the center of the lead to form a bundle not exceeding 40 cm in length. 7. Conducted emissions were investigated over the frequency range from 0.15MHz to 30MHz using a receiver bandwidth of 9 kHz. 8. During the above scans, the emissions were maximized by cable manipulation.

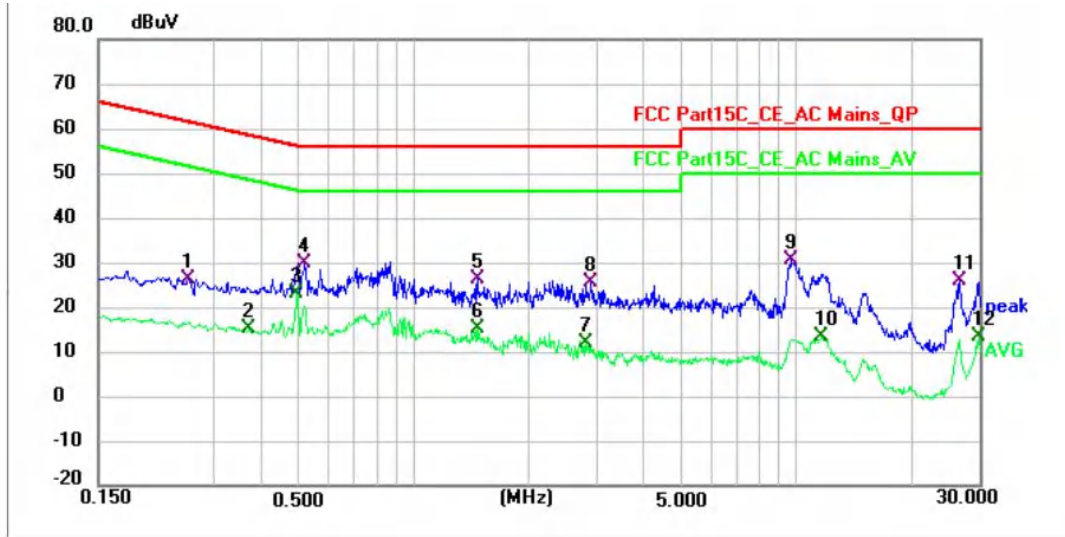

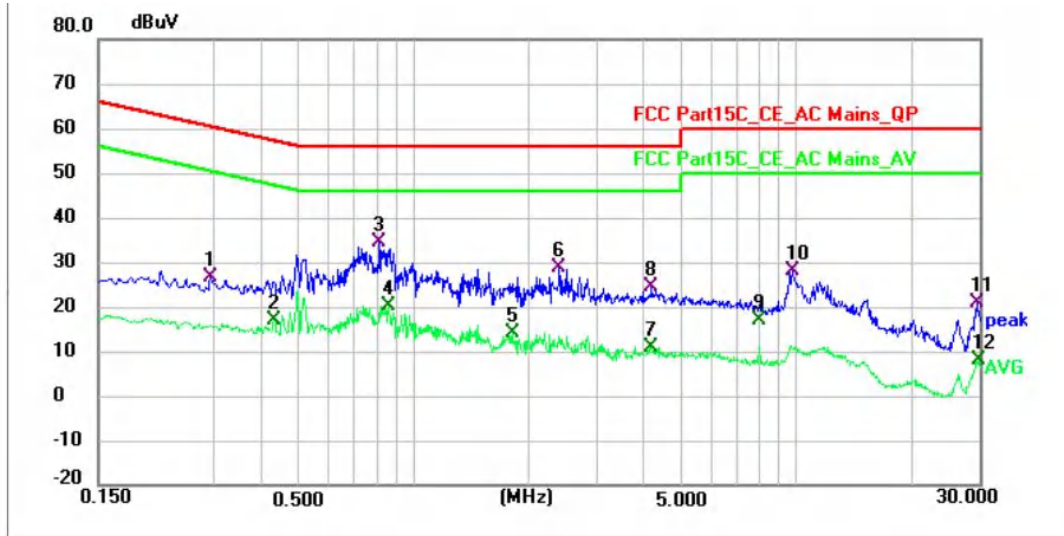

Procedure:	11.8.1 Option 1 The steps for the first option are as follows: - Set RBW = shall be in the range of 1% to 5% of the OBW but not less than 100 kHz. - Set the VBW $\geq [3 \times \text{RBW}]$. - Detector = peak. - Trace mode = max-hold. - Sweep = No faster than coupled (auto) time. - Allow the trace to stabilize. - Measure the maximum width of the emission by placing two markers, one at the lowest frequency and the other at the highest frequency of the envelope of the spectral display, such that each marker is at or slightly below the “-6 dB down amplitude”. Test Limit:	Refer to 47 CFR 15.247(b)(3), For systems using digital modulation in the 902-928 MHz, 2400-2483.5 MHz, and 5725-5850 MHz bands: 1 Watt. As an alternative to a peak power measurement, compliance with the one Watt limit can be based on a measurement of the maximum conducted output power. Maximum Conducted Output Power is defined as the total transmit power delivered to all antennas and antenna elements averaged across all symbols in the signaling alphabet when the transmitter is operating at its maximum power control level. Power must be summed across all antennas and antenna elements. The average must not include any time intervals during which the transmitter is off or is transmitting at a reduced power level. Test Limit:	Refer to 47 CFR 15.247(d), In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. 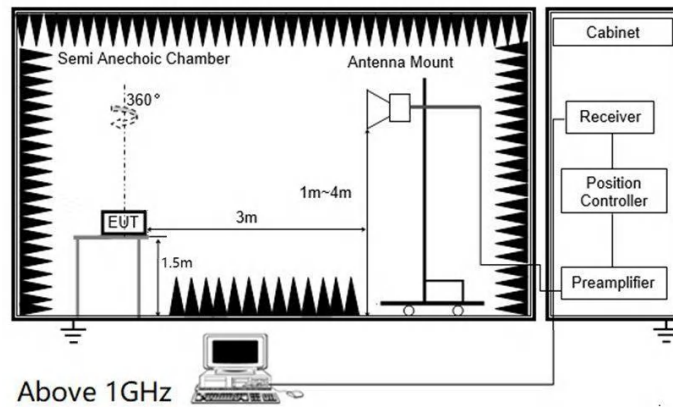

Procedure:	1. EUT was setup and tested according to ANSI C63.10 . 2. The EUT is placed on a turn table which is 1.5 meter above ground. The turn table is rotated 360 degrees to determine the position of the maximum emission level. 3. The EUT was positioned such that the distance from antenna to the EUT was 3 meters. 4. The antenna is scanned from 1 meter to 4 meters to find out the maximum emission level. This is repeated for both horizontal and vertical polarization of the antenna. In order to find the maximum emission, all of the interface cables were manipulated according to ANSI C63.10 on radiated measurement. 5. Use the following spectrum analyzer settings: a) Span shall wide enough to fully capture the emission being measured b) Set RBW=1MHz, VBW=3MHz for >1GHz, Sweep time=auto, Detector=peak, Trace=max hold for Peak measurement For average measurement: use duty cycle correction factor method (DCCF), Averager level = Peak level + DCCF

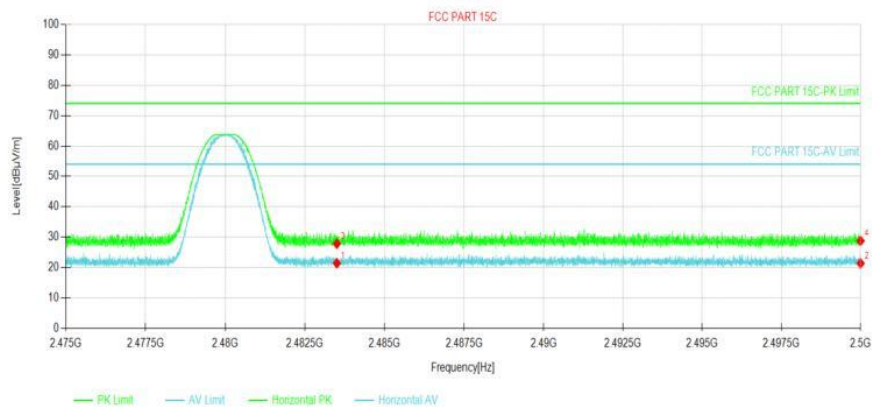

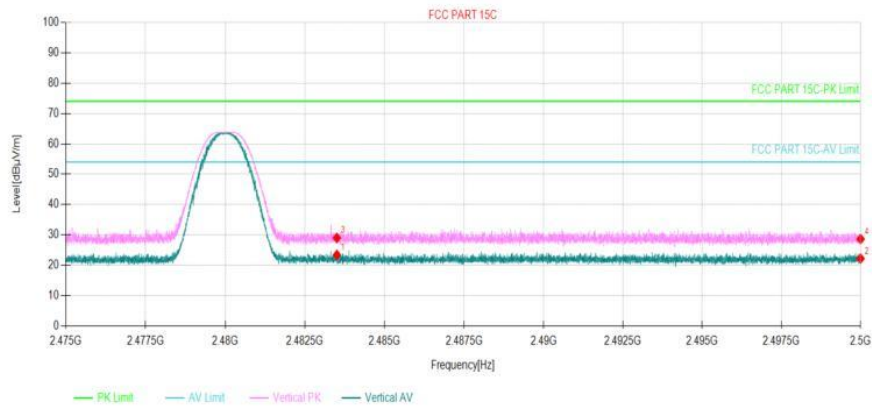

Mode1 / Polarization: Horizontal / CH: L



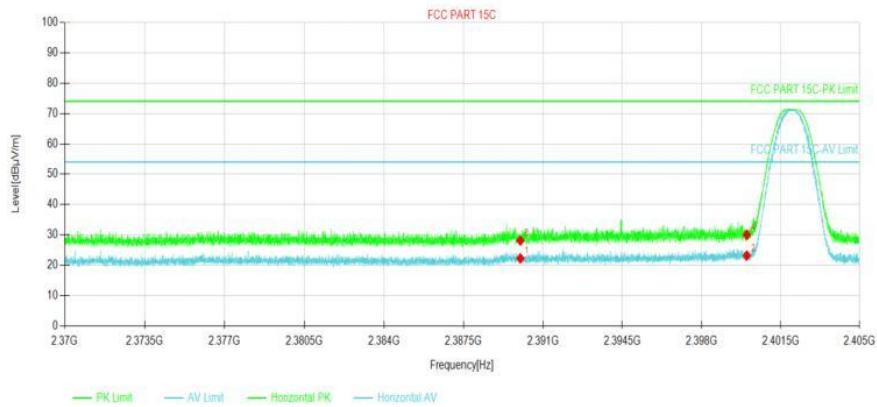

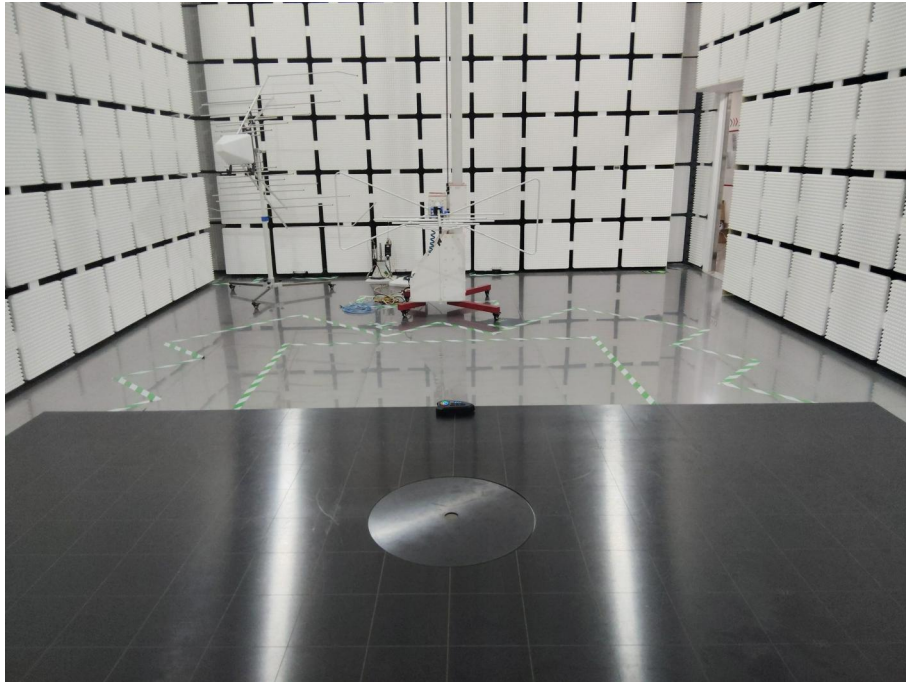
Conducted Emission at AC power line



Radiated Spurious Emission (Above 1GHz)



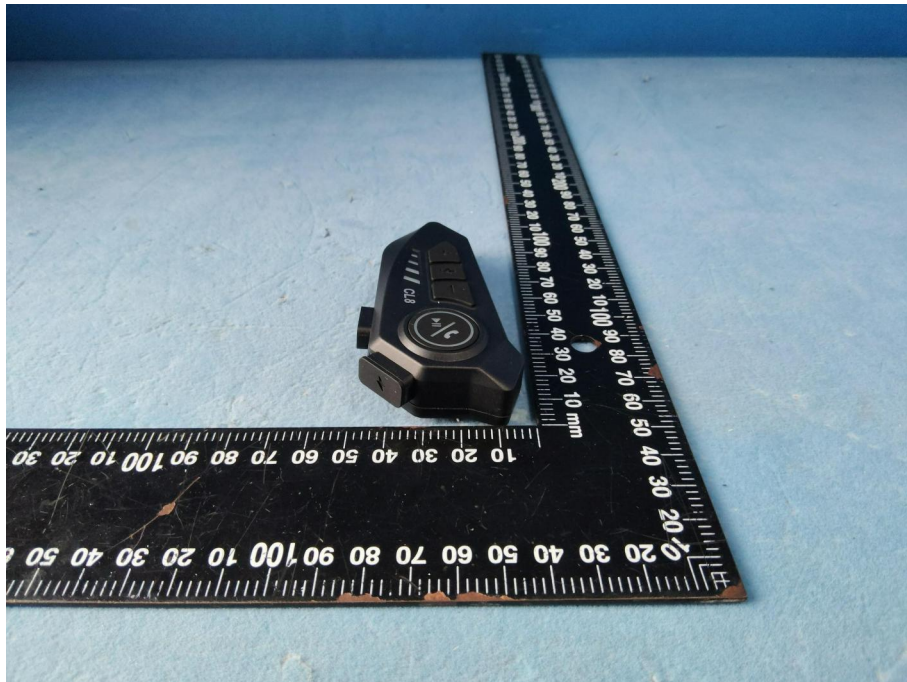
Radiated Spurious Emission (below 1GHz)

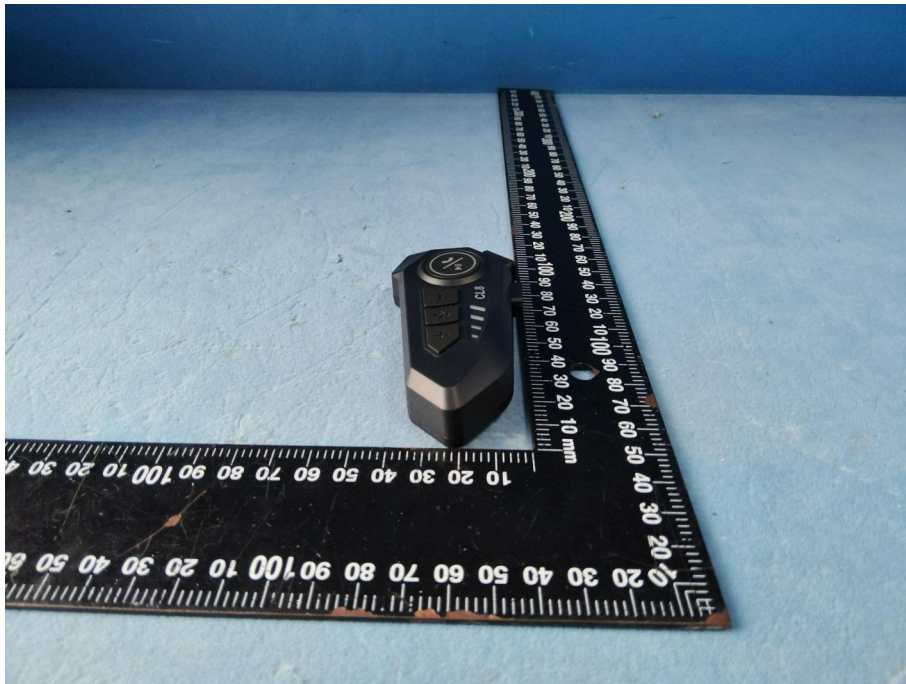
