

The wireless charger comes with a 1m cable, connect the adapter to the power source;2. Put on a mobile phone that supports magnetic suction, and the wireless charging is automatically aligned with the mobile phone and directly magnetically charged;3. When charging, you need to keep the center of the mobile phone aligned with the center of the wireless charger, then wireless charging can be performed. If it cannot work normally, adjust the position of the mobile phone until the mobile phone shows normal charging. 	<p>PRECAUTIONS</p> <ol style="list-style-type: none">1. It is recommended to use a high-power adapter above 20W for better experience.2.
