

User Manual :

- Open the packaging, put the battery of the accessories box into the battery slot at the bottom of the sound (pay attention to the positive and negative poles, one end of the battery perforated piece is positive, into the battery slot marked with + end) and cover the battery cover; Please plug the power line into Power input port to charge the battery, at the same time The red light will come on. Please charge it fully before first use.
- Slide the power switch to the right to start the machine, and the audio system will display the voice prompt (bluetoothMode), and the audio indicator flashes blue (if the charging line is plugged in at this time, red and blue will alternate when chargingFlashing). Use the mobile phone Bluetooth function to search for the audio Bluetooth device and connect it (the device model is F18)Audio. The audio prompt (ding dong sound) indicates that the Bluetooth connection is successful. Open the mobile music player, The stereo can play mobile music through Bluetooth.
- Play songs of U disk/TF card: You can be directly inserted into the U disk to the USB port (or inserted into the TF card to TF port (printed side of TF card is down)), The speaker will automatically switch to play music of the U disk / TF card.
- In the process of playing music (no matter which play mode), press once + to control play/pause, previous song and next song respectively, Long press to increase volume, Long press to decrease volume.
- Stick the silicone on the bracket hook foot according to the requirement.



使用方法 :

- 打开包装，把配件盒里的电池装入音响底部的电池槽内（注意正负极，电池加孔片的一端为正极，装入电池槽标有+的那端）并盖上电池盖；（请插入电源线到音响的充电接口给电池充电，同时红色指示灯亮。首次使用前请充满电。）
- 将电源开关往右滑动开机，音响出现语音配对的语音提示，同时音响指示灯为蓝灯闪烁（如果此时插了充电线充电时就会红蓝交替闪烁）。用手机搜索音响的设备并联接（设备型号为F18）此音响。音响出现语音提示（叮咚声）表示无线连接成功。打开手机音乐播放器，音响就可以通过播放手机音乐了。
- 播放U盘/TF卡：可直接插入U盘到USB接口（或者插入TF卡音响自动播放TF卡音乐（TF卡有印字的一面朝下）），音响将自动切换到播放U盘歌曲/TF卡中的音乐。
- 音乐播放过程中（无论哪种播放模式），按一下 + 可以分别控制播放/暂停、上一曲、下一曲。

音乐播放过程中按住 键音量增大，按住 音量减小。

- 根据需求将硅胶贴到支架勾脚上。
