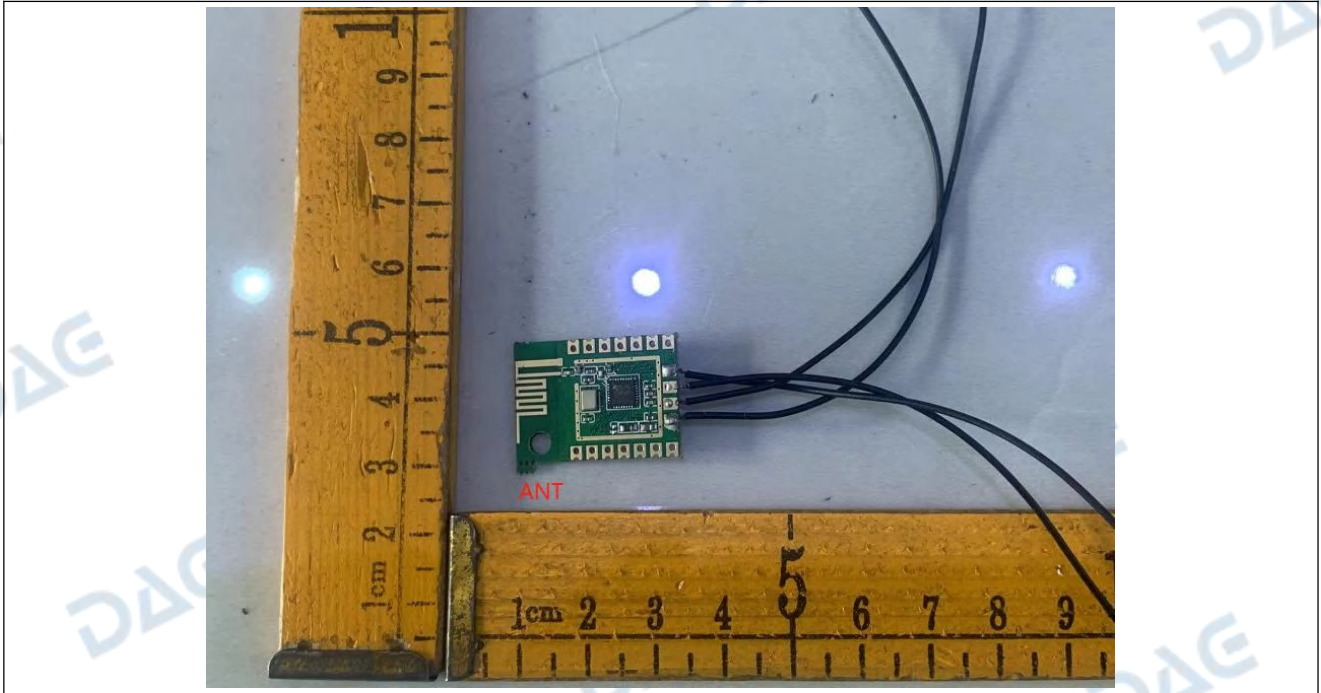

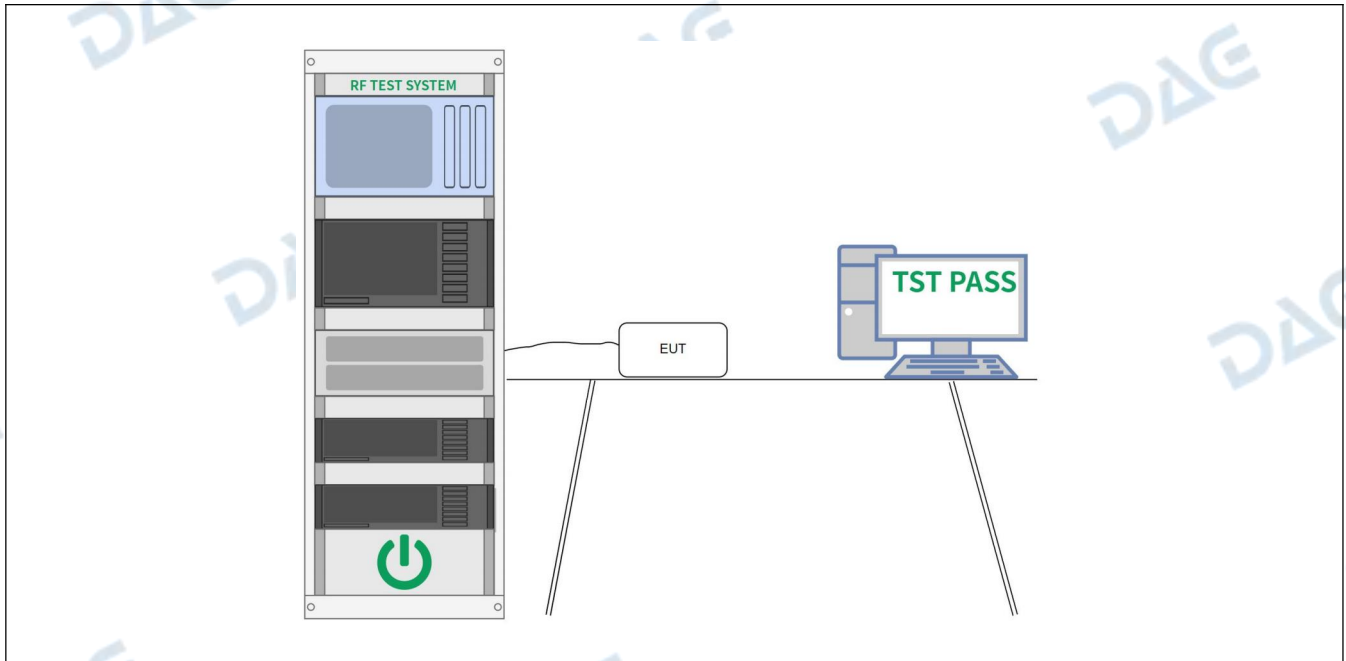

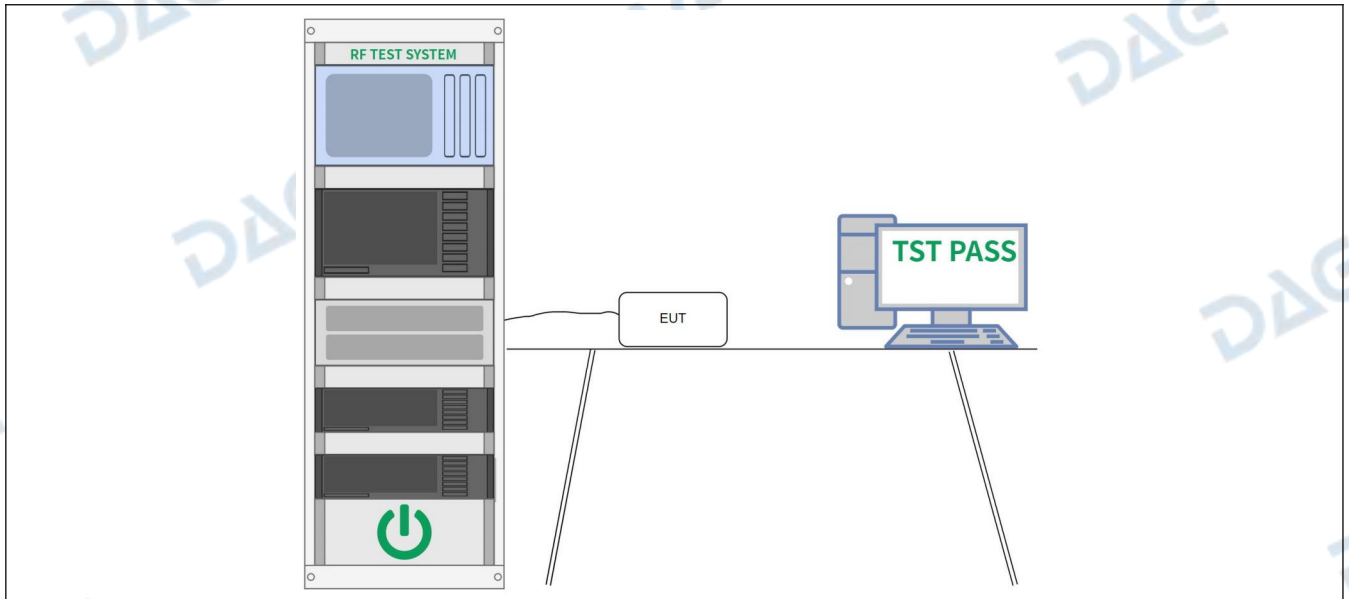
4.2 Maximum Conducted Output Power

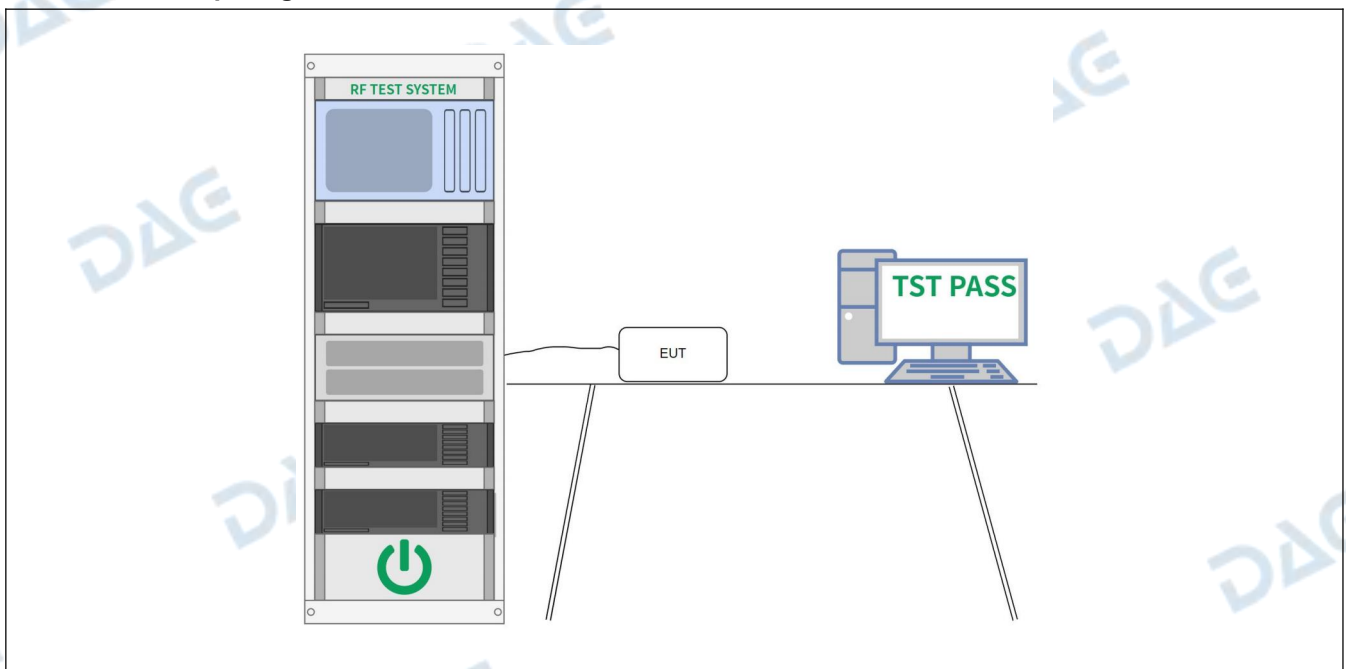

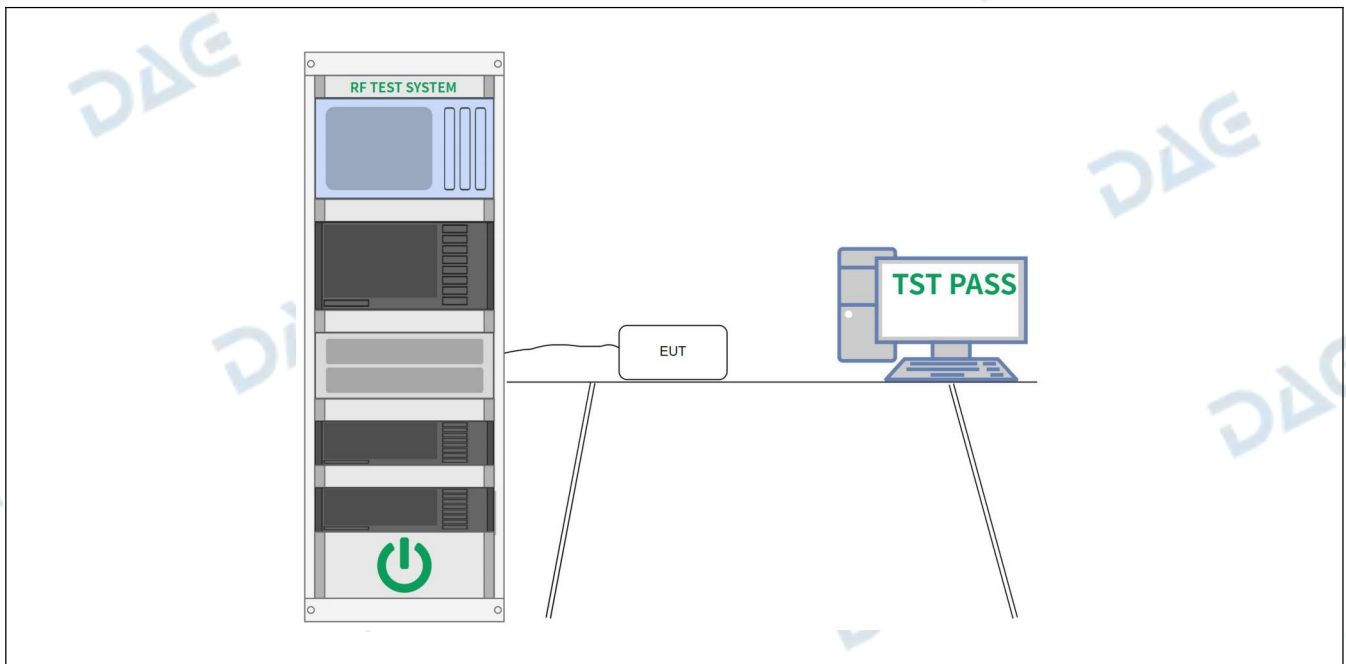
