






1 Bluetooth Connection

- a. Search “BT-Speaker” to connect with Bluetooth
- b. Use smart phone to disconnect Bluetooth with speaker, the speaker will automatically turn into pairing mode



2 Button Function

- a. Long press to turn on/off the Bluetooth speaker
- b. One-click to switch TF card play mode/Bluetooth mode
- c. Double-click to switch light modes, 4 light modes in total




- a. Short press to volume down
- b. Long press to the previous song

- b. Long press to next song


- a. Short press to play/pause music

3 Indicator Light



- a. The indicator Light Flashing while Bluetooth is waiting for pairing.
The indicator light is always on when Bluetooth is connected
- b. The indicator light slowly flashing blue light when is playing.
Indicator light is always on.
- c. The second Bluetooth speaker Indicator light is always on while the TWS mode is successfully connected
- d. The indicator light turns red and is always on while it's charging.
The red light is off when the Bluetooth speaker is fully charged
