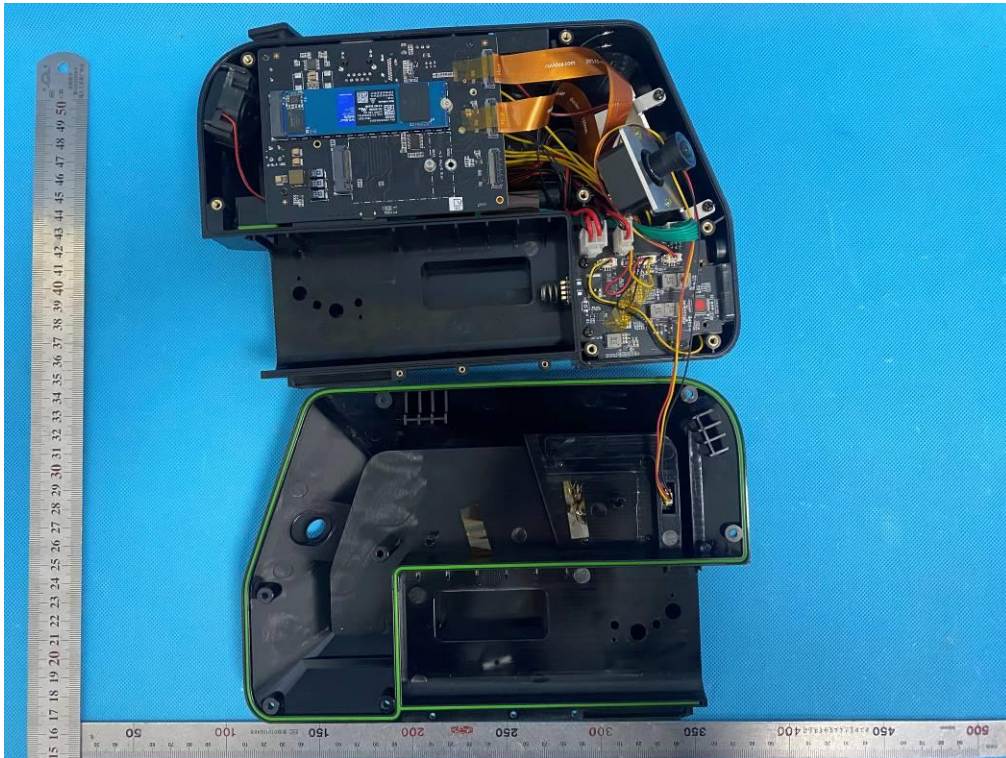


OPEN VIEW OF EUT (FIGURE 2)

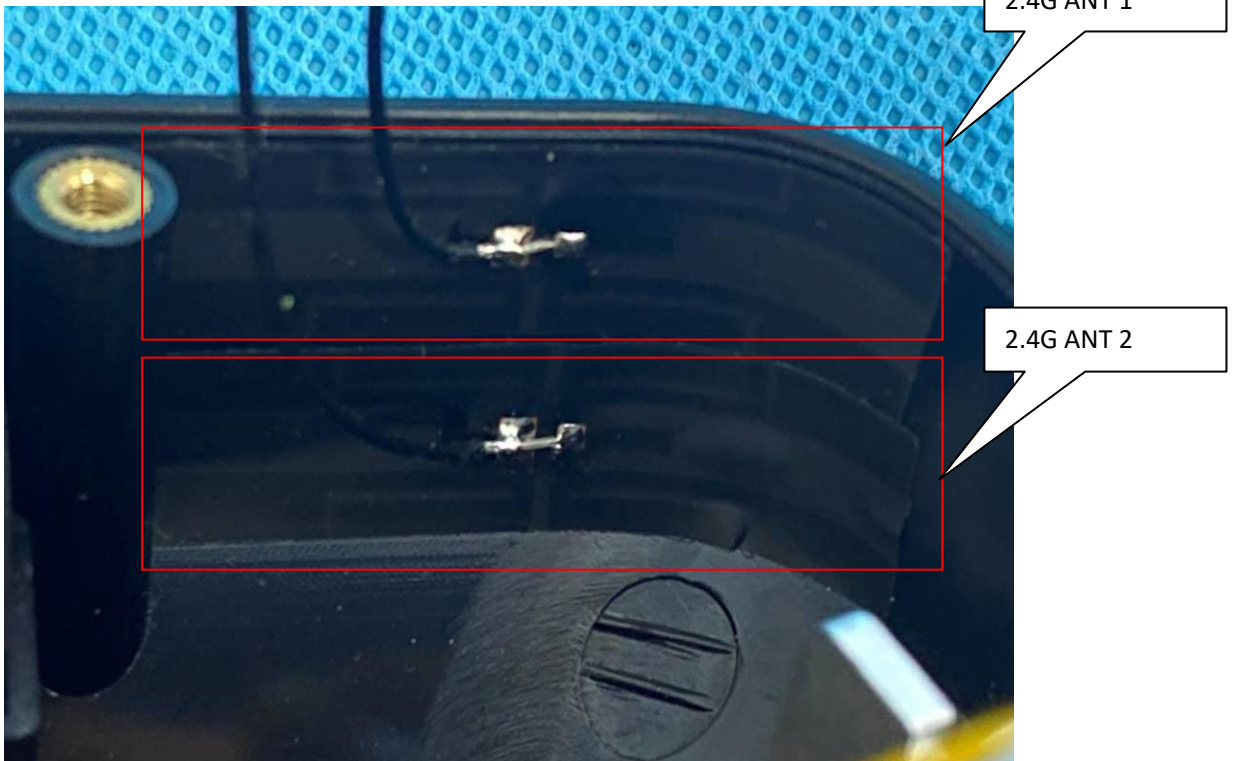

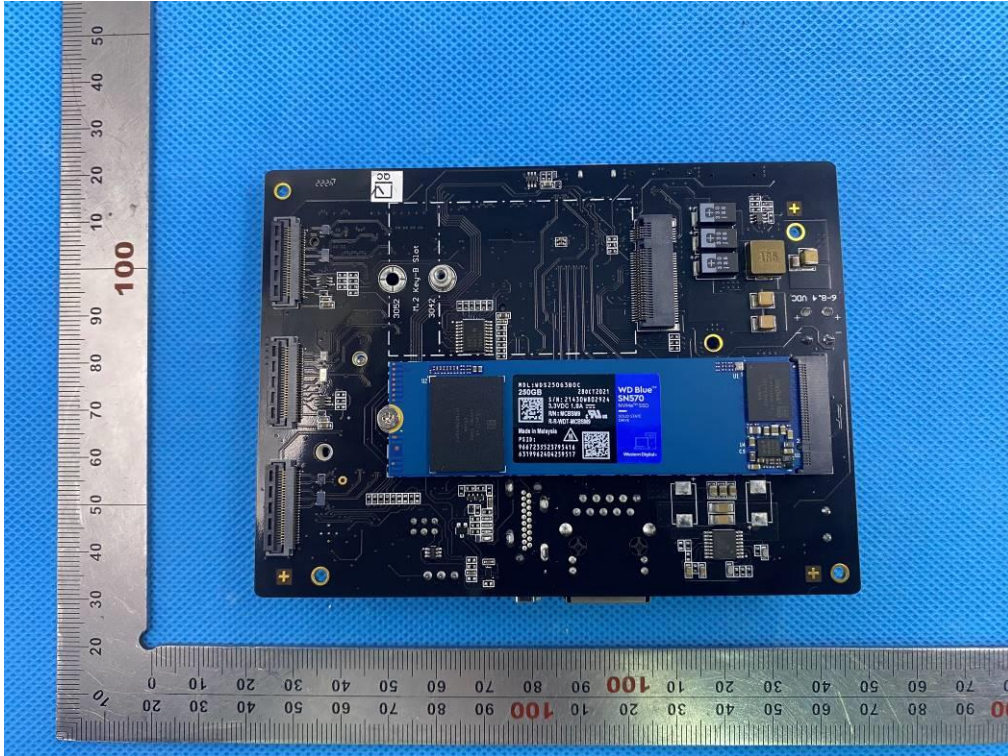

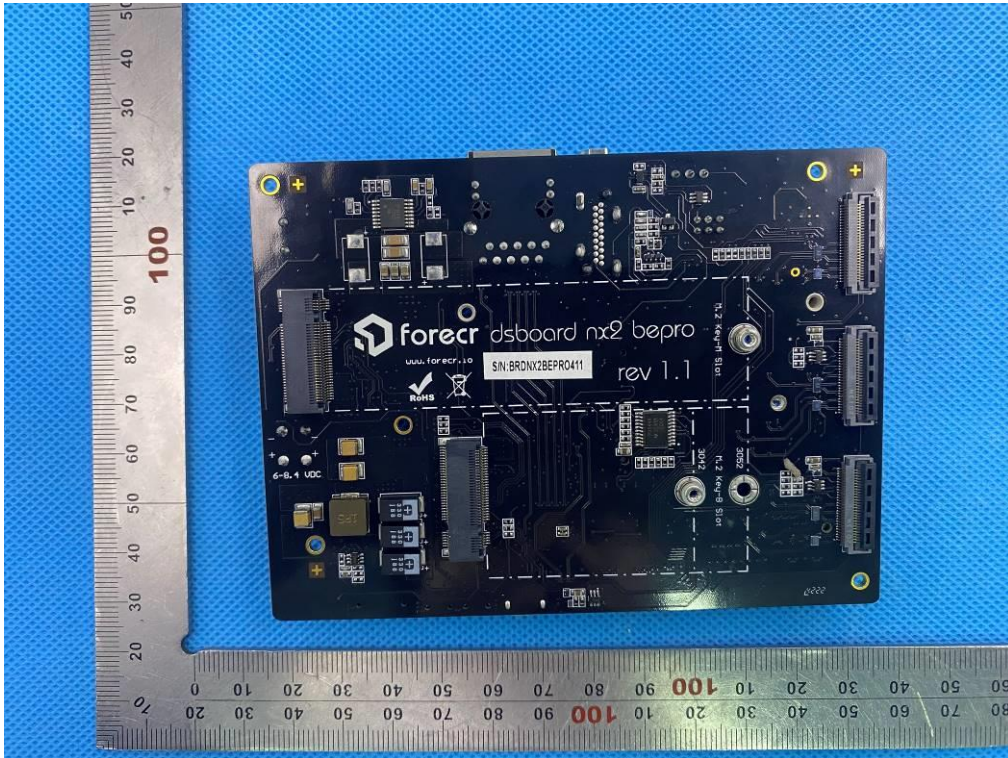

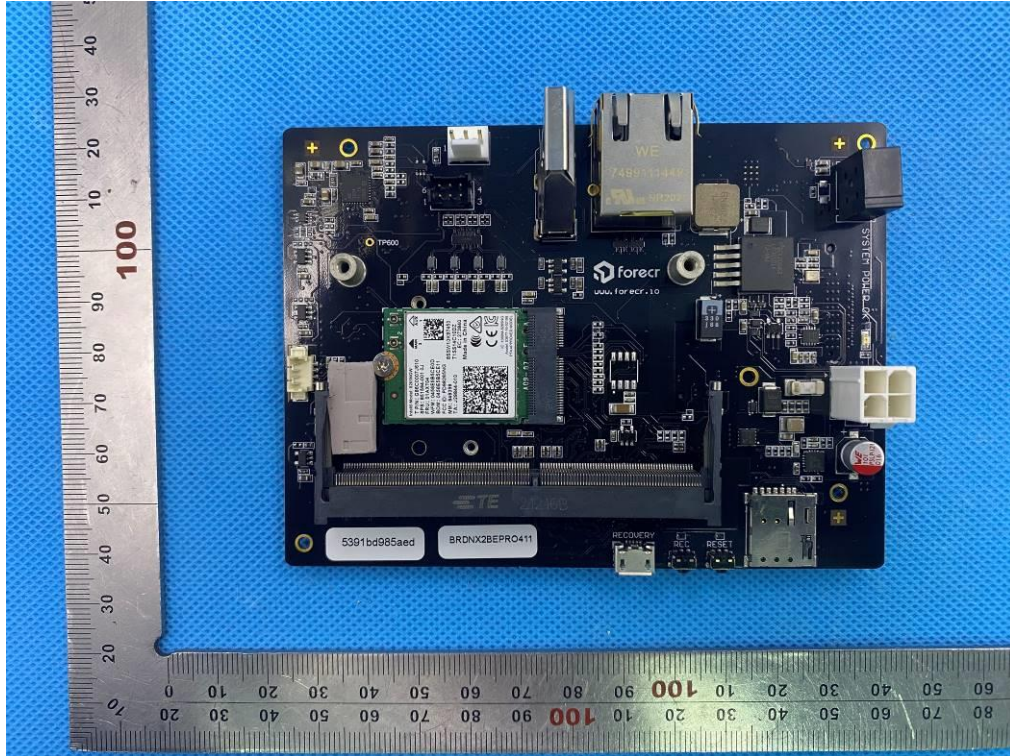

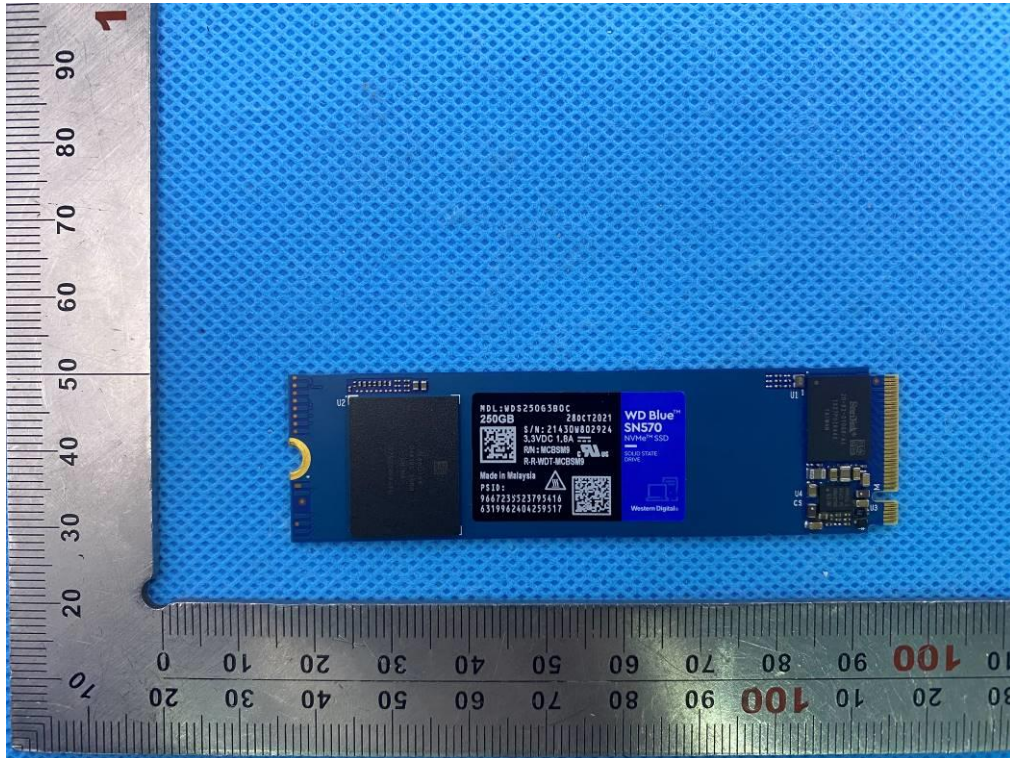

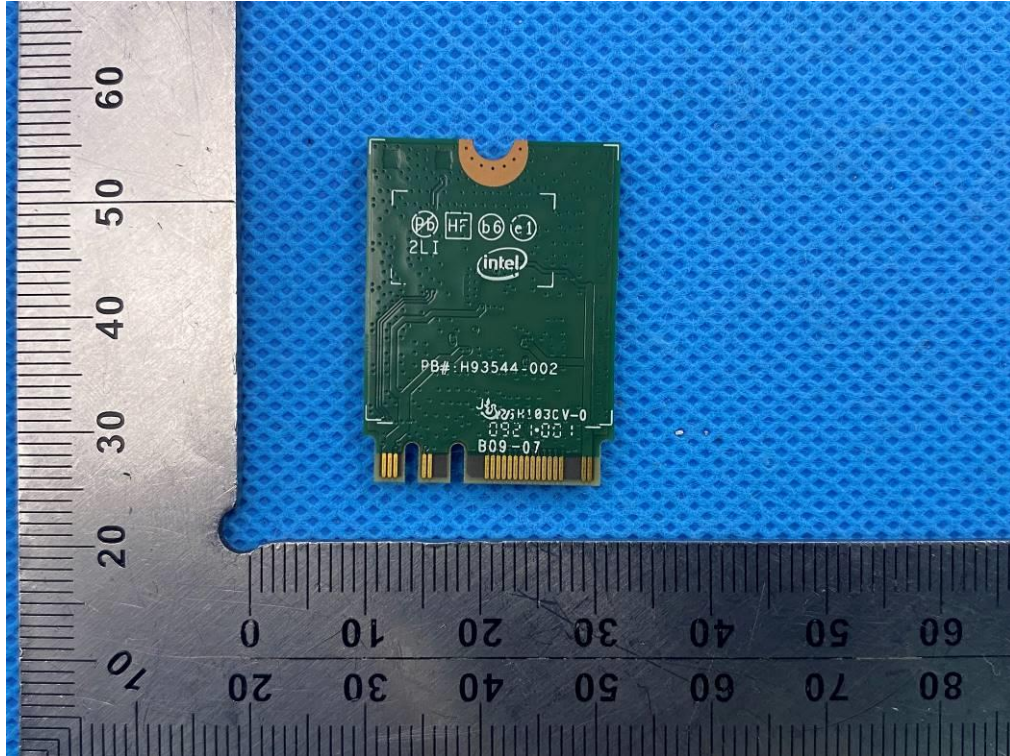


INTERNAL VIEW OF EUT (FIGURE 7)

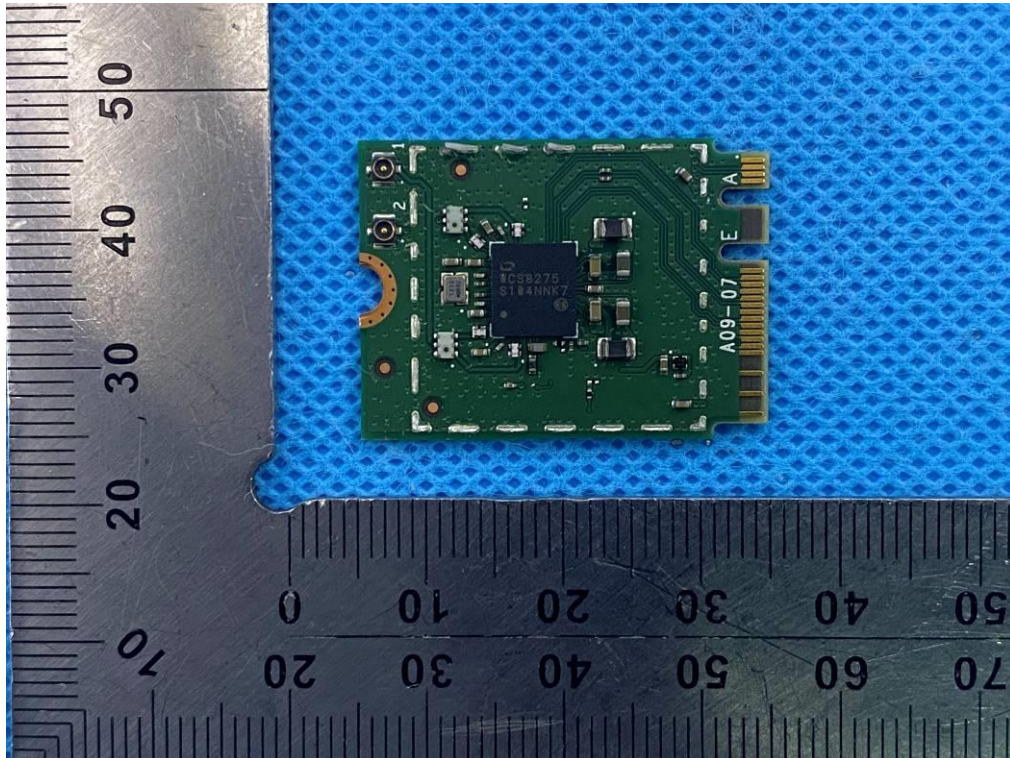


INTERNAL VIEW OF EUT (FIGURE 9)

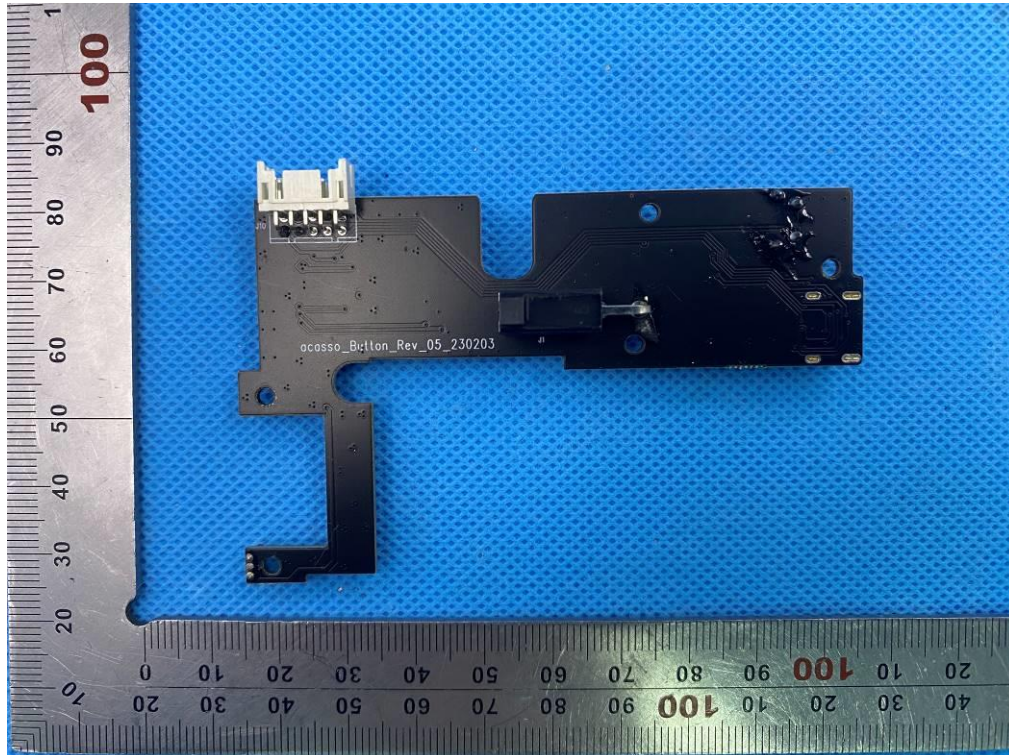


INTERNAL VIEW OF EUT (FIGURE 11)

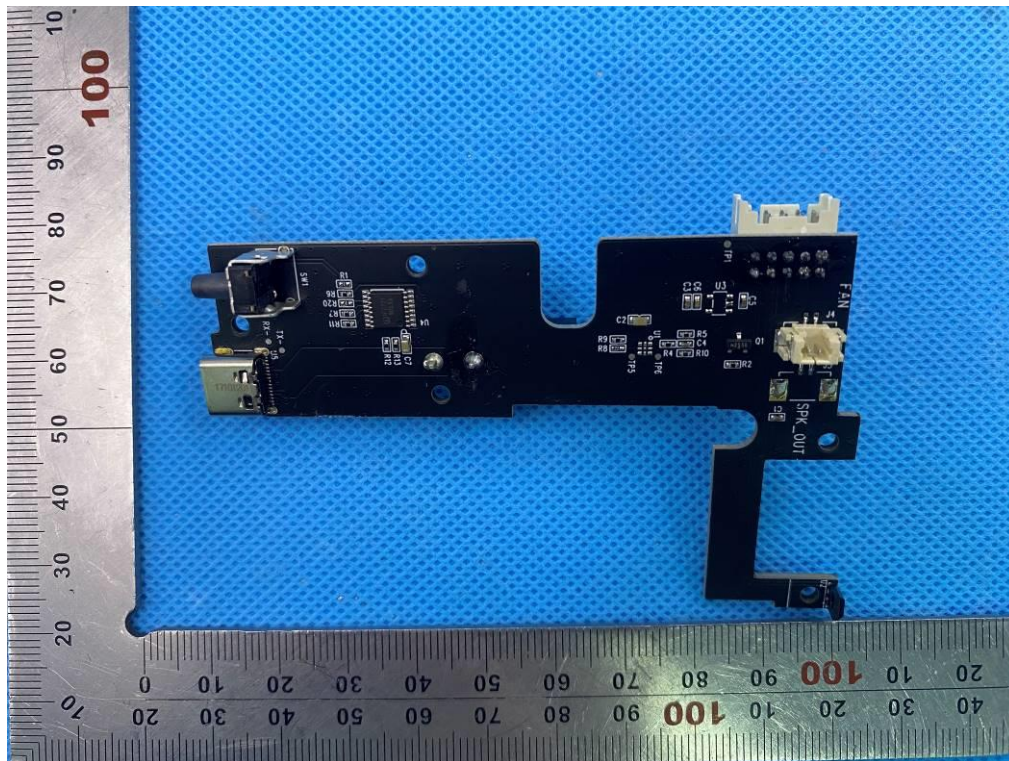

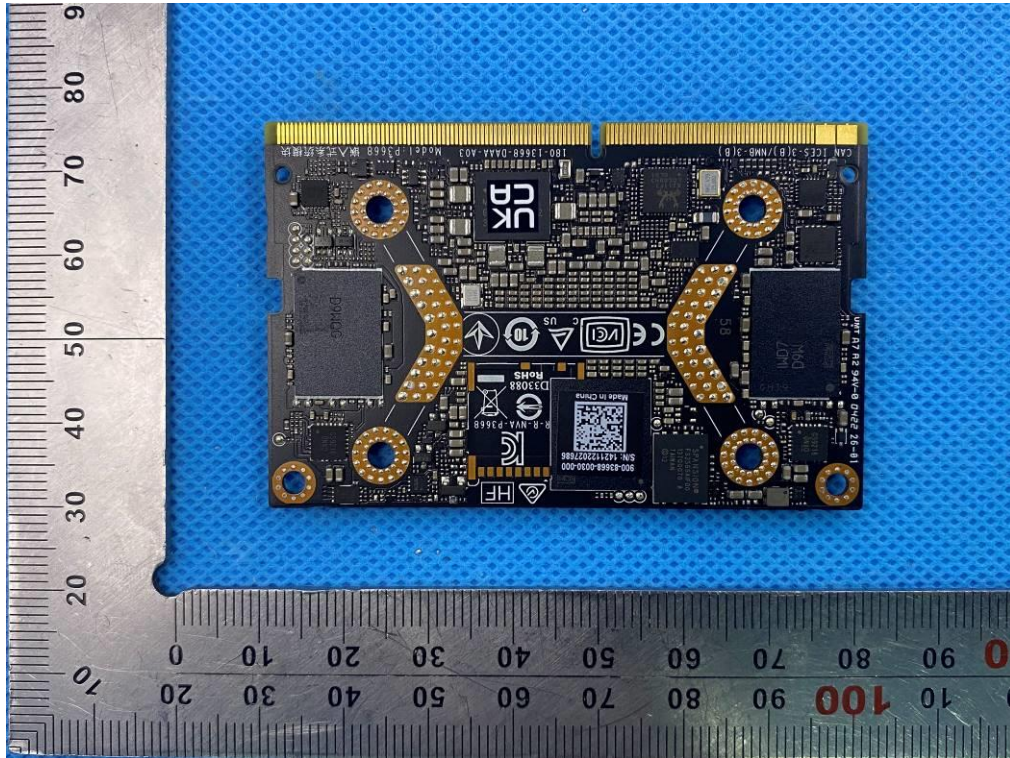


INTERNAL VIEW OF EUT (FIGURE 13)

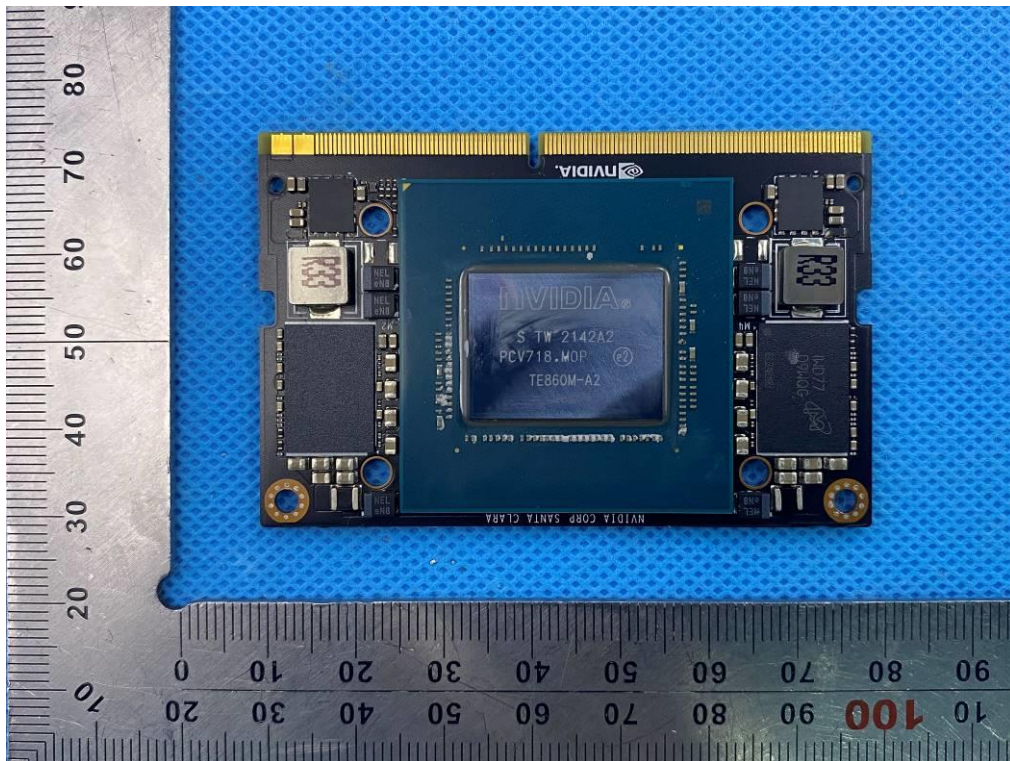

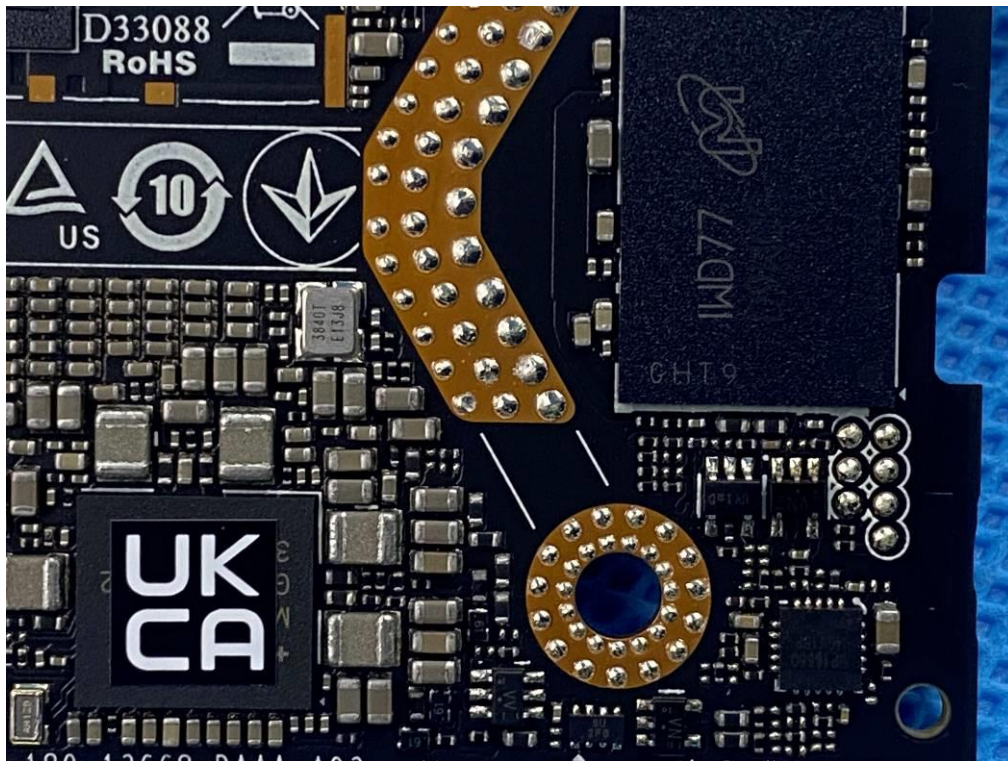

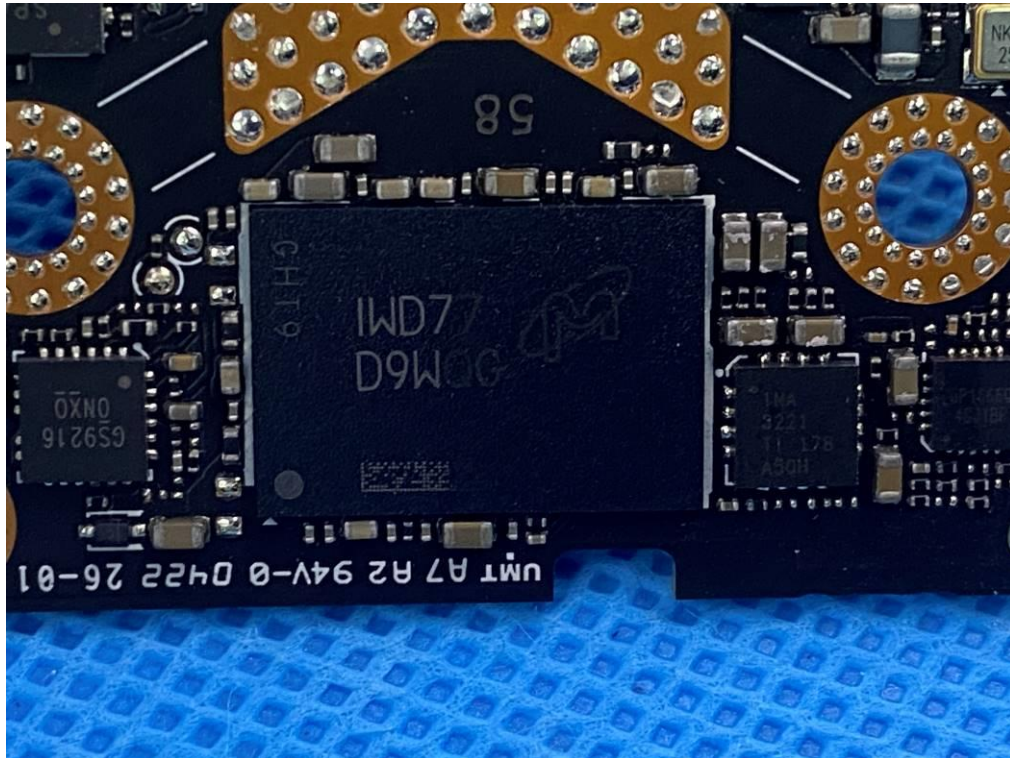


INTERNAL VIEW OF EUT (FIGURE 17)

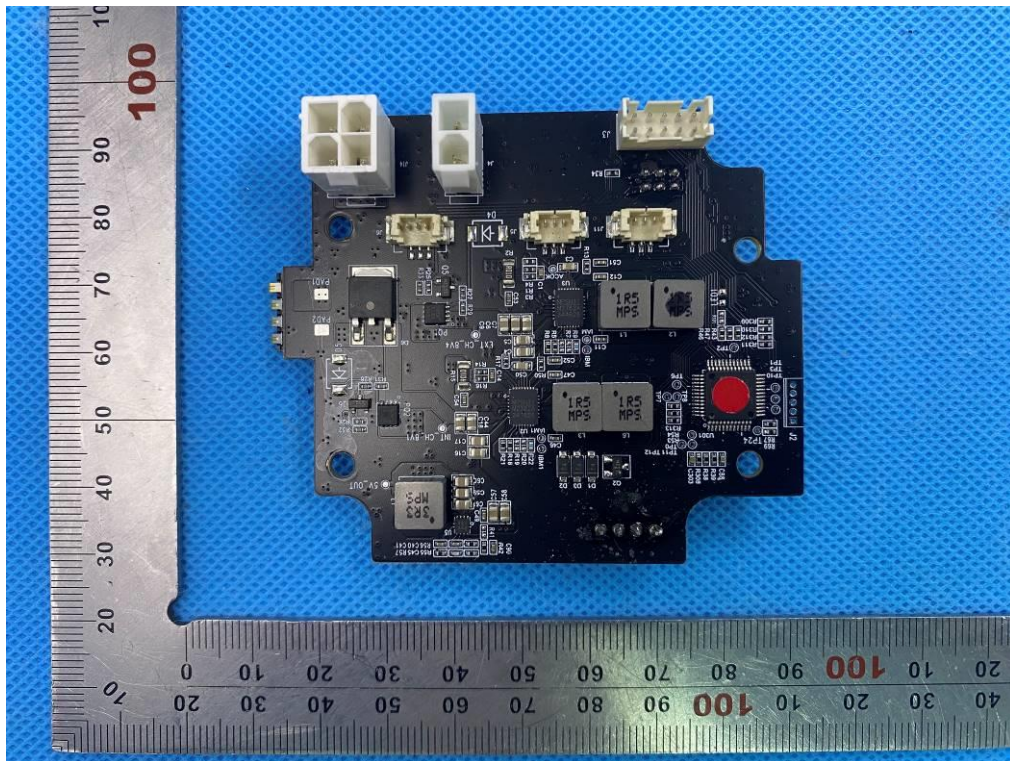

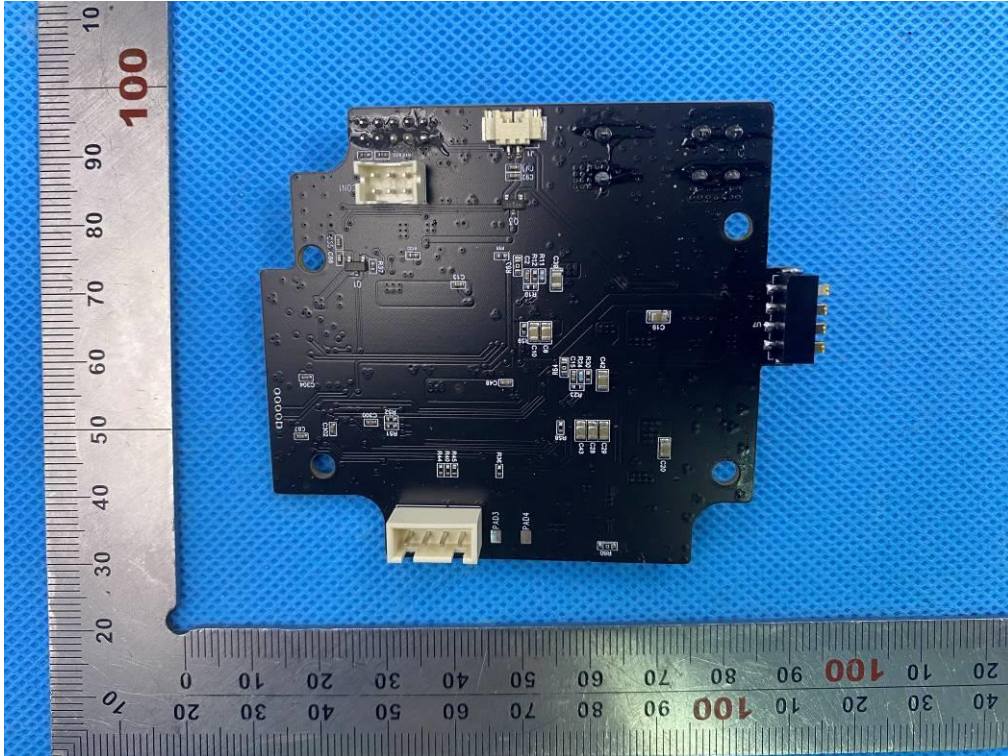


INTERNAL VIEW OF EUT (FIGURE 19)

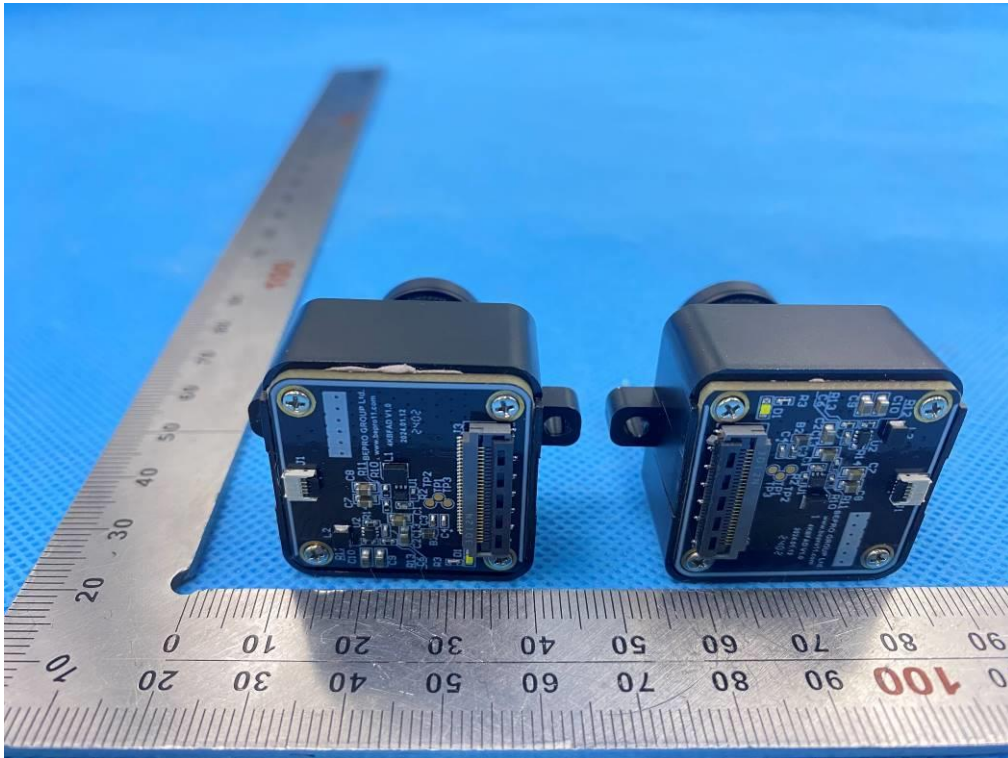

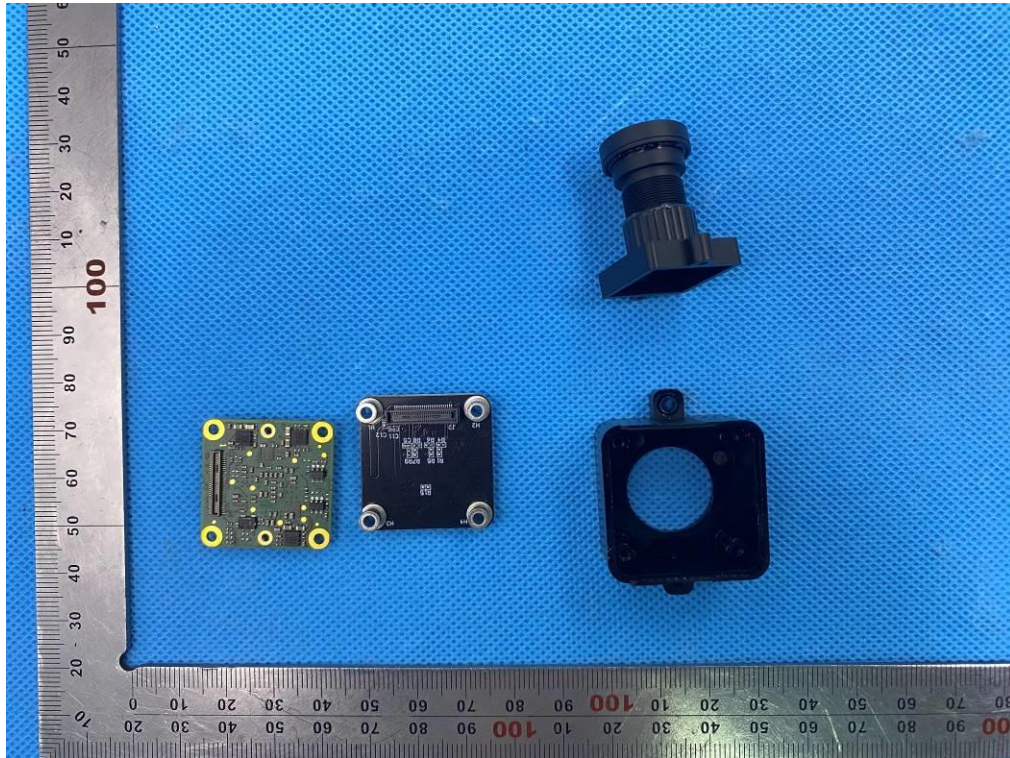


INTERNAL VIEW OF EUT (FIGURE 21)

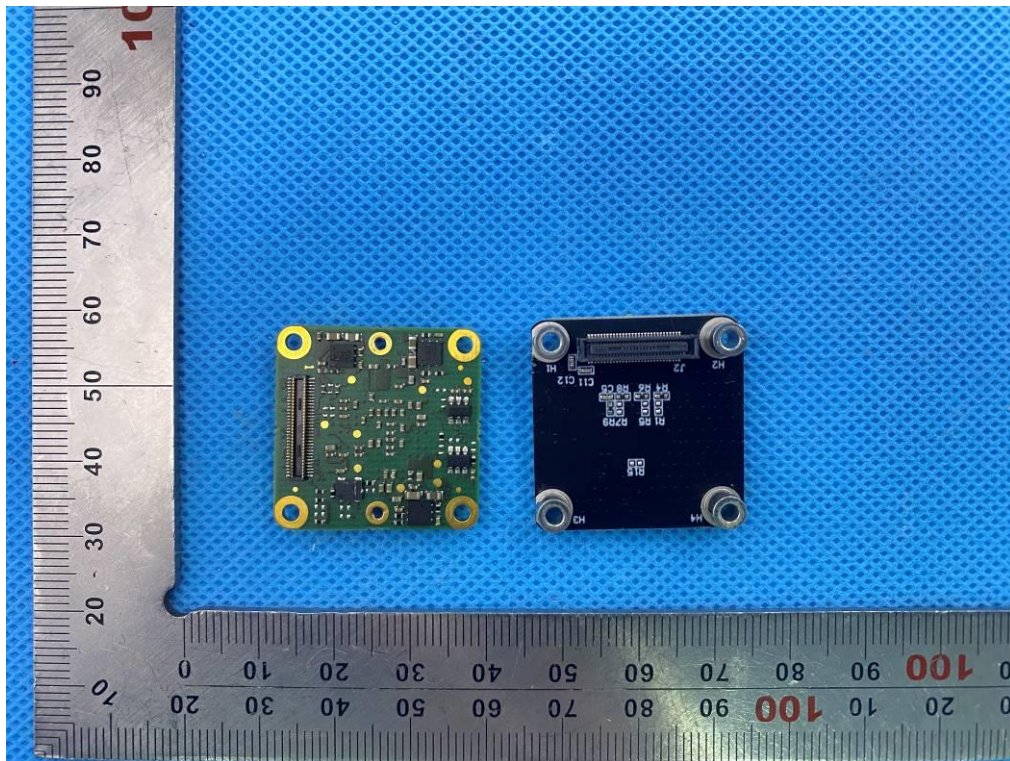

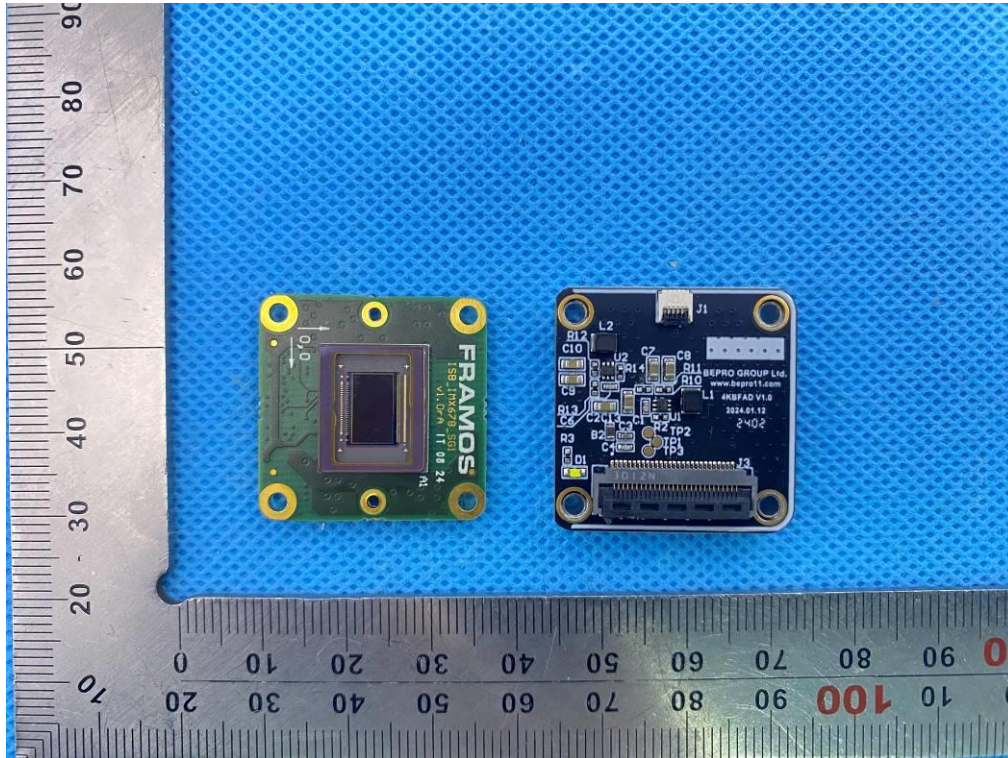

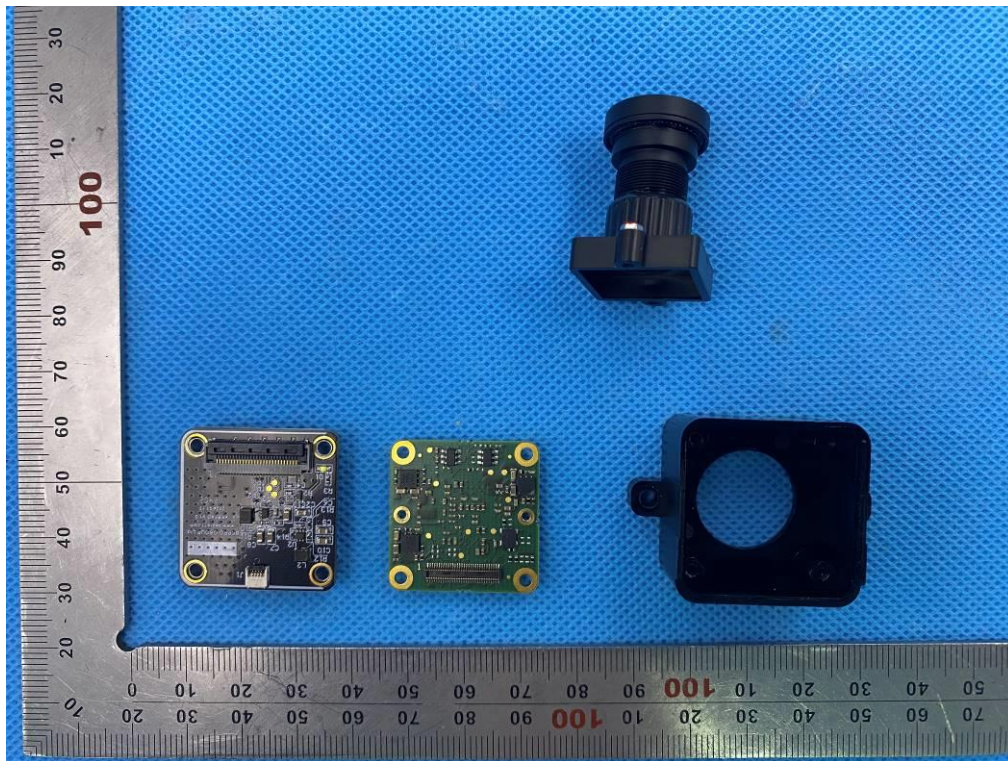

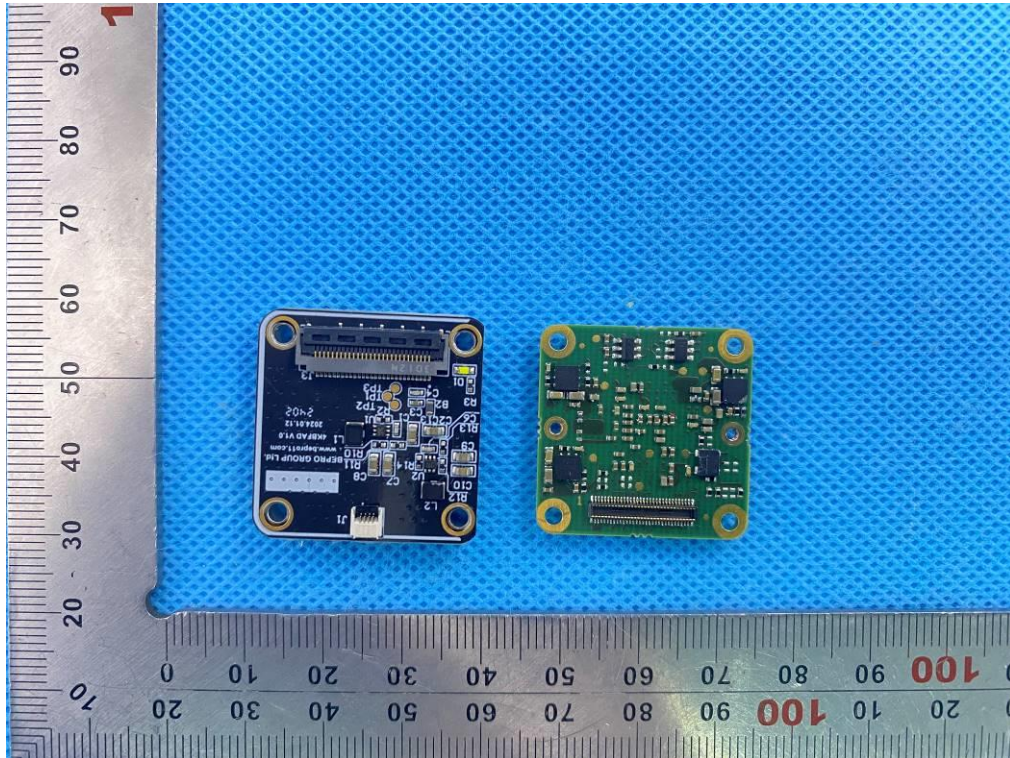

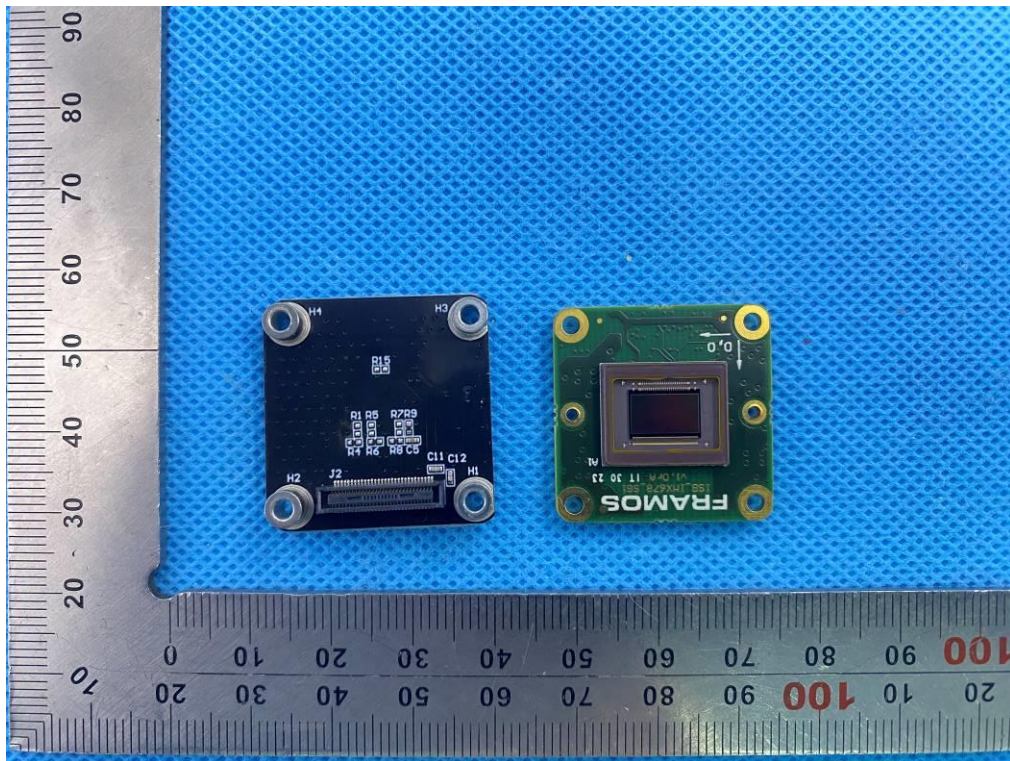
